-  The picture of Greater Minnesota's economies is complex and diverse. Brigid Tuck and her team studied economic outputs, employment and interdependencies in 12 Greater Minnesota regions in 2014-15. She will present an overview of findings, with special attention to how Greater Minnesota weathered the Great Recession.
- Brigid Tuck joined the Extension Center for Community Vitality in fall of 2008 after working for both St. Cloud State University in Minnesota and the University of Georgia Extension. She has her bachelors' degree in economics and management from the University of Minnesota-Morris, and her Masters from the Applied Economics Department at the University of Minnesota, and has more than 15 years of experience using IMPLAN, the input-output modeling software used in economic impact analysis. For Extension, Brigid conducts analysis and writes reports for the Economic Impact Analysis program, which has conducted about 50 economic impact analysis studies since 2010.
