2 killed, 3 injured during shootings at birthday parties

were partygoers or if they were passersby who were shot by those at the party.

"We don't know all the connections. That will be a part of our investigation that's ongoing at this point," Gonzalez said.

In the second shooting, people at an apartment complex in west Houston were having a birthday party Saturday night when a neighbor began complaining to them about the loud music.

Around 50 people had attended the party at a home in Jacinto City, located about 10 miles east of Houston, when shots were fired after an argument, authorities said.

Two people — Candelario Gonzalez Jr., 22, and Christian Rangel, 30 — were shot and taken to local hospitals, where they were pronounced dead, said Harris County Sheriff Ed Gonzalez.

"Unfortunately, two young men lost their lives at a birthday party for, again, what we're looking at is probably over just some petty verbal altercation," Ritchie said.

No arrests have been made.

Gonzalez said investigators are still trying to determine if the two victims

Recovery crews continue clean-up at site of Baltimore bridge collapse

BALTIMORE — As divers assisted crews with the complicated and meticulous operation of removing the steel and concrete from the fallen Francis Scott Key Bridge in Baltimore, some near the site took time on Easter Sunday to reflect on the six workers presumed to have plunged to their deaths.

As cranes periodically swung into place and workers measured and cut the steel to prepare to lift sections of twisted steel, Rev. Ako Walker held a Mass in Spanish at Sacred Heart of Jesus, about 5 miles up the Patapsco River from the collapse.

"Yes we can rebuild a bridge, but we have to look at the way in which migrant workers are treated and how best we can improve their situation as they come to the United States of America," Walker said of the men who were from Mexico, Guatemala, Honduras and El Salvador and were patching potholes.

Everything the salvage crews do affects what happens next and ultimately how long it will take to remove all the debris and reopen the ship channel and the blocked Port of Baltimore, Maryland Gov. Wes Moore said.

It can also alter the course of the National Transportation Safety Board investigation, which Moore said is important to ensure this doesn't happen again.

"We need to have answers on what happened. We need to know who should be accountable for this. And we need to make sure we're holding them accountable," Moore said Sunday on CNN.

Dive teams were in the river Sunday surveying parts of the bridge underwater and checking on the ship to ensure it can be safely floated away once the wreckage is lifted. Workers in lifts used torches earlier to cut parts of the twisted steel superstructure above water.

The bridge fell early Tuesday as the crew of the
