Judge Hutson move to approve the minutes for the February 19, 2025 meeting. Melanie Bush Seconded. Melisa Miller, Judge Hamilton, Captain Richards and Judge Mack abstain. All other members were in favor, the motion passed.

VIII. COMPLAINT SUBCOMMITTEE

- A. Consider and take appropriate action after receiving update and recommendations from the Complaint Subcommittee relating to complaint received February 10, 2025, from Karen Coy against Sondra Morris owner of Bail Bonds by Renell, license number 107 and Ace Bail Bonds of Montgomery County, license number 104.

Judge Hamilton swore in attorney Mike Starzys .Judge Hutson summarized the details of the complaint. The Complaint subcommittee reviewed the background check that was submitted in July 2024 for Ms. Jackson and determined that Ms. Jackson is eligible for employment. Judge Hutson submits subcommittee's recommendations for Sondra Morris to submit employment paperwork for Ms. Jackson within thirty days for review. Judge Mack move to approve the subcommittee's recommendations. Melanie Bush seconded. The motion passed.

Judge Mack swore in Will Nale and Mike Whitlock. Melisa Miller move to approve the license renewal application. Melanie Bush seconded. All members in favor. Motion passed

B. Consider, discuss and take action on request by Doug Wyrwich to release property located at 904 11th Street, Texas City, Texas 77539, from collateral pledged for expired license number 47. Mr. Wyrwich request that the Board consider the value increase of three remaining properties pledged for expired license number 47 when reviewing this change. The current outstanding liability for expired license number 47 is \$1,178,557.00. Without increasing the value of other properties the company limit would be \$1,075,800.00. With increasing the value of other properties the company limit would be \$1,344,200.00.

Melanie Bush move to reject the request to release property from collateral. Captain Richards seconded. All members in favor. Motion passed.
