A RESOLUTION TO AUTORIZE THE SUBMISSION OF A LOCAL PARKS AND RECREATION FUND (LPRF) GRANT APPLICATOIN FOR IMRPOVEMENTS AT CIVIC, FRED MILLER. HILLCREST, PARKS AND POPKIN FIELD

WHEREAS, the well-being of the citizens of the City of Morristown is of the greatest importance; and;

WHEREAS, all efforts shall be made to provide a safe, healthy play area for the citizens of the City of Morristown and surrounding areas;

WHEAREAS, improvements to Civic Hillcrest, Fred Miller Parks and Popkin Field are needed in order to enhance the lives of citizens through exceptional parks and recreation facilities:

WHEAREAS, the State of Tennessee offers grants to local communities to finance recreational improvements through its LPRF program;

WHEAREAS, the City of Morristown must submit a formal application in order to be eligible for funding through the LPRF program, said application to request funding for City Park improvements.

NOW, THEREFORE, BE IT RESOLVED by the Mayor and City Council of the City of Morristown, the following:

Section 1: That the City of Morristown is hereby authorized to submit application for a 2016 LPRF grant not to exceed \$ 1,000,000.

Section 2: That the City of Morristown is hereby authorized to provide a matching sum to serve as a match for any monies provided by this grant, up to \$ 500,000 to be provided by an appropriation in the general fund budget.

Section 3: That the City of Morristown owns the proposed location and acknowledges the Notice of Limitation of Use to be placed upon the land so that it will only be used for public recreation;

Section 4: that the City of Morristown acknowledges the project must be completed within 2 years if the contract is awarded.

This Resolution shall be effective from and after its adoption.

Whereas, no monetary amount shall be exchanged between the City or Norfolk Southern Corporation.

Whereas, the remainder of the contract between the City of Morristown and Norfolk Southern Corporation shall remain in full force and effect, with the exception of the modifications as stated above.

The above amendments to the contract between the City of Morristown and Norfolk Southern Corporation are hereby approved and ratified by the City Council for the City of Morristown, Tennessee.

SUBJECT - NS/Morristown

Dear Mayor Chesney:

I am diligently working to put at rest terms of a resolution that was passed by the City on November 21, 2006. While some of components of the resolution and agreement between the Railroad and the City were followed through with, others were not. I offer the following notes as a summary of that agreement:

- The original agreement was for 5 closures and a grand total payment of \$195,000 (\$160K from NS +\$35K from TDOT using matching Federal funds). A payment of \$156K and some change (check copy also enclosed in copy) was made to the City. 2 of the crossings were closed with the understanding that Howell and Bellwood would close after the connector was constructed and opened.
- There were aspirations of the City regarding future utility easement considerations and some sort of donation of an "abandoned" rail bed. I am unsure if either, or both, of these issues prevented both sides from completing the deal.
- There have been a lot of different folks working on this through the years, on both ends, many have come and gone.
- We want to finish this out, understanding that development has, and is continuing to occur in this
 area, I understand that the terms of the previous agreement may need to be amended to satisfy both of
 us.

It is my hope that the Council will take a look at this Summary and the following two proposed action items that will allow for NS and the City to bring this open topic to closure.

Primary Action Item:

Working off of the City Resolution adopted 11.21.06, we would feel most comfortable if the City passed a new resolution, referencing the revisions that we are in agreement to, which are:

- Re-iterating the closure of Howell Rd, DOT #731 376M.
- No longer pursuing previously agreed upon closure of Bellwood Rd, DOT #731 374Y at the request of the City.

- Working with TDOT to modify existing flashing light and bell warning devices at Jim Senter Way,
 DOT #731 352Y (also known as Park Ave. per Railroad documents) to include new lights, gates and bell equipped warning devices.
- Providing an incentive payment to the City in the amount of \$15,000 for use in the City's construction of cul-de-sac, or suitable turn around configuration on the Southside of the tracks. TDOT will work to pursue a \$7,500 match on our incentive using Federal funds. The crossing at Howell Road will be permanently closed by NS when the total incentive is authorized.
- City will handle design and construction of cul-de-sac, or suitable end-of road design at the City's discretion, to be located off of RR property.
- Reference the previous payment from NS in the amount of \$156,516.00 for the 4 public closures.
- Maintain the existing clause that states the City will erect and maintain the proper road closed signage.

Secondary Action Item:

• Provide NS with a brief memo stating that the City does not maintain the Stockyard Supply crossing, DOT # 731 363L, on both sides, therefore it should be considered a private crossing. This allows us to change it with your acknowledgement from public to private. We will then post it for closure based on lack of agreement and lack of need due to other means of access.

Again, we are grateful to be able to work with the City, and TDOT to bring this to a conclusion while enhancing safety of the travelling public in Morristown. I feel that the action items listed above will do that once they are accomplished. Please let me know if and when there is need for discussion.




A request for annexation into the corporate limits of Morristown has been received from Mr. Phillip Carlyle for his property located adjacent to North Bellwood Road in the Urban Growth Boundary.

The property, 3.5 acres in size, is now vacant with multifamily residential units being proposed for the site. Hamblen County has the site zoned for commercial development with properties adjacent to the east zoned likewise. (C-1) North of the site is currently vacant and zoned for residential development.

Due to the intended use of the property, the zoning designation, if approved, will be Medium Family Residential (R-2) which will provide a good transitional buffer between those commercial businesses along the south which include a Honda dealership and medical offices. Residential and vacant properties border the



site to the north. Across N. Bellwood Road to the west is an automotive detailing shop and Oakwood Gardens subdivision which is a mixture of residential apartments and duplex units.





Morristown Utility Commission currently has utility services in place to serve the proposed development. The City of Morristown Police and Fire Departments have been notified of the annexation requests and proposed development and have expressed no concerns.

The request went before the Morristown Regional Planning Commission at their regular meeting of April 12th, 2016 for a recommendation to the City Council. There was a unanimous vote to forward the request to City Council in the affirmative.

Staff feels that as utilities and other City services are readily available, annexation of this property with zoning designated as R-2, along with the Plan of Services be approved at this time.



AN ORDINANCE TO ANNEX CERTAIN TERRITORY AND TO INCORPORATE SAME WITHIN THE CORPORATE BOUNDARIES OF THE CITY OF MORRISTOWN TENNESSEE. Annexation of property located on North Bellwood Road to include Hamblen County Tax Parcel ID #040 03901000 with the Zoning Designation of Medium Density Residential (R-2).
Section I. WHEREAS, it now appears that the prosperity of the City and of the territory herein described shall be materially retarded and the safety and welfare of inhabitants and property owners thereof endangered if such territory is not annexed; and
Section II. WHEREAS, the annexation of such territory is deemed necessary for the welfare of the residents and property owners therof and the City as a whole;
NOW THEREFORE BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF MORRISTOWN;
(1) PURSUANT to the authority conferred by Section 6-15:102 of the Tennessee Code Annotated, there is hereby annexed to the City of Morristown, Tennessee, and incorporated within the corporate boundaries thereof, the following described territory adjoining the present corporate boundaries:
That property having Hamblen County Tax Parcel ID # 040 03901000, containing 3.5 acres of land more or less, which is located on the eastern right-of-way line of North Bellwood Road approximately 340 feet north of the West Andrew Johnson Highway right-of-way;
And the above described being as a crosshatched parcel on the attached exhibit A:
(2) Medium Density Residential (R-2) zoning shall be applied to this property upon adoption of the annexation area.
(3) This Ordinance shall become operative thirty days after its passage or as otherwise provided for in Chapter 113, Public Acts of Tennessee, 1955.
(4) This Ordinance shall become effective from and after its final passage, the public welfare requiring it.

Whereas City on or about February 24, 2016 issued its Request for Proposals for Real Estate Agent/Broker Services, and

Whereas LeBel on or about March 18, 2016 submitted its Proposal which said proposal was approved by City Council on April 5, 2016, and

Whereas an initial contract for a period commencing upon City Council approval of this Contract and Agreement and ending on June 30, 2019 is required.

NOW THEREFORE IT IS AGREED AS FOLLOWS:

- 1. <u>Scope of Services, Terms and Conditions</u>. The Proposal of LeBel, including, without limitation, the Scope of Services and Terms and Conditions therein set out, is incorporated by reference as if fully set out here. The need for such services shall be as determined from time to time by the City Administrator.
- 2. <u>Insurance</u>. LeBel shall maintain throughout the term of this Contract and Agreement Errors and Omissions coverage with limits of liability of \$100,000.00 each claim and \$300,000.
- 3. <u>Good Standing</u>. LeBel shall maintain all licensing, certifications and standing now in place throughout the term of this Contract and Agreement.
- 4. Reservation of Rights. While the term of this Contract and Agreement is three years, the City reserves the right to terminate/modify same as annual budget constraints may require. LeBel reserves the right to terminate this Contract upon providing a thirty (30) day written notice to the City.

- 5. Compensation. The compensation of LeBel shall be determined by the City Administrator and LeBel on a case by case basis either as a percentage of the contract price in the event of the sale of real property or an hourly rate for other services such as consulting, lease negotiation and like services, said hourly rate to be One Hundred Thirty-five dollars (\$135.00). The hourly fee shall also be used in the situation where work is done by LeBel, but the sale/purchase of the real property does not occur. The percentage fee for transactions below Three Hundred Thousand Dollars (\$300,000.00) shall be Seven percent (7%). The percentage fee for transactions above Three Hundred Thousand Dollars (\$300,000.00) shall be Five percent (5%).
- 6. <u>City Council Approval</u>. Only transactions exceeding the amount established by City ordinance shall require City Council approval.

Insurance Benefits

Background/History: The City of Morristown continues to evaluate its contracted services. Due to the fact that insurance brokerage services had not been sought in several years, it was determined that seeking requests for proposals was in the City's best interest. The City of Morristown sought proposals for brokerage/consulting firms that would provide consulting services and administer the City of Morristown's group insurance programs, voluntary employee benefits and the administration of its Section 125 plans including premium only plans. The selection criteria was established to ensure that all interested parties would be able to submit and be objectively evaluated based on their submittal. The proposals were evaluated by a six-member committee. Each member evaluated each proposal independently. The scores of each committee member were averaged to determine the top two responses. The committee then interviewed the top two respondents.

Findings/Current Activity: The Request for Proposal was advertised in the Citizen Tribune on February 24, 2016 and on March 2, 2016. Additionally, the Request for Proposal was posted to the City of Morristown's website and through Vendor Registry, an on-line facilitation website. The Request for Proposal was remitted directly to current brokers and to brokers that had previously contacted the City of Morristown and expressed interest conducting business with the City. The Request for Proposal was amended with one addenda. This addenda was published in the Citizen Tribune on March 17, 2018. The addenda was posted to the City of Morristown's website. Additionally, the addenda was remitted directly to current brokers and to brokers that had previously contacted the City of Morristown and expressed interest conducting business with the City. The submission deadline was 11:00 AM on Monday, March 28, 2016. We received nine (9) responses.

Financial Impact: The overall financial impact of the approval of the Request for Proposal cannot be determined at this time. The selection of the right respondent will have a positive impact on the City of Morristown's financial position, specifically in the administration of the City's self-insurance fund that will result in saving significant dollars. Additionally, the selection of the right respondent will have a positive financial impact for City employees on the products that can be offered and the services received. The direct financial impact to the City will result in a savings of approximately \$8,000. Mark III Employee Benefits Inc.'s response to the Request for Proposal for fees was as follows: a flat fee of \$30,000 per year to be paid out monthly for the medical, dental, and vision plan consulting (no commission will be taken on these products); standard rate of commission (10%) that is in the premiums for the basic life, AD&D, long-term disability and dependent life group plans; and standard rate of commission on voluntary benefits (short-term disability, life, cancer, etc.).

Action options/Recommendations: It is staffs' recommendation to approve Mark III Employee Benefits Inc. as the broker/consultant.
