RESOLUTION NO. 2022-1

BEING A RESOLUTION OF THE CITY OF MORRISTOWN, TENNESSEE, AMENDING "SECTION IV – 6. MEDICAL EXAMINATIONS AND GENERAL PHYSICALS" OF THE CITY OF MORRISTOWN EMPLOYEE HANDBOOK.

BE IT RESOLVED by the City Council for the City of Morristown, Tennessee that "Section IV - 6. Medical Examinations and General Physicals" of the Employee Handbook be amended as follows:

IV – 6. MEDICAL EXAMINATIONS AND GENERAL PHYSICALS

Post-employment:

- C. All employees of the City may, during their employment, be required by their department head, with the approval of the human resource department, to undergo periodic examinations to determine their physical and mental fitness to continue to perform the work of their position. This periodic examination shall be at no expense to the employee. Determination of physical or mental fitness will be made by a physician designated by the City.
 - (1) Fire suppression personnel may be required to complete a Candidate Physical Ability Test (CPAT/MPAT). The MPAT will be inclusive of 3 levels of completion status:

1st Level- Participant will complete within 10 minutes and 20 seconds and will be awarded 12 hours compensatory time.

2nd Level- Participant will complete the test, necessary to maintain employment.

3rd Level- Participant cannot complete test. Participant will be referred to a physician for evaluation and to create a fitness action plan to enable them to pass the test within twelve months. The fitness action plan must be submitted to the Training Office within 30-days of failing to pass the test. Participant shall elect to use a physician of their own choosing at their own cost. If participant is unable to pass the test within twelve months, he/she will be considered unfit or unable to perform the essential functions of fire suppression personnel and be separated from City employment.

RESOLUTION 2022-2

A JOINT RESOLUTION OF THE COUNTY LEGISLATIVE BODY OF HAMBLEN COUNTY, TENNESSEE AND THE CITY COUNCIL OF THE CITY OF MORRISTOWN, TENNESSEE REQUESTING THE STATE OF TENNESSEE TO KEEP THE SWIMMING POOL AT PANTHER CREEK STATE PARK OPEN

WHEREAS, Panther Creek State Park is one of 56 state parks in Tennessee that attract millions of visitors from throughout the United States every year to enjoy hiking, camping, boating, swimming and many other outdoor activities; and,

WHEREAS, state parks play a key role in making tourism the third leading industry in Tennessee generating millions of dollars' worth of economic activity for their communities; and,

WHEREAS, the swimming pool at Panther Creek State Park has offered park visitors and the Lakeway Region a public place to swim with family and friends and to enjoy other park amenities for 36 years and is the only public pool in operation in Hamblen County ; and,

WHEREAS, the Tennessee Department of Environment and Conservation (TDEC) announced in December 2021 its plans to close the swimming pools at 11 state parks including the one at Panther Creek State Park citing declining usage, cost to repair the pools and cost of operation for a seasonal activity; and

WHEREAS, many park patrons, such as members of Friends of Panther Creek State Park, and local leaders disagree with the state's decision and want state officials to consider options to keep the pool open because of its value to park visitors and the community;

NOW THEREFORE, BE IT RESOLVED by the members of the Hamblen County Commission and Morristown City Council, with the support of State Representative Rick Eldridge and State Senator Steve Southerland, that Tennessee state park officials reverse their decision to close the pool at Panther Creek State Park and choose to keep it open with possible changes to its operation to make it more accessible for public use.

BE IT FURTHER RESOLVED that certified copies of this resolution are mailed to the offices of Governor Bill Lee, TDEC Commissioner David Salyers and Deputy Commissioner for Parks and Conservation Jim Bryson.
