A public hearing was held on the following captioned Ordinance 3394. Councilmember Rooney made a motion to adopt said Ordinance on second and final reading; Councilmember Garrett seconded the motion and upon roll call, all voted “aye”.

**Ordinance No. 3394  
Being an Ordinance amending the Morristown Municipal  
Code Title 18 (Water and Sewers), Chapter 4 (Water  
Pollution Control). (sewer use fees)**

A public hearing was held on the following captioned Ordinance 3395. Councilmember Rooney made a motion to adopt said Ordinance on second and final reading. Councilmember Garrett seconded the motion and upon roll call, Councilmembers Garrett, Jinks, Rooney, Senter and Mayor Barile voted “aye”; Councilmember McGuffin “abstained”; Councilmember Brooks voted “no”.

**Ordinance No. 3395  
Being an ordinance amending the Morristown Municipal Code  
Title 17 by modifying the refuse collection fee schedule and  
other chapters where necessary to make same consistent with  
current practices.**

A public hearing was held on the following captioned Ordinance 3396. Councilmember Jinks made a motion to adopt said Ordinance on second and final reading as amended (added Storm Water Fund / \$140,000). Councilmember Garrett seconded the motion and upon roll call, Councilmembers Garret, Jinks, McGuffin, Rooney, Senter and Mayor Barile voted “aye”; Councilmember Brooks voted “no”.

**Ordinance No. 3396  
Entitled an Ordinance to amend the Fiscal Year 2010 Budget  
by providing for appropriations from Revenue and Expenditure**

**Accounts on an individual fund and line item basis.**

Councilmember Jinks made a motion to adopt the following captioned Ordinance No. 3393 on second and final reading. Councilmember Rooney seconded the motion and upon roll call, Councilmembers Garret, Jinks, McGuffin, Rooney, Senter and Mayor Barile voted "aye"; Councilmember Brooks voted "no".
