Dr. Chris Dotson, Pastor Free Will Baptist Church and Morristown Police Department Chaplain Coordinator, lead in the invocation and Councilmember Jinks led in the "Pledge of Allegiance".

Councilmember Senter made a motion to approve the May 15, 2012 minutes as circulated. Councilmember Jinks seconded the motion and upon roll call; all voted "aye".

Being an Ordinance of the City Council for the City of Morristown, Tennessee, Amending Title 8 of the Morristown Municipal Code.**

Councilmember Bivens made a motion to approve Ordinance No. 3419.15 on second and final reading. Councilmember Jinks seconded the motion and upon roll call; all voted "aye".

An Ordinance to Amend Ordinance Number 3419, The City of Morristown, Tennessee Annual Budget for the Fiscal Year 2011-2012 and Appropriate the Sum of \$2,000 for Project Graduation.**

Councilmember Jinks made a motion to approve Ordinance No. 3443 on first reading and schedule a public hearing relative to final passage of said Ordinance for June 19, 2012. Councilmember Senter seconded the motion and upon roll call; Councilmembers Garrett, Bivens, Senter, Jinks and LeBel voted "aye"; Councilmember Brooks and Mayor Thomas voted "no".

An Ordinance establishing Expenditure Appropriates for the Fiscal Year Beginning July 1, 2012 and Ending June 30, 2013 and Further Approving the City Administrator's Proposed Budget with such Modifications as Deemed Necessary or Desirable by the Morristown Tennessee City Council for the Fiscal Year 2012/2013.**

Councilmember Bivens made a motion to approve Ordinance No. 3444 on first reading and schedule a public hearing relative to final passage of said Ordinance for June 19, 2012. Councilmember LeBel seconded the motion and upon roll call; all voted "aye".

An Ordinance to Fix the Rate for Ad Valorem Real and Personal Property Tax for the Tax Year of 2012.**

Councilmember Senter made a motion to approve adoption of the Hamblen County Hazard Mitigation Plan. Councilmember LeBel seconded the motion and upon roll call; all voted "aye".
