The City Council for the City of Morristown, Hamblen County, Tennessee, met in regular session at the regular meeting place of the Council in the Morristown City Center at 5:00 p.m., Tuesday, July 2, 2013 with the Honorable Mayor Danny Thomas presiding and the following Councilmembers present; Bob Garrett, Chris Bivens, Kay Senter, Dennis Alvis, Paul LeBel and Gary Chesney.

Chris Dotson, Chaplain Morristown Police Department led in the invocation and Councilmember Alvis led in the "Pledge of Allegiance".

Councilmember Senter made a motion to approve the June 18, 2013 minutes as circulated. Councilmember Bivens seconded the motion and upon roll call; all voted "aye".

Councilmember Alvis made a motion to declare one service weapon as surplus property (Glock Model 19 9mm handgun, serial number #LLG918). Councilmember Bivens seconded the motion and upon roll call; all voted "aye".

Mayor Thomas recognized Gary Lowe with a proclamation congratulating him on his retirement and thanking him for his many years of service with the Morristown Police Department. Chief Overholt presented Major Lowe a watch and his service weapon.

A Public Hearing was held on Ordinance No. 3478.

Councilmember LeBel made a motion to approve Ordinance No. 3478 on second and final reading. Councilmember Alvis seconded the motion and upon roll call; all voted "aye".

**Ordinance No. 3478**

**An Ordinance to Amend the Municipal Code of the City of Morristown, Tennessee, Appendix B. Rezoning of property located in Alpha Square at 5750 Old Highway 11E (Hamblen County Tax Map 48, Parcel 13.01) and Bulldog Lane (Hamblen County Tax Map 48, Parcel 13.15) from Medium Density Residential (R-2) to Intermediate Business (IB).**

Councilmember Senter made a motion to approve Ordinance No. 3479 on first reading and schedule a public hearing relative to final passage of said Ordinance for July 16, 2013. Councilmember Alvis seconded the motion and upon roll call; all voted "aye".

**Ordinance No. 3479**

**An Ordinance of the City of Morristown, Tennessee, Amending Chapter 2 of the Morristown Municipal Code (Boards and Commissions; Parks and Recreation Advisory Board).**

Councilmember Bivens made a motion to approve Ordinance No. 3480 on first reading and schedule a public hearing relative to final passage of said Ordinance for July 16, 2013. Councilmember Chesney seconded the motion and upon roll call; all voted "aye".

**Ordinance No. 3480**

**An Ordinance to Amend Title 12 of the Municipal Code of the City of Morristown, Tennessee, by Adopting Certain Amendments Thereto Relative to Building Codes (Building, Utility, Etc. Codes).**

Councilmember Chesney made a motion to approve Ordinance No. 3481 on first reading and schedule a public hearing relative to final passage of said Ordinance for July 16, 2013. Councilmember Bivens seconded the motion and upon roll call; all voted "aye".

**Ordinance No. 3481**

**An Ordinance of the City of Morristown, Tennessee, to Amend Section 5-204, Section 5-205 and Section 5-206 of the Morristown Municipal Code (Municipal Finance and Taxation).**

Councilmember Alvis made a motion to award a bid to American Infrastructure Technologies in the amount of \$567,100 for Sewer Rehabilitation project - Waste Water Treatment Plant 3 (WWTP3), Contract "A" Sewer Basin. Councilmember Bivens seconded the motion and upon roll call; all voted "aye".

Mayor Thomas adjourned the July 2, 2013 meeting.
