This application must be completely filled out and submitted with application fees (non-refundable) and the requirements listed above. By making this application, the applicant assumes personal responsibility for all information provided. The Beer Board may delay action or deny the permit if an application contains inaccurate information. Copies of licenses and documents must be submitted with the completed beer permit application to the City of Morristown Tax Office, 100 West 1st North Street. Each application must be signed and notarized. Applicants may call (423) 318-1552 with any questions regarding the application process.

A background check will be conducted from all counties an applicant has resided in within the last 10 years. The Beer Board requires records checks on all owners, registered agents and managers.

The owner shall list the local manager(s) responsible for operations. Any change in management must be reported and a new owner/manager questionnaire submitted to the city business tax office. A new manager is subject to a background check. Applicant may not have been convicted of any crime involving moral turpitude or violation of any alcoholic beverage law within the ten (10) years prior to applying for permit.

The City will place a public notice in the local newspaper one (1) time at least ten (10) days prior to the Beer Board meeting. A notice will also be posted at the establishment at least (15) days prior to the meeting.

State law requires a \$100.00 annual privilege tax which is due each January. New permittees will pay a prorated annual tax.

A permit holder must surrender the beer permit to the City Business Tax Office within five (5) days of termination of the business, change in ownership, relocation of the business or change in the business name. A change in ownership for a corporate owner occurs when at least fifty percent (50%) of the stock of the corporation is transferred to a new owner.

The City Beer Board meets as needed on the first and third Tuesday of each month. To ensure consideration of an application, the applicant must submit the completed application to the City of Morristown Tax Office 30 days prior to the next Beer Board meeting in order to appear on that agenda.



Procedures to be followed for sale of beer at Downtown Green Concert Series


Crossroads Downtown Partnership is very cognizant of its responsibilities for providing a family friendly atmosphere in the Downtown Green Space for these events. We plan to have all four concerts follow these procedures. Please refer to attached area map.

- 1. The Downtown Green will be staked and safety tape will be used to demarcate event area (the Green, and the adjacent parking area to the north of the green between the green and the RR tracks). One entry area will also have a barricade.
- 2. Toilet facilities will be provided in the parking lot area as noted above.
- 3. Beverage facilities will also be in a separate section of that parking area on the asphalt.
- 4. Food, if available, will also be set up in that area.
- 5. The Farmers Market Pavilion area will serve as a backup for the event in the case of inclement weather. It will be sectioned off accordingly if it is needed. Otherwise it provides additional parking space.
- 6. Two public entrance area will be provided. One at the NW corner of the green and the other on the NE corner of the green just above the steps. At these entry areas, there will be a table with Crossroads representatives answering questions, and directing folks to where they can put their chairs and enjoy the green before, during and after the concert.
- 7. The Green will be ready to admit folks by 6 PM, with music starting at 6:30 PM and ending at 8:30 PM.
- 8. Tickets will be sold to purchase soft beverage. \$1 for soft drinks and water.
- 9. For Beer, a Tyvek bracelet will be sold for \$5 for a beer. A table for that purpose will be set up and manned by adults on the north side of the green near the food and beverage area. Bracelets will be placed on the purchaser. Beer will be served in the iconic red cups and each time a server provides a beer, the Tyvek bracelet will be punched with a round hole punch. All servers will be licensed servers provided by a company like Pour Guys. That way the event is covered by full liquor liability as CDP will pay extra for that coverage. Any additional beers require an additional hole punch and an additional \$5. No more than 3 beers will be sold to any individual during the concert. All beer will be purchased from a distributor in accordance with TN law.
- 10. Signs will be posted at the taped perimeter stating "No beer beyond this point". There will be two signs on all four sides of the event area.
- 11. We will hire two off duty police officers to help us spot for folks trying to bring in their own alcoholic beverages (which is not allowed) or to be on hand to help respond to circumstances as they may arise.
- 12. We will not asking to close any City streets. However, we will have a monitor wearing a safety vest to assist folks crossing S. Henry Street and put a sign in a traffic cone saying "Watch out for Pedestrians."
- 13. Besides, trash facilities KMHB will provide containers for disposing recyclable items like cups, plastic bottles, etc.
