#### LEASE AGREEMENT

This lease agreement made and entered into on this 1st day of <u>Soloter</u> to 5 by and between By-Lo Markets, Inc. hereinafter Designated "Lessor", and hereinafter "Lessee".

#### WITNESSETH

That for the considerations and upon the terms and conditions recited herein, Lessor hereby leased to the Lessee the property at <u>2564 Buffalo Trail Morristown, TN 37814</u> to wit:

- 1. This lease shall include all building fixtures, and equipment located on the leased property and owned/or controlled by either Lessor or Lessee.
- 2. The terms of this lease shall be for a period of Three (3) years beginning 10-22-15, and ending on 10-21-18

  The lease payment is Two Thousand Five Hundred Dollars and 00/100 (\$ 2500.00) due on the 22<sup>100</sup> day of each month. There will be a 5 year option to renew said Lease at the end of the original Three (3) year period. There will be a Two Thousand Five Hundred Dollars and 00/100 (\$2500.00) security deposit.
- 3. The Lessor will maintain the air machine and the ATM with the Lessee providing the internet.
- 4. Upon termination of this lease for whatever reason, Lessee shall have Thirty (30) days after the date of such termination to enter the premises and remove any improvements of equipment placed thereon by Lessee or any third parties acting under the direction of Lessee. However any improvements which shall be deemed to be part of the realty shall not be subject to removal.
- 5. Lessee will keep the building, water pipes, sewer, drains, heat and air units, coolers, freezers and all electrical systems in good state of repair during the tenure of this lease. Lessee shall have the right to make improvements to the premises from time to time as Lessee in its discretion sees fit to do; however, Lessee shall not be obligated to do so.
- 6.
