I. RENTAL

Lessee shall pay to Lessor the monthly rent of Zugo per month. Rent shall be payable at the location of the leased premises, or at such other place as Lessor may designate in writing. Rental shall be payable on or before 14 days from receipt of the remail billing submitted by Lesson

2. TERM OF LEASE

The initial term of this lease shall commence on the 10 1 2014 and end at 12:00 midnight on the 9 20 2019 unless sooner terminated by Lesson or Lessee by giving one hundred twenty days advance written nonce to the other of the intention to terminate or unless somer terminated as otherwise provided herein.

REAL ESTATE TAXES

Lessor, herein, shall pay all real estate taxes and assessments upon the leased property, and upon the buildings and improvements thereon, which are assessed and allocable to such property during the term of the lease

4. FIRE INSURANCE

Lessee shall not be obligated to maintain fire or casualty insurance on its vehicles stored on the premises or any other of its property, but may do so if it so eleers.

5. GENERAL PUBLIC LIABILITY INSURANCE

After the commencement date of the term of the lease, the Lessee shall, at its sole cost and expense, maintain comprehensive general public liability insurance, with limits of at least one hundred thirty thousand dollars (\$130,000.00) per person and three hundred thousand dollars (\$300,000.00) per occurrence for bodily injury and fifty thousand dollars (\$50,000.00) for property damage. Such policies shall name the Lessor and the Lessee as the insureds. Within ten days after the date hereof, Lessee shall deliver to Lessor certificates of insurance certifying that such insurance is in full force and effect.

6. REQUIREMENTS OF LESSEE-INSURANCE

All policies of insurance required to be maintained by Lessee, if any, shall name Lessee and Lessor as the insured as their respective interests may appear. All such policies shall, to the extent obtainable, contain an agreement by the insurors that such policies shall not be canceled without at least ten days prior written notice to Lessor and to the holder of any mortgage to whom loss hereunder may be payable.

7. INSURANCE - RENEWALS

At least thirty (30) days prior to the expiration of any policy of insurance the Lessee is obligated to carry under this lease, Lessee shall furnish a binder to Lessor renewing each such policy. Each policy and/or binder shall provide for at least ten (10) days notice to Lessor of any change or cancellation thereof. Lessee shall promptly deliver to Lessor a certificate from the insurance carrier evidencing the renewal of the policy and the payment of the premium.

8. UTILITIES

Lessee shall pay for all utilities including but not limited to charges for water, sewer, gas, electricity, light, heat, power and telephone or other communications services used, rendered or supplied upon or in connection with the leased property, and shall indemnify the other party hereto against any liability or damages on such account.

9. INTERIOR REPAIRS

Lessee covenants that during the term of this lease, Lessee will, at its own cost, keep in good order and repair (and make such renewals thereof from time to time as may be necessary or advisable) the interior of the building located on the premises.

10. EXTERIOR REPAIRS

Lessee covenants that during the term of this lease it will, at its own cost, keep in good order and repair the exterior of said building and lot.

11. FIXTURES

Any improvements to the leased property or any part thereof and any replacement of fixtures and personal property during the term of this lease shall at once become the absolute property of Lessor without payment of any kind.

12. DEFAULT

Lessee further covenants that if said premises at any time be deserted, abandoned or closed or if Lessee defaults for a period of thirty (30) days from paying any installment of rent when due or in performing any covenant, provision or condition herein contained binding upon Lessee, Lessor shall have in addition to all other rights and remedies provided by law, the right, without notice to Lessee, to enter and take possession of the premises, peaceably or by force, and to terminate this lease; and Lessor may relet said premises for the unexpired portion of the term or any part thereof, and receive the rent therefore and apply it on the rent due hereunder, and Lessor's actions shall be final and binding upon said Lessee and Lessee agrees to pay promptly to Lessor upon demand at one time or from time to time any difference between the rent payable hereunder and any smaller amounts collected by Lessor from the tenant or tenants to whom said premises may be relet as aforesaid. Lessor shall have the right to terminate this lease at any time Lessee goes into bankruptcy or receivership or makes a general assignment for the benefit of its creditors.

13. DAMAGE BY FIRE

In case of damage by fire or other casualty to the building in which the leased property is located, without the fault of Lessor, if the damage is so extensive as to amount practically to the total destruction of the leased property or such building, this lease shall cease, and the rent shall by apportioned to the time of the damage. In all other cases where the leased property is damaged by fire or other casualty without the fault of Lessor, Lessee shall repair the damage within a reasonable time, and if the damage has rendered the leased property untenable, in whole or in part, it shall be in apportionment of the rent until the damage has been repaired. In determining what constitutes a reasonable time, consideration will be given to delays caused by strikes, adjustment of insurance and other causes beyond Lessee's control.

14. CONDEMNATION

If the whole of the leased property, or such portion thereof as will make the leased property unsuitable for the purposes herein leased, is condemned for any public use or purpose by any legally constituted authority, then in either of such events this lease shall cease from the time when possession is taken by such public authority and rental shall be accounted for between the Lessor and Lessee as of the date of surrender of possession. Such termination shall be without prejudice to the rights of either the Lessor or the Lessee to recover compensation from the condemning authority for any loss or damage caused by such condemnation. Neither the Lessor or the Lessee shall have any rights in or to any award made to the other by the condemning authority.

15. ASSIGNMENT

Lessee may not assign or sublet the demised premises to third parties without the consent of Lessor; however, such assignment or subletting shall not be permitted where so doing would violate any governmental ordinance, statute, rule or regulation; or where so doing would result in a substantial change in the use of the premises to the detriment of Lessor.

16.DISCLAIMER AND ACCEPTANCE

Neither the Lessor nor an agent of Lessor has made any representations with respect to the leased premises or any real estate of which same may be a part except as expressly set forth herein and no rights, easements or licenses are acquired by Lessee by implication or otherwise except as expressly set forth in the provisions of this lease. The taking of possession of the leased premises by Lessee shall be conclusive evidence that Lessee accepts the same "as is" and that the leased premises and the real estate of which same be a part were in good and acceptable condition at the time possession was taken, unless expressly provided for otherwise, hereinafter.

17. SURRENDER

Lessee covenants that it will, upon the termination of this lease, deliver to Lessor the same premises and all appurtenances thereto peaceably and quietly in as good order and condition as same are or may hereafter be put by Lessor and Lessee, ordinary wear and tear and damage from fire not occasioned by the fault or negligence of Lessee, its agents or employees, excepted.

18. NON-WAIVER OF REMEDIES

Lessee agrees that any failure of Lessor to insist upon strict observance of any covenant, provision or condition of this lease in any one or more instances shall not constitute or be deemed a waiver, at that time or thereafter, of such or any other covenant, provision or condition of this lease.

19. RIGHT OF ENTRY

Lessor and its representatives may enter the leased property, at any reasonable time, for the purpose of inspecting the leased property, performing any work which the Lessor elects to undertake made necessary by reason of Lessee's default under the terms of this lease, and exhibiting the leased property for sale, lease, or mortgage financing.

20. HOLD HARMLESS

Lessor shall not be liable for injury or damage to person or property occurring within the leased premises, unless caused by or resulting from the negligence of Lessor or any of Lessor's agents, servants, or employees.

21. CONSTRUCTION LAW

The lease shall be governed by, constructed and enforced in accordance with the laws of the State of Tennessee.

22. GENERAL CONSTRUCTION

In construing this lease, feminine or neuter pronouns shall be substituted for those masculine form and vice-versa, and plural terms shall be substituted for singular and singular for plural in any place in which the context so requires.

23. JOINT AND SEVERAL

If there is more than one party Lessee, the covenants of the Lessee shall be the joint and several obligations of each such party, and if Lessee is a partnership, the covenants of Lessee shall be the joint and several obligations of each of the partners and the obligations of the firm.

24. PERSONS BOUND
