



**PUBLIC MEETING NOTICE**  
**PROPOSED MAJOR UPDATE TO THE MPO's PUBLIC**  
**PARTICIPATION PLAN (PPP)**

The Pasco County Metropolitan Planning Organization (MPO), the designated agency responsible for conducting a countywide transportation planning program, will hold a public MPO Board meeting on June 13, 2024 to seek approval to provide for public comment the DRAFT Major Update to the Pasco MPO's Public Participation Plan (PPP), which was adopted in 2018 with minor amendments in 2021 and 2022. This DRAFT Major Update to the PPP revises the existing MPO's PPP to reflect current outreach strategies which include many types of public engagement events the MPO conducts or hosts. The meeting will be held at 10:00 a.m. at the West Pasco Government Center, 8731 Citizens Drive, New Port Richey, FL 34654-5598.

The Draft PPP outlining the proposed major update will be available on the MPO's website in the [Public Participation Plan \(PPP\) tab under the Additional Plans section](#) for the required 45-day comment period which begins June 13, 2024 and continues through July 28, 2024.
