Jobs and Economic Opportunities Trust Fund (JEOTF)

The Jobs and Economic Opportunities Trust Fund (JEOTF) will be used to fund economic development projects that improve the local economy. Proposed projects will be required to submit an application, undergo a review by the Pasco County Board of County Commissioners, and meet one of the following criteria:

1. Comply with the Pasco County Target Industry Job Creation Incentive Ordinance (Chapter 22, Article II, Pasco County Code of Ordinances), or
2. Other criteria developed by the Board of County Commissioners to determine whether the proposed economic development project meets the intent and requirements of Section 212.055(2)(d)3, Florida Statutes.

Examples of Qualifying JEOTF Projects:

- Economic Incentives
- Economic Gardening and Investment
- Supporting Infrastructure
- Business Incubators
- Workforce Development
- Capital Projects

Public Safety

- Vehicles and equipment for Pasco Sheriff's Office, Emergency Management Services and Fire Rescue
- Fire Rescue Training Facility Upgrade and Expansion
- Fire Station 13 Reconstruction
- County-Wide Public Safety Communication System

Note: Funding will be shared 50/50 between Pasco County Emergency Services and the Pasco County Sheriff's Office.

Environmental Lands Acquisition

Continue the Environmental Lands Acquisition Program created by Pasco County in 2004 through Resolution No. 04-233, for the purpose of acquiring interests in real property to provide the following for the residents of Pasco County:

- Protect the remaining natural communities for future generations
- Connect major public lands through the acquisition of corridors in them
- Conserve native plants, animals and their habitat
- Protect water resources and wetlands
- Enhance natural resource-based recreational and educational opportunities
- Promote the preservation of lands near residential neighborhoods that increase the quality of life
