### **Project Overview**

Pasco County, in coordination with the FDOT, District Seven, is conducting a Project Development and Environment (PD&E) Study for Rangeland Boulevard in Pasco County to improve regional mobility and connectivity to destinations and communities east and west of the Suncoast Parkway in addition to relieving traffic congestion and improving safety on State Road (SR) 54. The Rangeland Boulevard study limits are from Cattle Gap Trail to Bexley Village Drive in Pasco County, a distance of approximately 3.4 miles.

Potential improvements include a new four or six-lane roadway along with bicycle lanes, a sidewalk, and a multi-use path. An overpass crossing the existing Suncoast Expressway (SR 589) is also included. The proposed multi-use path will serve as part of the Orange Belt Trail, a planned 37-mile trail across Pasco County. A potential connection with the existing Suncoast Trail and the provision of a trailhead at their junction is also being evaluated.






