Public Hearing; Resolution; Virginia Department of Transportation Six-Year Plan for Prince George County Secondary Roads Improvement for Fiscal Years 2019 through 2024 and Secondary Roads Construction Budget for Fiscal Year 2018/19 for Prince George County

The Virginia Department of Transportation and the Board of Supervisors of Prince George County, in accordance with Section Section 33.2-331 of the Code of Virginia, will conduct a joint public hearing in the regular meeting room of the Prince George County Government Administration Building, 6602 Courts Drive, Prince George, Virginia at 7:30pm on Tuesday, May 8, 2018. The purpose of this public hearing is to receive public comment on the proposed Secondary Six-Year Plan for Fiscal Years 2018/2019 through 2023/2024 in Prince George County, and on the Secondary System Construction Budget for Fiscal Year 2018/19.

Copies of the proposed Plan and Budget will be reviewed by VDOT staff for Board of Supervisor consideration.

All projects in the Secondary Six-Year Plan that are eligible for federal funds will be included in the Statewide Transportation Improvement Program (STIP), which documents how Virginia will obligate federal transportation funds.

After the public hearing and discussion with VDOT staff, County staff recommends adoption of the draft resolution.
