The HVAC system in the County Administration Building has not been adequately cooling the building for the past two spring / summer seasons. The current unit is over 20 years old and requires R-22 refrigerant that is no longer manufactured, and very costly to obtain. The compressors are now obsolete along with circuit drivers. The current Variable Frequency drives replacement parts are obsolete and require replacement when break downs occur. When the Emergency repairs were made it was determined that a full replacement of the air cooled chiller and eleven variable frequency drives is necessary.

This repair is of an urgent nature and should be made prior to the spring of 2022.

**Daikin** provided pricing under cooperative Omnia contracts R200401-VA-312621 and R200401-VA-312635. A ten year warranty is recommended with this replacement.

The total pricing is \$220,610.00 and a breakdown is shown below.



# **Project Overview**

We have been requested by Prince George County Administration to price a replacement air cooled chiller at Prince George Administration Building. We have walked the site and gather the information on the existing equipment to properly size the replacement chiller for the customer. The current McQuay ALS chiller uses refrigerant R-22 and is not being manufactured any longer. Any major refrigerant leaks would lead to a very costly repair. The parts for the existing ALS chiller are also becoming obsolete. The screw compressors currently have no replacement options currently and are obsolete.

Daikin recommends replacing the existing McQuay ALS chiller with a Daikin AGZ air cooled chiller. The Daikin AGZ air cooled scroll chiller utilizes multiple compressor design in two circuit configurations. The AGZ Air Cooled Scroll Chiller fits well with in the existing infrastructure and space. Our selection for this chiller was referred to the original design specifications. The following benefits are for the AGZ Air Cooled Chiller option:

We have also provided Prince George County Administration with two warranty options over the standard first year parts, labor and refrigerant warranty to help minimize the impact to the Prince George in the future.

Option One is a 2nd thru 5th Year Parts, Labor & Refrigerant Extended Warranty.
