

## **Description and Current Status**



The County has received a proposal from Tencarva Machinery Company to provide two enclosed pump stations for \$204,400 each, for a total of \$408,800. Each enclosed pump station provides 2 pumps and motors and all associated piping, valves and panels to operate the station.

Staff recommends an award of contract for the purchase of two enclosed pump stations from Tencarva Machinery Company for \$408,800. Staff also recommends the use of ARPA funds for the costs of the purchase.

Concrete pad installation and electrical work is not included in the cost estimates provided by Tencarva Machinery Company. The **total estimated cost** for improvements at each station is **\$300,000**. Staff is also requesting budget transfers within the ARPA fund to cover the total cost of improvements as follows:

We propose to furnish a Gorman Rupp above-ground, factory assembled 8'x12' fiberglass enclosed pump station, to include a reinforced concrete base, 8' x 12' fiberglass housing with a hinged access door, thermostatically controlled vent fan, and internal station light. Included with the pump station are the following:

#### PUMPS AND MOTORS

Two Gorman-Rupp Ultra V-Series model V4A60-B pumps with a design capacity of 600 GPM @ 105' TDH when v-belt driven by a 40 HP 1,800 RPM, 3/60/230 volt, ODP motor. Pumps provided with drain kit, gauge kit and a spare parts kit.

#### INTEGRAL VALVES AND PIPING

Individual 6" pump suction piping including a flanged connection; 6" cast iron swing check valve, 6" plug valve for each pump discharge and a 6" pump station discharge provided with a flanged connection. Each pump is provided with an automatic air release valve.

#### PUMP MOTOR CONTROL PANEL/LIQUID LEVEL CONTROLLER

A Gorman Rupp factory fabricated control panel in a NEMA 1 stainless steel enclosure, housing main entrance terminal blocks; thermal magnetic circuit breakers, FVNR full voltage direct across the line solid state motor starters, hand-off-automatic switch, run light, elapsed time meter, high temperature shutdown circuit and motor overload reset for each pump motor; duplex service receptacle; electronic pressure switch with submersible level transducer liquid level control system with backup float high level alarm circuit, pump alternation circuit, wet well level indicator and an alarm silence circuit; phase/power monitor; 5KVA control voltage transformer

RESOLUTION: AWARD OF CONTRACT FOR PURCHASE OF TWO PUMP STATIONS – PUMP STATION 9 AND PUMP STATION 10 OF \$204,400 EACH (TOTAL \$408,800) AND A BUDGET TRANSFER FROM ARPA UTILITY CONTINGENCY ACCOUNT FOR \$600,000 TO COVER TOTAL ESTIMATED PUMP STATION 9 AND 10 IMPROVEMENTS.

WHEREAS, county owns and operates two pump stations installed in the 1980s that operate with the original pumping equipment, Pump Station #9 and Pump Station #10; and

WHEREAS, parts for the original station are becoming less available to keep these stations operable, and therefore, it is recommended the pumps, and the associated equipment, be replaced; and

WHEREAS, the County has received a proposal from Tencarva Machinery Company, for the purchase of two pump stations for \$204,400 each, or a total purchase price of \$408,800, and Tencarva Machinery Company is the sole source vendor for Gorman-Rupp pumps; and

WHEREAS, concrete pad installation and electrical improvements are not included in the equipment pricing and total rehabilitation is estimated at \$300,000 per pump station, or \$600,000 in total, and sufficient American Recovery Plan Act (ARPA) Funding is available to cover these costs.

NOW, THEREFORE BE IT RESOLVED: that the Board of Supervisors of the

County of Prince George this 13<sup>th</sup> day of September, 2022, hereby awards the contract for the purchase of two package pump stations to Tencarva Machinery Company for \$204,400 each, \$408,800 in total.
