Mr. Dan Whitten, County Attorney, stated that the By-Laws of the Board of Supervisors currently reference Virginia Code Section 2.2-3708.2 under Participation by Electronic Communication Means, Sec. 4. As of September 1, 2022, this Code Section is only applicable when there is a declared state of emergency. Virginia Code Section 2.2-3708.3 has been added to address participation by electronic communication means. The By-Laws will be amended to reference the correct Virginia Code Section and will now allow a member to participate by electronic communication if the member's principal residence is more than 60 miles from the meeting location identified in the required notice for the meeting. The By-Laws will also be amended to reflect the requirements for meetings held through electronic communication during declared states of emergency and that the provisions of this section are only applicable during the emergency. In addition, the Board has suggested that the County Attorney and the Clerk be included in communicating to the entire Board in a timely manner should any Board member meet with them regarding substantive comment. Mr. Webb suggested that they give Mr. Whitten time to add the last addition and bring the By-Laws back to the Board at the next meeting. ORDINANCE TO AMEND § 2-1 OF “THE CODE OF THE COUNTY OF PRINCE GEORGE, VIRGINIA”, 2005, AS AMENDED TO MAKE CHANGES TO THE BACKGROUND CHECK AND FINGERPRINTING REQUIREMENTS FOR PERSONS OFFERED CONDITIONAL EMPLOYMENT AND FOR VOLUNTEERS

BE IT ORDAINED by the Board of Supervisors of Prince George County:

(1) That § 2-1 of The Code of the County of Prince George, Virginia, 2005, as amended, is amended as follows:

CHAPTER 2 ADMINISTRATION

ARTICLE I. IN GENERAL

Sec. 2-1. Employment, ~~licensing~~ and volunteer service; background check.

- (a) This section is enacted pursuant to comply with the provisions of the Code of Virginia, § 15.2-1503.1, 15.2-1505.1, 15.2-1505.3 and 19.2-389(A) 7 to be able to access criminal history record information of any person conditionally offered county employment in order to determine whether the past criminal conduct of such persons would be compatible with the nature of such employment. Further, the provisions of this section are intended to be in addition to, and not in derogation of, all other federal and state statutes providing for access to criminal history record information concerning applicants for, and persons offered, county employment. In addition, this section is enacted to regulate employment by the county, a prospective licensee for any categories of license is required to submit to fingerprinting and volunteer service.
- (b) All persons conditionally offered employment ~~An applicant, licensee or volunteers seeking to engage in employment or volunteer service shall submit~~ to fingerprinting and provide personal descriptive information to be forwarded to the Central Criminal Records Exchange and the Federal Bureau of Investigation for the purpose of obtaining criminal history record information. All offers of employment or volunteering shall be conditioned upon the person, offered such employment or the opportunity to volunteer, submitting to fingerprinting and providing personal descriptive information necessary to do the background check. Failure of the person to submit to fingerprinting and to provide personal descriptive information shall disqualify the person from employment in such position or from serving as a volunteer. ~~if required, two sets of his fingerprints taken by the county police department to the Central Criminal Records Exchange in Richmond, Virginia, along with the appropriate fees.~~
- (c) Upon receipt of the fingerprints ~~and the appropriate fees, the~~ human resources department ~~county police department will transmit both sets of~~ the fingerprints and appropriate fees ~~(unless a satisfactory billing arrangement has been entered into between the police department and the Central Criminal Records Exchange)~~ personal descriptive information through ~~to~~ the Central Criminal Records Exchange. The Central Criminal Records Exchange will compare the subject's fingerprints against its criminal file and, if no disqualifying conduct is found therein, submit the fingerprints to the Federal Bureau of Investigation for a comparison with nationwide records. The results of the Federal Bureau of Investigation will be returned to the Central Criminal Records Exchange, which will disseminate the state and national results to the ~~police department~~ human resources department.
- ~~(d) The county police department shall disseminate the results of the criminal background check to the county for fitness determination.~~
- ~~(d) In rendering a fitness determination, the county will decide whether the record subject has been convicted of or is under pending indictment for:~~
- ~~(1) A crime which bears upon his ability of fitness to serve in that capacity; or~~
 - ~~(2) Any felony or a misdemeanor which involved force or threat of force, controlled substances, was a sex-related offense, or a crime involving moral turpitude; or~~
 - ~~(3) Has been the subject of a founded child abuse or neglect complaint~~

Upon receipt of a report from the Central Criminal Records Exchange concerning a person either conditionally offered employment or to volunteer that indicates that the person has a criminal history record, the human resources director shall determine whether the conviction contained in the record directly relates to the authorized position, whether the past criminal conduct contained in the record is

compatible with the nature of the employment or volunteering in the authorized position, and whether such conviction disqualifies the person from employment or volunteering in that authorized position. In determining whether a criminal conviction directly relates to the position, the following shall be considered:

- (1) **The nature and seriousness of the crime;**
- (2) **The relationship of the crime to the work to be performed in the position applied for;**
- (3) **The extent to which the position applied for might offer an opportunity to engage in further criminal activity of the same type as that in which the person had been involved;**
- (4) **The relationship of the crime to the ability, capacity or fitness required to perform the duties and discharge the responsibilities of the position being sought;**
- (5) **The nature and extent of the person's past criminal activity;**
- (6) **The age of the person at the time of the commission of the crime;**
- (7) **The amount of time that has elapsed since the person's last involvement in the commission of a crime;**
- (8) **The conduct and work activity of the person before and after the criminal activity; and**
- (9) **Evidence of the person's rehabilitation or rehabilitative efforts while incarcerated or following release.**

~~(e) Any such person will be presumptively disqualified and any such person who is presumptively disqualified will only be permitted to engage in employment or volunteer service if authorized by the county administrator and county attorney.~~

~~(e)~~(f) A record subject denied employment, licensure or service as a volunteer shall be notified that information from the Central Criminal Records Exchange contributed to such denial. Should the record subject seek to amend or correct his record, he must contact the Central Criminal Records Exchange for a Virginia record or the Federal Bureau of Investigation for records from other jurisdictions maintained in its file.

That position was held for 15 years by Ms. Hamilton, who recently left the position to focus on her private practice. Ms. Fierro is requesting that the Board consider making this part-time position a full-time position for the next fiscal year as well as back filling it to finish out this fiscal year. The increase in costs for a full-year is \$80,863. To back-fill, it would be an additional \$25,806. The person in this position handled some of their most complex cases, including the domestic violence docket, and crimes committed against children. Many of these cases went to jury trial. Right now the position is

advertised as a part-time position. They currently have five applications, but she is not sure any of them would be viable candidates at this time. Their work has increased substantially since July, 2021 since the General Assembly change regarding optional jury trials. It has created a large increase in jury trials. In 2019, they had four jury trials. In 2022, they had 34 jury trials. A large amount of time is dedicated in preparing for these trials, including pre-trial motions, cross-examination of witnesses, and research. The ceasefire prosecutor is a shared position with Hopewell and it will be limited to gun violence and gun crime and they will not be any assistance to cases regarding regular domestic violence and children. Mr. Webb asked if the ceasefire prosecutor will have the option to change the venue to assure no bias. Ms. Fierro stated that she will have that option. Mr. Carmichael asked if the request for this full-time position is salary or will there be overtime. Ms. Fierro stated that all of the attorneys are salary and are not compensated for overtime. The Board agreed by consensus to have this request placed on the January 24 agenda.

A-9. Resolution: Award of Contract for Portable TP125 110kW Generator (Bay Power Solutions \$97,167). Mr. Dean Simmons, General Services Director, stated that the Board of Supervisors approved an award of contract to L3Harris for a replacement Public Safety Radio System on November 26, 2019. The County engaged in Series 2017 and 2018 Borrowing for Radio System Replacement and related consulting services. Staff briefed the Board of available funds remaining in the Radio System Project budget / borrowings during the November 22, 2022 work session. A-11. Resolution: Award of Contract Fire & EMS ESO Software (\$57,708.32). Chief Paul Beamon stated that the Board of Supervisors approved an award of contract to L3Harris for a replacement Public Safety Radio System on November 26, 2019. The County engaged in Series 2017 and 2018 Borrowing for Radio System Replacement and related consulting services. Staff briefed the Board of available funds remaining in the Radio System Project budget / borrowings during the November 22, 2022 work session. Staff recommends a number of purchases that enhance the Radio System project and / or public safety operations. The Radio Project working group recommends the purchase of integrated Fire & EMS software from ESO. The Board was provided with a quote from ESO for \$57,708.32, utilizing a cooperative contract through the Western Virginia EMS Council for the software modules specified on the quote. Annual recurring subscription costs will be included in the operating FY2024 budget and in future budgets (estimated at \$52,309). Sufficient funds are available to purchase year one of software subscription costs (initial, one-time costs and year-1). This award of contract will allow the County to move forward with purchasing an integrated software solution that will enhance Fire and EMS operations and related reporting. By moving to the ESO reporting platform, PGFEMS will consolidate all career and volunteer members under one system and provide the same reporting system implemented and supported by the Commonwealth. In addition, PGFEMS will improve data collection and analysis, enhance decision-making with access to accurate and up-to-date data, increase efficiency, create better communication and collaboration, and enhance accountability. Mr. Carmichael asked what the radio budget balance is following this request. Ms. Drewry stated \$844,000. Chief Beamon added that this would align us with the State EMS database. The State Office has informed him that the first initial computers and tablets would all be free if they go to that system. Mr. Webb stated that if his memory serves him correctly, the State made it clear that if we do not have the prerequisites, they will not allow you to jump ahead and take someone else's spot in monies for training. A-12. Resolution: Authorize the FIRE/EMS Department to Complete and Submit a Grant Application to FEMA for SAFER Staffing. Chief Paul Beamon stated that the Prince George Fire and EMS Department (hereafter referred to as PGFEMS) is requesting approval from the Prince George County Board of Supervisors to pursue grant opportunities offered by the Department of Homeland Security (DHS) and Federal Emergency Management Agency's (FEMA) entitled "Staffing for Fire and Emergency Response (SAFER) Grant Program" (hereafter referred to as the SAFER Program). PGFEMS is seeking authorization to apply for a total of 9 positions under the SAFER Staffing Grant of a three (3) year total of \$2,424,160.00 (\$808,053.00 per year) through FEMA, due February 4, 2023. During the three (3) year life, the SAFER Grant is funded 100% and covers all salaries and benefits with no cost share or match by the County. The SAFER Grant does not pay for the built-in overtime for the firefighters resulting an expense to the County of \$53,596 per year. At the end of the three (3) year grant period, the SAFER grant discontinues the funding, and the County would then pick up the full financing of the positions estimated at \$861,649 per year. The PGFEMS career staffing model currently consists of two (2) paid providers located at four (4) stations. The firefighters at these stations operate in a dual function role. Dual function is used when the two (2) firefighters are used to staff more than one fire vehicle. The firefighter will staff the ambulance when a request for medical assistance is made, thereby leaving the fire engine unstaffed and unable to answer calls. When a request for a fire engine is made, the team will take the fire engine and leave the ambulance without any certified members to respond to calls such as chest pain. In a recent review, we found that the career-staffed fire engines are left unstaffed for approximately 142 days out of the year. Our heavy volume stations are currently Station eight (8) and station five (5). The two of these stations account for a total of 85 full days (2,040 hours) of unstaffed fire engines that result in no coverage or delayed responses to emergency calls in those areas. With nine (9) additional career members, we would place the additional members at two of the busiest stations. Mr. Webb stated that in eight years this County will have a larger population than the town of Charlottesville. If we do not plan for it, we will be in the same boat that we are in with utilities. We have been fortunate to get a lot of money for utilities from the pandemic. He stated that the County is in a good state financially, which may not always get a grant for us. The volunteers do a great job, but we need all of the help we can get. Mr. Webb asked that if we are lucky enough to get this grant, how long will it take to train them and become fully functional. Chief Beamon stated that it takes a 16-week training program regardless of the experience.

Ms. Betsy Drewry, Deputy County Administrator, Finance, stated that the Commonwealth’s Attorney received Board permission to apply for a Virginia Department of Criminal Justice Services (DCJS) Operation Ceasefire grant on November 9, 2022. The grant was awarded by DCJS on December 15, 2022, totals \$249,996.00, and is for a two-year period of January 1, 2023 – December 31, 2024. There is no required local match, but in-kind support (facility and supplies) will be provided for this position. Mr. Webb asked if the position is fiscally shared equally between the two localities. Ms. Drewry stated that it is 100% funded by the grant. A-14. Resolution: Authority to Advertise Public Hearing to Approve New Polling Locations for the Rives and Jefferson Park Precincts. Mr. Dan Whitten, County Attorney, stated that Walton Elementary School is the current polling location for the Rives (104) Precinct. Walton Elementary School is scheduled to close in February, 2023 and move to the new Middle Road Elementary School. Faith Baptist Church on Middle Road is the current polling location for the Jefferson Park (205) Precinct. There are concerns about accessibility from the parking lot to the rear basement entrance. You have to walk down a steep hill which could be dangerous in inclement weather. Also, there are ADA concerns since there is limited handicap parking by the rear entrance. The Board of Elections and Registrar's office has been able to secure new polling locations for the Rives and Jefferson Park Precincts. Rives Precinct polling location will be Sacred Heart Catholic Church at 9300 Community Lane, located on Route 460, County Drive. Jefferson Park Precinct polling location will be the new Middle Road Elementary School, 5400 Middle Road. To make these changes, the Board will need to amend County Code § 30-62 to designate new polling locations. The Registrar's office will mail letters to the public advising them of the new polling locations.
