PRINCE GEORGE COUNTY BEGINS REVITALIZATION AT EXIT 45



Located off of I-95, Exit 45 was once a flourishing exit known as a destination for travelers, but the exit has not maintained this reputation as tourism trends have changed. This exit is now a revitalization priority for

the County. The County contracted with Sanford Holshouser to conduct an Exit 45 Strategic Vision and Action Plan. After thorough research and stakeholder meetings, the plan was developed.

One of the six economic development goals listed in the plan is to obtain and redevelop the Continental Motel property. Prince George County has worked since late 2021 to obtain ownership of the property, with the County closing on the property on July 18. A golden sledgehammer demolition ceremony at the property on August 10. The County will market the greenspace for redevelopment for a tourism-related business.

"Prince George County is excited to take the next steps for the revitalization of Exit 45," said Chair Marlene J. Waymack of the Prince George County Board of Supervisors. "Purchasing the Continental Motel property and its future redevelopment moves Exit 45 forward and indicates that Prince George County is invested in the revitalization effort."

NEW ELEMENTARY SCHOOL UPDATE


The ground breaking for construction of a new elementary school along Middle Road was held in May of 2021 and construction remains underway. The new school will replace existing William A. Walton Elementary School, which was



constructed in 1960. At its July 2022 meeting, the Prince George County School Board approved the new school's name as "Middle Road Elementary School." The school will accommodate 850 students ranging from Pre-K to fifth grade.

Construction is approximately 80% complete. Loughridge & Company have estimated substantial

completion will occur mid-November 2022, and that students and staff will be able to move into the school in early 2023. School personnel are currently monitoring the estimated substantial completion date.



BUSINESS SHOW & JOB FAIR

Prince George County will host a Business Show and Job Fair on Friday, November 4, 2022 from 11 a.m. -3 p.m. The event will take place at the Central Wellness Center, located at 11023 Prince George Drive Disputanta, VA 23842. The County is partnering with the Department of Social Services and Prince George County High School to include students and various workforce services. COURTHOUSE RENOVATIONS

The design stage for the long-awaited renovations to the Prince George Circuit Courtroom were presented to the Board of Supervisors at their August 9 meeting. The Board gave consensus to move forward to solicit bids for the renovations. The renovations will include updated courtroom finishing along with audio-visual upgrades. Other updates will include the jury room, witness rooms, assembly rooms and a generator to provide power in the event of an outage. The estimated cost of the project as prepared by Mosley Architects and presented to the Board was \$2,190,042. The project is currently out for bid.

NEW CONVENIENCE CENTER SITE

The Board of Supervisors determined that a second convenience center was needed for the citizens of Prince George County. General Services reviewed locations that would be best suited for this center and presented their

findings to the Board. The architectural firm of Guernsey Tingle has been instructed to proceed with the site development plans at the Yancey property. Plans are being developed and a Spring 2023 construction date is anticipated.



COUNTY GARAGE EXPANSION UNDERWAY

During the adoption of the FY2021 budget, the Board of Supervisors approved funding for \$3,065,000 in Capital Improvements to expand the County Garage. The project was pushed back and demolition work began on June 27.

The expansion will include two additional heavy-duty repair bays that will accommodate large fire apparatus. The bays will be capable of housing up to four fire engines and the ceiling will be tall enough to raise the ladders for maintenance on the County's two aerial trucks. The expansion will include a reception area, office, parts room, meeting room and an additional equipment storage area. An upgraded generator will be included to ensure that the garage remains fully operational in the event of an emergency.



The contract was awarded to Loughridge & Company with Guernsey Tingle overseeing the architectural and engineering aspects of the project. The expansion is scheduled to be complete by Spring 2023.

PARKS AND RECREATION

SPORTS AND PROGRAM SCHEDULE HIGHLIGHTS

Youth Basketball - Prince George Parks and Recreation is offering Basketball registration for Prince George youth aged 7 – 15 for the following divisions: Mini-Mites (Co-Ed - Boys and Girls age 7 – 8); Pee-Wee Boys Basketball (age 9 -10); Junior Girls Basketball (age 9 – 11); Junior Boys Basketball (age 11 – 12); Senior Girls Basketball (12 -15); and Senior Boys Basketball (age 13 – 15). The age division is determined by the age the child will be on or before January 1, 2023. Registration is available through October 28, 2022. The season starts at the beginning of December, and runs through the end of February. The fee is \$30 for one child, \$50 for two

Disc Golf - Prince George Parks and Recreation celebrated the grand opening of the new disc golf course "Pine Valley at Scott Park" on September 27. The course is located at 6000 Scott Memorial Park Rd., Prince George, VA 23875. The disc golf course is open daily from dawn - dusk. Players can download an app on their phone to score their rounds, measure their throws, and discover new courses. Parks and Recreation would like to give thanks to Richard Scott and Jay Risher, both of whom volunteered countless hours designing and

developing the course! The course is free and open to the public. Participants must supply their own equipment.

The Registrar's Office is located in the County Administration Building. Office hours are Monday through Friday from 8:30 a.m. to 5:00 p.m. In-person absentee voting starts September 23 from 8:30 a.m. to 4:30 p.m. Monday through Friday with Saturday hours available on October 29 and November 5 from 9:00 a.m. until 5:00 p.m.

Failure to notify the Registrar's Office of any change in name or address may result in temporary loss of voting privileges. If in doubt, please call the Registrar's office and verify your voting information. This will save you time on Election Day. Any questions about those affected by the restoration of rights for felons are urged to contact the Registrar's Office for information at (804) 722-8748.

Bring Your ID - You need to show your ID or sign an ID confirmation statement to vote in person in this election.

Acceptable forms of identification:

- Voter confirmation documents
- Virginia DMV-issued driver's license* or ID card **
- United States Passport (valid)
- Employer-issued photo ID (valid)
- Student ID issued by a Virginia college/university/high school (valid)
- Student photo ID issued by U.S. college/university (valid)
- Other U.S. or Virginia government-issued ID
- Tribal enrollment or other tribal ID (valid)
- Virginia Voter Photo ID card
- Any current utility bill, bank statement, government check, paycheck, or other government document with your name and address (within the past 12 months)
- A signed ID confirmation statement
- *Virginia law permits an expired Virginia DMV license to be used for voting purposes.
- **A Virginia driver's privilege card is not acceptable for voting purposes.

A voter who does not bring an acceptable ID to the polls or does not sign an ID Confirmation Statement will be offered a provisional ballot.

PRINCE GEORGE COUNTY STRATEGIC PLAN UPDATE

The Board of Supervisors recently completed the Strategic Plan for the County with the assistance of County citizens, community stakeholders, and County staff. The process was facilitated by the consulting firm Managing Results, LLC. and identifies the four main strategic priorities of the Economic Development Board: Infrastructure, Prosperity, Land Use & Development, and Good Governance. The Strategic Plan will be used by the County to guide budget decisions and to measure results of service delivery to our community. Through aligning operations to the Strategic Plan, budgeting to achieve the results identified in the Plan, and demonstrating performance of County operations and budgeting, we are able to build trust with and show accountability to our taxpayers. ELECTION PRECINCTS BOUNDARY CHANGES

On December 28, 2021, the Supreme Court of Virginia approved and adopted final redistricting maps for the State's congressional districts, House of Delegates districts, and State Senate districts. The State's final redistricting maps split the Courts (204) precinct. Section 24.2-307 of the Code of Virginia requires that each voting precinct be wholly contained within a single congressional district, Senate district, House of Delegates district, and election district used for the election of one or more members of the governing body or school board. In order to cure the voting precinct split, the Board was required to adjust the precinct boundaries. To make this change, the Board amended County Code § 30-61 to adjust boundaries for the Courts (204) precinct and Bland (201) precinct. As a result, approximately 300 registered voters moved from the Courts (204) precinct to the Bland (201) precinct. In addition, the Board amended § 30-62 of the County Code to move the polling location for the Courts (204) precinct from the Courts Building to Abundant Life Church, located at 6500 Middle Road in Prince George, Virginia. On April 21, 2022, the Virginia Office of the Attorney General sent a certification of no objection for such changes. The Registrar has mailed a notice to the registered voters affected by such changes.

FIRE STATION 8 UPGRADES

Prince George Fire Station 8 is undergoing much needed electrical upgrades. After several months of planning by General Services and the architectural firm of DJG, and with product delays, work will begin around December 2022. The



upgrades include: complete rewiring of the building, generator replacement and a new electrical panel to include single phase electrical service to three phase service. After the improvements are made, the building will provide a safer environment for the staff that is housed in the building. This work is being performed by Frazier Electrical and Prince George General Services Department.

TWO COUNTY DEPARTMENTS HAVE NEW LEADERSHIP

Prince George County Administrator Jeffrey Stoke



announced two new key leaders for the County on August 1. Brian E. Gordineer was welcomed as the new Real Estate Assessor. He was the prior Assessor for the City of Petersburg. Stoke said, "In his first two years with the City of Petersburg, he and his team earned the City the Certificate of

Excellence in Assessment Administration, an achievement shared by just fifty assessment offices across the world. His leadership style fits perfectly into the opportunities ahead to continue to advance the department." Gordineer received his Bachelor's Degree from The College of William and Mary, and his Master's of Business Administration from The College of William and Mary – Mason School of Business.

Panayiotis "Yoti" Jabri was the former Director of Economic Development for Surry County. He returns to Prince George where he previously held the position of Economic Development Specialist. Mr. Stoke said, "We are very pleased to be able to appoint Mr. Jabri to



this very important County position. He has worked on several major economic development initiatives over the years and is very familiar with our community." Jabri received his Bachelor of Business Administration from Longwood University, and his Master of Arts in Economics/Public Administration from VSU.

CHANGE IN THIRD-PARTY PAYMENT PROCESSOR AND RELATED FEES

The County will be migrating from Elavon to Tyler Payments as its third party payment processor because of required financial system upgrades. The credit and debit card processing fee, which is passed along to

customers/citizens, will increase from 1.4% to 3% (with a \$2.50 minimum fee). New features & enhancements are: Acceptance of e-checks - \$1.75 flat fee (on-line & in person), acceptance of American Express and acceptance of Apple Pay. October 31 is the targeted completion date for the upgrades and changes to the Citizen Self Service portal. Be on the lookout for more information about these changes.



TAX REMINDER FY23

First half of FY2023 real estate taxes are due on or before December 5, 2022. Taxes not paid by this date will be subject to an immediate 10% penalty, plus interest. If you own property in Prince George County and do not receive a tax bill, please call (804) 722-8750. Tax bills should be mailed no later than November 5, 2022. Failure to receive a bill does not relieve the taxpayer of any additional charges that will accrue under the law for failure to pay within the prescribed time. Please bring in or mail the bottom portion of each bill with payment. Office hours are 8:30a.m. to 5:00p.m., Monday thru Friday. Drop boxes are available at the County Administration Building. (Must be postmarked by the U.S. Postal Service by December 5, 2022).

OPIOID SETTLEMENT FUNDS ROLL IN

The County has begun receiving settlement distributions from nationwide settlements with three pharmaceutical distributors and opioid manufacturer that helped to fuel the opioid epidemic. In all, Virginia and its localities will receive approximately \$530 million over a period of years in the settlements with the drug distributors McKesson Corp., AmerisourceBergen Corp. and Cardinal Health, and the prescription opioid manufacturer Janssen Pharmaceutical. These settlements resulted in part from the efforts of the County, who first filed suit against these defendants several years ago.

Last year, the Office of the Virginia Attorney General successfully partnered with each of Commonwealth's 133 cities and counties to reach 100% agreement in support of a structured program for distributing opioid settlement funds.

Under the terms of the agreement between the state and its local jurisdictions: 15-percent of settlement funds will be allocated to the Commonwealth of Virginia, and 30-percent of settlement funds will be allocated to Virginia's cities and counties of which at least half of the funds must be spent on communitybased opioid abuse prevention, treatment and recovery efforts. Each locality's allocation is based on specific local metrics, including the number of opioid-related ER visits and overdose deaths and the volume of opioid prescription drugs shipped into each locality. The remaining 55-percent of settlement funds will be administered by the Virginia Opioid Abatement Authority to provide additional and ongoing support for local, regional and state opioid abuse abatement efforts.

Going forward, local, regional and state opioid abatement efforts are expected to be further supplemented by additional settlements, verdicts or court orders involving others who participated in the manufacture, marketing, distribution and sale of opioids in Virginia.

COUNTY RECEIVES \$90K IN TOURISM MARKETING RECOVERY FUND

The Virginia Tourism Corporation (VTC) received \$50 million in American Rescue Plan Act (ARPA) funds from the General Assembly. VTC directed the majority of that funding to each Virginia locality to be designated for tourism marketing, media, public relations, sales, and product development.

Based on Prince George County's relative share of tax revenue to total state tax revenue attributable to tourism in 2019, Prince George County received \$90,000 from VTC to be spent by June 2024.

"This appropriation is an opportunity to the statewide tourism industry with its continued recovery efforts," said Rita McClenny, President and CEO of Virginia Tourism Corporation. "The localities and DMOs for each destination will be able utilize these much-needed funds to help drive increased visitation and revenue generation."

Prince George County, with authorization from VTC, will allocate our spending to three different areas. The first is sports tourism, where we will update our sports tourism marketing collateral, attend a sports tourism trade show, make physical improvements to sports facilities, and join a sports tourism trade association. The second is a targeted marketing campaign to promote the tourism assets and destinations throughout the County that will include print media, digital media, partnerships, and media relations. The third is donations to organizations to bolster our tourism destinations. Please contact our Economic Development and Tourism department for more information.

UTILITY EXPANSION PROJECT UPDATES

<u>Water Main Extension to Route 10 Corridor</u> - The County was awarded \$3.2M in Community Project Funds from the Office of Congressman McEachin to aid in County efforts to extend its central water system 4.5 miles from Sandy Ridge Road to serve the subdivisions of Jordan on the James and Beechwood Manor. The design is complete and construction is anticipated to begin late 2022 with project completion anticipated in early 2024.





Temple Ave Water Storage Tank & Booster Station and 24" Waterline Under the Appomattox River - A new one million gallon water storage tank and booster

station to be located on River Road near Temple Avenue will replace the existing booster station. The new station will allow the county to use its full water supply allocation. The 24" waterline proposed to be drilled under the Appomattox River will increase capacity and reliability, replacing the existing 16" waterline that hangs on the bridge. The two projects will increase the water supply capacity by approximately 1.2-1.5 million gallons per day. The river crossing is anticipated to be complete by mid-2024 and the storage tank and booster station are anticipated to be complete by April 2025.

Route 156 Water Storage Tank & Booster Station - A new half million gallon water storage tank and booster station to be located on Middle Road near Route 156 will connect to the Virginia American Water supply that currently serves the City of Hopewell. This will add around one million gallons per day of supply capacity and add redundancy by adding a new supply source. The project is currently under design and is anticipated to be complete in mid-2025.



Southpoint Business Park Force Main Realignment - The Southpoint Business Park is served by two sewer pumping stations that pump into a common force main that

discharges into a gravity sewer along Route 460. This gravity sewer is at its full capacity preventing new businesses from locating in the Park. This project will reroute the force main to bypass the gravity sewer and discharge downstream to another sewer system that is able to convey the sewer, which will provide additional wastewater conveyance capacity to the Park. The engineering design is near completion and construction activities are anticipated to begin late 2022. The project is anticipated to be complete by October 2023.

INTERSECTION IMPROVEMENTS AT COURTHOUSE ROAD (RT. 106) AND BULL HILL ROAD (RT. 630)

The purpose of the project is to replace the existing, skewed intersection at Courthouse Road and Bull Hill Road with a single lane roundabout in a dog bone shape to improve both safety and operation.

The intersection provides access to Route 460 and I-295, and is part of a main route to the Fort Lee activity center. Proposed intersection improvements will reduce crashes and congestion in the area.

According to VDOT, the total estimated cost for the project is \$5.7 million. The construction is slated to start this fall, with an estimated completion date of winter 2023-24.
