- GENERAL FUND OPERATIONS:

- General Fund, **Fund Balance grew by \$5,074,514** between 6/30/2020 and 6/30/2021; Fund Balance at 6/30/2021 = \$33,403,287 (31.01% of Expenditures)







AMERICAN RECOVERY PLAN ACT FEDERAL FUNDS 2021 ANNUAL REPORT

THE COUNTY RECEIVED \$3,724,810.50 IN FEDERAL AMERICAN RECOVERY PLAN ACT (ARPA) FEDERAL FUNDING IN AUGUST OF 2021 AND WILL RECEIVE ANOTHER TRANCHE OF \$3,724,810.50 IN AUGUST OF 2022

- TO DATE, THE PRINCE GEORGE COUNTY BOARD OF SU-PERVISORS HAS EARMARKED USING THE FUNDS TO:
 - Provide a car tax rebate to residents who saw an increase in vehicle values between 2020 and 2021 [Application Process opened on January 1, 2022]
 - Compensate call center and additional cleaning staff during the pandemic
 - Purchase a safe board meeting platform that allows for virtual board meeting attendance and viewing
 - Purchase an air filtration system for the Courthouse
 - THE MAJORITY OF THE FUNDS WILL BE EAR-MARKED TO PAY FOR UTILITY INFRASTRUCE IM-PROVEMENTS AND EXPANSION PROJECTS
