## MIDDLE ROAD ELEMENTARY WELCOMES STUDENTS

Middle Road Elementary School opened its doors to students on February 21, 2023. Taking nearly two years to complete, the new 98,000-square foot building has a student capacity of 850. The school replaces William A. Walton Elementary School, which served the community for over 60 years.

Middle Road showcases educational innovations including expansive collaborative learning spaces in each wing of the Pre-K – 5 school, additional areas for reading and math interventionists, and other resources to support student learning. The campus' built-in flexibility allows for learning spaces to be adjusted in order to serve the community for years to come.

## FISCAL YEAR 2024 INTRODUCED BUDGET

County Administrator Jeffrey Stoke presented the introduced Fiscal Year (FY) 2024 budget to the Board of Supervisors (BOS) and the public on March 14. The presentation followed three pre-budget work sessions where Board members provided input into budget priorities.

The introduced budget keeps the Real Estate Tax rate at \$0.82 per \$100 of assessed value and keeps the Personal Property Tax rate at \$3.90 per \$100 of assessed value. The real property values increased between 2022 and 2023, and there will be an effective tax increase for FY 2024 based on higher assessments. Personal property values have dropped, but not to pre-pandemic levels. There are 5% increases proposed in both the water and sewer rates for FY 2024 to address inflation and to maintain existing systems and equipment. A public hearing on water and sewer rates was held on April 11. A public hearing on tax rates is scheduled for April 25.


#### Introduced Budget Highlights:

1. The budget includes step increases for all County employees, along with market regrades for positions whose pay is below regional market averages. The BOS previously approved January 1, 2023 market regrades for public safety employees, and similar market increases are included in the FY 2024 introduced budget for non-public safety employees. Multiple position reclassifications resulted from an internal market study and the County will adjust pay and position titles to compete for and retain talented employees. The County must provide a mandated pay increase for state-supported Social Services and Riverside Criminal Justice Agency employees and must fund Virginia Compensation Board pay increases for Constitutional Officers and their employees. These proposed and mandated compensation increases will cost \$1,383,967. Another \$988,238 has been budgeted to continue the increases for public safety employees approved on January 1, and other position changes and reclassifications approved throughout FY 2023.

3. A General Fund transfer to the Capital Fund of \$993,374 is proposed for the purchase of public safety and county vehicles (\$450,000) and school buses (\$543,374). Another General Fund transfer to the Capital Fund of \$314,502 is included to purchase Fleet Focus, an automated vehicle/apparatus fuel management system. The County proposes to upgrade to Microsoft Office 365 in FY 2024 at a cost of \$64,800. The budget includes \$260,000 within the General Services budget to address needed facility repairs throughout the County. There are no planned General Fund-supported capital projects or purchases that will require the issuance of debt during FY 2024. The introduced budget reduces the General Fund debt contribution by \$215,000 for FY 2024 because County vehicles and school buses are now cash funded, not financed by borrowing.

4. The County proposes to update its Comprehensive Plan during FY 2024 (estimated at \$115,000) and perform a first round of department strategic plans, estimated at \$100,000.

5. The proposed General Fund transfer to the Public School Division remains at \$18,553,165, the same as in FY 2023, even though there have been continued decreases in student enrollment numbers amidst County population increases. The amount slightly exceeds the transfer calculated using the Revenue Sharing Formula that has been in place since FY 2007. The budget proposal includes County contributions of \$18,553,165 to the School Operating and Textbook Funds, \$2,827,767 for school debt, and \$543,374 for the purchase of school buses for FY 2024. These combined contributions to and payments for the school system total \$21,924,306 and represent 30.3% of the FY 2024 Introduced General Fund Budget.

The BOS continues its work in reviewing and revising the FY 2024 budget. State revenue projections will be fine-tuned for both the General Fund and the Public School System once the Virginia General Assembly completes the state budget. A work session is planned for May 2 and a public hearing on the FY 2024 budget is scheduled for May 9. The Board plans to adopt the budget on May 23.

# **INTERSECTION IMPROVEMENTS**

The total estimated cost to replace the existing, skewed intersection at Bull Hill Road and Courthouse Road with a single lane roundabout is \$5.7 million, according to the Virginia Department of Transportation (VDOT). The construction is slated to start in October 2023, with a fixed completion date of November 2024.

VDOT indicates a single lane roundabout in a dog bone shape will improve both operation and safety.

The intersection provides access to Route 460 and I-295, and is part of a main route to the Fort Lee activity center. Proposed intersection improvements will reduce congestion and crashes in the area.

# GARAGE EXPANSION



Approved in the FY 2021 budget, the County Garage is nearing completion. The new bays are capable of housing four fire engines. The ceilings are tall enough to raise the ladders for maintenance on the County's two aerial trucks. Larger apparatus can now be repaired indoors.

The garage has a new separate entrance to a reception area where visitors can wait while vehicles are serviced. A designated parts room, meeting room, tire service area, lube/compressor room, equipment storage area, and management office were also created. An upgraded generator exists to ensure that the garage remains fully operational at all times. The upgrades allow Fleet Management to maintain and dispatch safe, reliable vehicles and equipment for all County departments including Police, Fire and EMS.

# UTILITIES UPDATES



Water Main Extension to Route 10 Corridor

The County was awarded \$3.2M in Community Project Funds from the Office of late Congressman McEachin to aid in County efforts to extend its central water system 4.5 miles from Sandy Ridge Road to serve the subdivisions of Jordan on the James, Eagle Preserve, Beechwood Manor, and Chappell Creek. The construction contract has been awarded and construction is anticipated to begin spring 2023, with project completion anticipated in fall 2024.



## Southpoint Business Park Force Main Realignment

The Southpoint Business Park is served by two sewer pumping stations that pump into a common force main that discharges into a gravity sewer along Route 460. This gravity sewer is at its full capacity, preventing new business from locating in the park. The project will reroute the force main to bypass the gravity discharge sewer and downstream to another sewer system that is able to convey the sewer. This will provide additional wastewater conveyance capacity to the Park. Construction began in March 2023 and the project is anticipated to be complete by October 2023.



Blackwater Swamp Wastewater Pump Station

Design has started on a new 3.25 million gallon per day wastewater pump station to be located near the intersection of Prince George Dr. and E. Quaker Rd.

This project will increase the wastewater conveyance capacity for this portion of the County, allowing for new growth and development in the Southpoint Business Park, Crosspointe Centre, and the surrounding area. Design and construction are anticipated to take four to five years.

## Temple Ave. Water Storage Tank & Booster Station and



24" Waterline Under the Appomattox River

A new one million gallon water storage tank and booster station, to be located on River Rd. near Temple Ave., will replace the existing booster station. The new station will allow the County to use its full water supply allocation. The 24" waterline, proposed to be drilled under the Appomattox River, will increase capacity and reliability.

The two projects will increase the water supply capacity by approximately 1.2-1.5 million gallons per day. The river crossing is anticipated to be complete by mid-2024 and the storage tank and booster station is anticipated to be complete by April 2025.

# COMMUNITY CLEAN UP DAY

Prince George County held its Annual Community Day on April 15. Residents arrived in droves to the County Government Complex and the Prince George Convenience Center to dispose of tires, household hazardous waste, white goods, yard debris, unwanted household items and trash at no cost. It is estimated that more than 70 tons of materials were collected during the event.

### Route 156 Water Storage Tank & Booster Station

A new half million gallon water storage tank and booster station to be located on Middle Road near Route 156 will connect to the Virginia American Water supply that currently serves the city of Hopewell. This will add one million gallons per day of supply capacity and increase reliability by adding a new supply source. The project is currently under design and is anticipated to be complete by mid-2025.

#### Route 301/Exit 45 Groundwater Withdrawal Permit Renewal

A new groundwater withdrawal permit for the Route 301/Exit 45 area has been issued. The new permit allows for the addition of a new well that will increase the available capacity in this area of the County. This increase will allow the County to meet the goals established in the strategic plan for this area. Design has started on siting and drilling the new well. Work is anticipated to be complete by fall 2023.

There are various tourism-related businesses along the trail including outdoor recreation venues, restaurants, and retail establishments. The formation of this trail creates a platform to market each of these businesses and localities together as a tourism destination.

# SEPTIC PUMPOUT PROGRAM

2018. In the Prince George Department of County Community Development & Code Compliance-Environmental Division acquired the of management the Septic Pumpout and Inspections Program from the Virginia Department of Health. The intent of the program is to help improve water quality in the Chesapeake Bay Protection Area (CBPA) of the County non-point through source pollutant management. Under the provisions of the Chesapeake Bay Preservation Act. owners of properties within the James and Appomattox River watersheds serviced by private on-site septic systems are required to have those systems pumped or inspected once every five years.

With the completion of compliance mailings to Zones 1 through 5, approximately 2,500 households and businesses located within the CBPA have been notified of the County ordinance requirement. The mailings include a program description, the property owner compliance deadline, and a verification and compliance form to be submitted to the department.

#### Compliance results:

Zone 1 - 77% (382 Properties) - 2022 Zone 2 - 80% (1048 Properties) - 2018 Zone 3 - 83% (399 Properties) - 2019 Zone 4 - 81% (356 Properties) - 2020 Zone 5 - 63% (184 Properties) - 2021

## VOTING PRECINCT CHANGE
