We request that you do not reveal what you see or hear during the tour that could be detrimental to the prosecution of any cases arising from the officer's performance of duty. You may be called upon to be a witness in a court proceeding and you may be called upon for assistance. The decision for this will rest upon the officer to whom you are assigned and the circumstances.

All participants are expected to wear business-like attire and are only permitted to participate twice within a twelve (12) month period unless further approval is granted by the Chief of Police. Civilian Observer participants will not be permitted to carry weapons of any kind. Cameras and tape recorders are not permitted unless prior approval is granted by the Chief of Police.

The Prince George County Police Department's Civilian Observer Program is a privilege extended to persons who are interested in observing the police officer, his duties and how he/she interacts with the community. The Department reserves the right to refuse participation in the program based on the same standards that are used for employment in relation to false statements or arrest records.
