UTILITIES ONLINE BILL PAY



Starting in March, the County has provided a way for citizens to pay their utility bills online. The online portal is secure and the County does not charge a fee for its use. Master-Card, Visa and Discover credit cards are accepted as well as debit cards that display a MasterCard or Visa

logo. Citizens can register by visiting http://www.princegeorgecountyva.gov/residents/online_bill_pay.php and following the online information. In order to register, you must have a recent bill with your account information, and you will need to link your online account to your billing account. This service can be used to check your account balance, view past bills, and monitor your consumption information.

If you need assistance with the Online Bill Pay service, several options have been setup for you to use. The Information Technology department can assist Monday - Friday between 8 a.m. and 5 p.m. by calling (804) 722-8789 or emailing cssadmin@princegeorgecountyva.gov. There is also a new chat feature located on the home page of the County's website or on the first screen of the online bill pay portal.

In April 2018, the County is also making this service available for Personal Property bills. More information is located on the County's Online Bill Pay page.

POLICE DEPARTMENT ACHIEVES FIRST STATE REACCREDITATION

The Prince George County Police Department has achieved its first state reaccreditation through the Virginia Law Enforcement Professional Standards Commission

(VLEPSC). On behalf of the department, Colonel W. Keith Early, Police Chief, was presented a reaccreditation

certificate at the Prince George County Board of Supervisors meeting on Tuesday, February 13th.

The Police Department had their on-site assessment December 4 - 5, 2017. The Department was found to be flawlessly in compliance with all 190 applicable standards. The Police Department first achieved state accreditation in January 2014. The lead assessor, Lt. David Hudson of Lancaster County Sheriff's Office, stated, "the Assessment Team was impressed with the Prince George Police Department and the professionalism of both its sworn and non-sworn members. This agency clearly demonstrates a high level of commitment and dedication to law enforcement and the needs of the citizens they protect and serve."

To achieve reaccreditation, the Police Department must undergo a rigorous on-site inspection every four years by multiple, specially trained, independent assessors. These assessors examine all areas of the agency to ensure compliance with the professional standards set forth by the Commission. The process of complying with these professional standards requires daily attention by department members.

COURTHOUSE BASEMENT CONTRACT APPROVED

On February 27th, the Board of Supervisors awarded a contract to J.W. Enochs, Inc. in the amount of \$1,195,000 to complete unfinished space in the lower level of the Courthouse for a Juvenile and Domestic Courtroom.

The project includes the Courthouse basement buildout, furniture, audio visual equipment, security access control equipment, telephone lines, data lines, equipment, and architectural and engineering services. The start date was March 27th with project completion anticipated in September 2018.



MOVIES IN THE PARK-SUMMER 2018


Prince George Parks and Recreation will be sponsoring free "Movies in the Park" at Scott Park on June 8, July 13 and August 10th. Come out and

DUAL PRIMARY ELECTION

May 21 - Last day to register to vote if not already registered.

June 9 - Last day for in person absentee voting. Registrar's office is open 9 a.m.-5 p.m..

June 12 - Election Day. All county precincts open from 6 a.m. to 7 p.m.

SGT. LAWRENCE G. SPRADER, JR. MEMORIAL BRIDGE

On March 2nd, House Bill 1159, sponsored by Delegate Emily Brewer, was signed into law by Governor Ralph Northam. The new law designates the bridge on Middle Road over Interstate 295 in Prince George County as the "Sgt. Lawrence G. Sprader, Jr., Memorial Bridge."

Sergeant Lawrence G. "J.R." Sprader, Jr. was a native son of Virginia, graduated from Prince George High School on June 16, 2000, and enlisted in the United States Army on July 28, 2000. Sergeant Sprader served two full combat tours in Iraq. Sergeant Sprader died during a field training exercise conducted by the 3rd Armored Cavalry Regiment, Warrior Leader Course, at Fort Hood, Texas, on June 12, 2007.

FISCAL YEAR 2019 COUNTY BUDGET

County Administrator, Percy Ashcraft, presented his proposed FY'19 budget to the Board of Supervisors on February 28th. Highlights of the Budget include:

Funding of *Employee Health Insurance* Increase.

Funding for partial implementation of a **Salary Study** for County employees - \$200,000.

Full funding of the Memorandum of Understanding *(MOU)* between the County and *Public School Division*.

General Fund *Equipment*, *Vehicles & Projects*:

Six (6) Vehicle Purchases - \$174,330

Maintenance Projects for County Buildings - \$300,000 Various Information Technology Projects, Software & Upgrades - \$181,250

Burrowsville Playground - \$29,229


Fencing for Scott Park Field #6 - \$21,715

Utility Capital Improvements totaling \$1.47 Million Capital Improvement Projects and Debt Issuance for various initiatives including a new elementary school, Route 156 Water Main Extension, Food Lion Water System Upgrades, Self-Contained Breathing Apparatus, Real Estate Assessment Software Replacement, Scott Park Concession & Restroom Facility, County Building Security and Entrance Improvements, Fire & Crew Buildings Security/ Entrance Systems, Police Vehicles, Police Boat (Grant Local Match)

A 5ϕ tax increase in the Real Estate Rate was included in the proposed budget for construction of a new elementary school. An estimated \$1,250,000 is generated by a 5ϕ increase in the real estate tax rate (\$250,000 per 1ϕ). The cost of the school is estimated to be \$29.1 Million and debt payments on the school are approximately \$1,893,088 per year over a 30 year repayment term.

Increases to both water and sewer rates were proposed. The Board of Supervisors continues its work in reviewing and revising the FY '19 budget. Work sessions were held on March 7th, March 20th and April 3rd. A public hearing is scheduled for April 24th and board adoption is planned for May 8. The Crossings Shopping Center to combine three campuses into one. The event was marked with a special service and light refreshments on October 15, 2017.



SERVICE CENTER METALS

Service Center Metals, based in Prince George County, is a manufacturer of aluminum extrusions. The company will invest \$45.2 million to expand its manufacturing operations, to include a third aluminum extrusion press. This expansion will be the fourth for Service Center Metals since it started operations in 2003 in the Southpoint Business Park. The company plans to add 58 new jobs. Gov. Terry McAuliffe, who made the announcement during his State of the Commonwealth speech, said Virginia competed against Indiana for the expansion project. With about 200 employees, the company makes aluminum rods, bars and tubing used in such end markets as the construction, transportation, machinery, and equipment industries. The company sells aluminum extrusions to metal service centers that supply those industries. Service Center Metals was founded by Scott Kelley, Randy Weis and Chip Dollins, who had been employees of Henrico County-based Reynolds Metals Co.

Each and every person involved with the Prince George Animal Services and Adoption Center makes a difference. Adopters, donators, volunteers, fosters, rescue agencies, visitors, Facebook friends, and other municipal animal agencies along with various veterinarians make their efforts possible. The Animal Control Officers work diligently throughout the year to ensure that the animals at the center are cared for and given the best chance to find a perfect home. In 2017, staff responded to over 2,000 calls for service, held 18 adoption events, obtained 22 convictions of animal cruelty and neglect, held 3 fundraisers, conducted 18



therapy dog visits, and had the largest annual open house to date. We are happy to report that adoptions have continued to increase over the past six years. Thank you for your service 365 days of the year!

All 2018 personal property taxes, license fees and second half of 2018 real estate taxes are due on or before June 5, 2018. Taxes not paid by due date will be subject to an immediate 10% penalty, plus interest. If you own property in Prince George County and have not received a tax bill, please call (804) 722-8750. Tax bills will be mailed May 1st, failure to receive a bill does not relieve the taxpayer of any additional charges that will accrue under the law for failure to pay within the prescribed time. Office hours are 8:30 a.m. – 5:00 p.m., Monday through Friday. Payments must be post marked by the US Postal Service by June 5, 2018. A drop box is available at the County Administration Building.

COMMUNITY EMERGENCY RESPONSE TEAM

CERT teams are grassroots efforts to help volunteers and members of communities to be better prepared for disasters of any kind. The members of the team go through a series of FEMA classes and certifications, both in person and online, as well as attend hands on training to earn the designation of a CERT team member. The primary purpose is to have trained volunteers respond and assist the paid emergency professionals during an emergency and/or disaster. The 2018 class of the CERT begins on September 14th. The class is approximately 8 weeks with meetings every Thursday from 6-9 p.m. If you are interested in learning more about

The Citizens Academy is a free course providing an inside look at Prince George County, Virginia, government system. During each class, various Directors will give an overview of their respective departments. STRATEGIC PLANNING FOR THE FUTURE

Several County departments are planning for the future with strategic planning processes underway. Fire/EMS is working on a five year strategic plan for operations and coordination with affiliated support organizations. The Economic Development and Tourism five year planning process just held its first citizen input meeting on April 19th and anticipates completion by July. An updated Scott Park master plan will be started this year to take the next steps in



planning development of the park. Dewberry Engineers have been hired by the County to evaluate water and sewer infrastructure needs at Southpoint Business Park. The report outlining possible infrastructure solutions should be complete by June 29th.

LOCAL EMERGENCY PLANNING COMMITTEE

The Local Emergency Planning Committee (LEPC) is a group of community leaders who want to help ensure our communities are safe and know how to respond safely to primarily chemical hazards in the area. The LEPC has also expanded its support scope to include any and all other disasters that could affect



you. During 2017, the LEPC hosted a very successful Survivor Day and several public forums to discuss the Opioid Crisis in our region. These events were well attended. The LEPC also supported the gifted student resource to help the PACE students. The LEPC is not a closed group. If you are an interested community member, you are welcome to join. NEW COLLECTION EFFORTS FOR DELINQUENT TAXES

Prince George County has recently contracted with TACS (Tax Authority Consulting Services, PC) to assist with the collection of delinquent/past due personal property and real estate taxes. When internal collection efforts from the Treasurer's Office and the County Attorney's Office are unsuccessful, delinquent accounts will be turned over to TACS. TACS

will engage in a variety of communications with delinquent taxpayers and will use all legal remedies for collecting these past due amounts. A 20% collection fee will be added to amounts owed on accounts that are turned over to TACS. Please be sure to pay your taxes by the established due date in order to avoid the extra 20% collection fee.
