	<p>A CONSTRUCTION ENTRANCE WILL BE INSTALLED BEFORE THE FOUNDATION IS DUG AND WILL BE A MINIMUM OF 10 FEET WIDE, 30 FEET LONG, AND 6 INCHES DEEP OF VDOT #21B STONE. THIS STONE CAN USED TO FORM A FOUNDATION AS A BASE OR FOR SURFACE PAVEMENT. IT MAY CONSIST OF NATURAL OR CRUSHED GRAVEL, CRUSHED STONE, OR SLAG.</p> <p>ALL CLEARED AREAS ON THIS PROPERTY WILL BE COVERED WITHIN 7 DAYS OF FINAL GRADING WITH PERMANENT VEGETATION OR A PROTECTIVE GROUND COVER SUITABLE FOR THE TIME OF YEAR.</p> <p>ALL WETLAND, RPA, OR RMA AREAS WILL BE IDENTIFIED IN THE FIELD AND THE BOUNDARIES RESPECTED.</p> <p style="text-align: center; font-weight: bold;">INSPECTIONS</p> <p>I UNDERSTAND THAT THE PRINCE GEORGE COUNTY EROSION AND SEDIMENT CONTROL INSPECTOR MAY PERIODICALLY INSPECT THIS SITE TO DETERMINE WHETHER THE MEASURES INSTALLED ARE EFFECTIVE IN CONTROLLING EROSION AND SEDIMENTATION. A VIOLATION OF THIS ORDINANCE SHALL BE DEEMED A MISDEMEANOR [ARTICLE II, SECTION 38-32(A) THE CODE OF PRINCE GEORGE COUNTY, VIRGINIA].</p>
