DEPARTING IT DIRECTOR MAJOR PART OF PRINCE GEORGE COUNTY ADVANCEMENTS

Next to public safety and responsible financial accounting, one could argue that information technology is the life blood of every government organization. After all, when internet doesn't work or your financial system can't pay the bills or produce payroll, nothing short of chaos starts to settle



in. Since May 1, 2006, Kirsten Cherry has been at the center of the IT revolution that has hit Prince George County Government. Since September 1, 2012, she has been the Director of Information Technology and she has led an advancement that has positioned Prince George County to compete in this complicated IT world.

Kirsten announced on September 11th that she was stepping away from her position with Prince George County and she and her husband were moving to Maine. BROADBAND EXPANSION CONTINUES

On August 13th, Prince George Electric Cooperative (PGEC) CEO, Casey Logan, reported to the County Board of Supervisors that PGEC Enterprises, LLC dba Ruralband had completed over 500 fiber-to-the-home connections to fulfill the initial agreement with the County. In addition, Ruralband has secured a FCC Connect America Fund federal grant which includes \$1.56 million for an additional 783 Prince George County locations. Ruralband and Prince George County will continue to evaluate expansion opportunities with the goal of 100% coverage in PGEC territory in Prince George County by 2025.





COUNTY ATTORNEY STEVE MICAS RETIRES; DANIEL WHITTEN HEADS LEGAL TEAM

Longtime County Attorney, Steve Micas retired August 1st and Daniel Whitten has been hired to head the County's legal team. Micas had over 40 years in municipal legal experience, serving time with both Chesterfield and Prince George Counties. He joined Prince George 10 years ago and played a very important part in major issues that has advanced County Government over the last decade. Micas was honored by the Board of Supervisors at its August 13th meeting.

Whitten, 36, began his stint on September 16th. He was the successful candidate among 11 applicants for the position. Whitten was formerly the County Attorney in Warren County. He is a graduate of the William & Mary School of Law and received his undergraduate degree at the University of Virginia. The County Attorney is one of three positions that report directly to the Board of Supervisors, the other two being the County Administrator and County Clerk.




NVR, Inc. is in the process of an \$11.5 million investment that includes an addition and

PARKS AND RECREATION

SPORTS AND PROGRAM SCHEDULE HIGHLIGHTS

Youth Basketball - Registration is October 7 - November 1, 2019, Monday through Friday between 8:30a.m. and 5:00p.m. The cost is \$30 for one child, \$50 for two children and \$70 for three children. Practices for both boys and girls leagues begin the last week of November or the first of December and games will begin in January. The games will be during the week and on Saturdays. *Mighty Mite* is a co-ed league for 7-8 year old boys and girls. Each participant must be 7 years of age and not have turned 9 years old on or before January 1, 2020. *Pee-Wee Boys* is an individual league for boys 9-10 years of age. Each participant must be 9 years old and not have turned 11 on or before January 1, 2020. *Junior Boys* is an individual league for 11-12 year olds. Each participant must be 11 years old and not have turned 13 on or before January 1, 2020. *Junior Girls* is an individual league for 9-11 year olds. Each participant must be 9 years old and not have turned 12 on or before January 1, 2020. *Senior Boys* & *Girls* are individual leagues for boys 13-15 years and girls 12-15 years of age. Girls must be 12 years of age, boys must be 13 and have not turned 16 years old on or before January 1, 2020. A birth

certificate is required at registration. A player may move up one age group in basketball if they are within one year of age of the cutoff for that division. They may only move up if they have participated for at least one year in their listed age division and with the consent of the Recreation department. Players may not move up from any 4 year old leagues.

<u>Adult Basketball</u> - \$175 team fee for basketball, the number of games will depend upon the number of teams. League will be for 35 years of age or older and must be 35 years of age by January 1, 2020. Teams must be made up of people who live or work in the County. League will begin in December and run through the beginning of March.

Registration will be held October 7 through November 1.

<u>Wrestling</u> - Prince George Parks and Recreation in partnership with Prince George Youth Wrestling Association (PGYWA) is offering youth wrestling, for County youth ages 5-14, participants must be 5 by October 1, 2020. Registration is September 9 – October 18, cost is \$45 per participant. The season will run from early November to the end of February.

PHOTO ID LAW

It is now required by law that every voter show a PHOTO ID in order to vote. This includes drivers license, DMV ID card, passport, business ID card, Government ID card or VA school ID card. Anyone that does not have a photo ID may come into the Registrar's Office and have one made for free. Regular office hours are 8:30am to 5pm. BEECHWOOD MANOR EMERGENCY ROOF REPAIR AND JORDAN ON THE JAMES WELL SYSTEM IMPROVEMENTS

The emergency repair to the roof of the reservoir located in Beechwood Manor was completed on August 30th. The water system was placed back in service on September 4th after confirmation from the lab that the water was safe to drink. The County staff is grateful for the patience and understanding of the customers impacted by this incident.

The engineering plans to improve the Jordan on the James well system are currently being reviewed by the Health Department. Upon approval from the health department, the County will advertise the plans for bid. Staff will present the results of the bids, and a recommendation on how to proceed to the Board of Supervisors on October 22nd.

RT 156 WATER MAIN EXTENSION AND RT 460 WATER SYSTEM IMPROVEMENTS

The Route 460 water system improvements and Route 156 water main extension projects continue to make progress towards finalizing the design. These projects will include an extension of the 12" water main from the Petersburg Jail Annex to the booster station located near the Food Lion distribution center and an extension of the 12" water main along Route 156 from Mount Sinai Rd (west) to Pine Ridge mobile home park. Easement acquisitions will begin upon completion of the design. After experiencing delays during the design process, construction is now anticipated to begin in the fall of 2019 and be completed in the fall of 2020. Residents will have an opportunity to connect to the county water system at that time.

ROUNDABOUT TO BE NAMED

On October 25th at 11am, Prince George County will host a ceremony to dedicate the roundabout at Courthouse Road and Allin Road for PFC Michael M. Carey, U.S. Marine Corps, 1st Battalion, 5th Marine Regiment, 1st Marine Division, killed in action on May 18, 2004 at Al Anbar, Iraq.

At the time of his death, PFC Carey was survived by his daughter, Mia, who was born two weeks before he died, father William and stepmother, Darlene Carey, mother Sandra Rhodes and stepfather Robert Rhodes, sister, Tandra Murphey and two brothers, Kristopher Carey and Travis Rhodes. PFC Carey is interred at Merchants Hope Memorial in Park Prince George, Virginia.

On August 28th at Disputanta Community Center, Delegate Emily Brewer hosted a Mobile Veteran Resource Center with Virginia Secretary of Veterans and Defense Affairs, Carlos Hopkins, keynoting at a town

hall meeting. Education and employment opportunities, DMV resources, health screenings and legislative updates highlighted the event.

STREAM RESTORATION PROJECT UPDATES

Through the Stormwater Utility Fee program, three stream channels used for stormwater drainage that were identified as severely compromised and exhibited channel erosion are undergoing transformations. The streams are located in the Birchett Estates and Cedar Creek subdivisions.

Two stream sections in the Cedar Creek subdivision have been substantially completed and work has begun at Birchett Estates. The Virginia Department of Environmental Quality (DEQ) recently awarded Prince George County an additional \$655,109 grant for the stream restoration project in the Birchett Estates subdivision.

The SLAF program, managed by DEQ, provides matching grants to localities for improvement projects that implement cost-effective best management practices. This year's awards will support 24 projects that will reduce water pollution across the state. DEQ received a total of 59 applications from 34 localities for projects totaling more than \$39 million.

This stormwater improvement funding from our state partners is essential to Prince George County to tackle the degradation that has occurred over time to our stormwater drainage systems and streams. County staff and their consultant, Timmons Group, prepared and submitted the grant request.

Additional funding for these projects is provided through the County's Stormwater Utility Fund. Fees collected through the Stormwater Utility Fee program can only be used for stormwater improvement projects throughout the County.

PUBLIC RADIO SYSTEM UPDATE

The Board of Supervisors at its September 24th meeting got its first glimpse of the proposal to install a new Radio System for Public Safety. Representatives from Altaris presented the details of the project, which is estimated to cost \$11.2 million. The system is designed to increase coverage for all public safety personnel through the installation of additional cell towers and modernized equipment. The system will be an asset to both career and volunteer personnel who respond to Fire & EMS calls. In addition, the Police Department will have increased capability for greater communication that includes backup units on the scene when needed. The BOS is expected to select a provider to install the system at one of its October meetings.



The new station will be a replacement for existing Station 5 on Jefferson Park Road. HBA Architectural firm is working with the County on the design for the new station. Site construction will begin later this fall with anticipated completion by fall of 2020. The station will house a detoxification unit that responding personnel will use to remove carcinogens produced by certain fires. This new station will be constructed in a manner that will allow for future expansion and growth in the County.

CENSUS 2020

On September 10, the Board of Supervisors recommended the creation of a Complete Count Committee (CCC) for the 2020 US Census. The CCC is an awareness and marketing committee comprised of community leaders. The chairperson of the CCC, appointed by the County Board, is the main contact with the US Census Bureau during the census. There are no limits to size and structure of a CCC, though suggestions are given by the US Census Bureau. The US Census Bureau does not manage the CCC. The goal of the CCC is to have a complete count of County residents per the US Constitution, Article I, Section II.

BACK TO SCHOOL FAIR The Back to School Fair is held every year in the month of



August. The goal of the event is to join forces with community partners and offer assistance to families of Prince George County with school supplies and pertinent information to aid them in the start



to a positive and productive school year. It is estimated that over 1,500 participants attended the event and over 500 back packs were distributed. Musical selections were provided along with free popcorn by Destination Church. Free haircuts by Kulture Kuts Barber Academy were given, free hot dogs were prepared by BBQ Bliss and a host of vendors and supporters were in attendance.

The event continues to be a huge success thanks to the many partnerships that have been developed over the years as well as the donations from area businesses, churches, health and service organizations, citizens and friends. Because of the success of the Annual Back to School Fair, the County of Prince George received the Virginia Association of Counties (VACO) 2019 Achievement Award.
