

RESOLUTION No. 2023- 7

RESOLUTION APPROVING COMMISSIONER REDISTRICTING FOR  
PROWERS COUNTY, COLORADO

BE IT RESOLVED by the Board of County Commissioners of the County of Prowers, State of Colorado;

That the County Commissioners' Districts of the County of Prowers, State of Colorado, are not now as equal in population as possible as required by law.

BE IT FURTHER RESOLVED, that the Commissioners' Districts of Prowers County be and the same are hereby redistricted as follows:

District 1:

All that part of Prowers County lying east of the following described line:

Beginning at the intersection of the center line of U.S. Highway 385 and the north boundary line of Prowers County, thence south to the center line intersection of County Highway 196, then west to the center line intersection of County Road 13, then south to the center line intersection of U.S. Highway 50, then west to the center line intersection of North 2nd Street in the City of Lamar, then south to the center line intersection of East Parmenter Street, then west to the center line intersection of South 4th Street, then south to the center line intersection of East Cedar Street, then east to the center line intersection of Parkview Avenue, then south to the center line intersection of Memorial Drive, then southeasterly to the center line intersection of Lake Drive, then east whereupon the roadway becomes County Road FF.3, then east to the center line intersection of County Road 9.5, then south to the southern boundary of Section 15, Township 23, Range 46, then east continuing on County Road EE to the center line intersection of County Road 19, then south to the center line intersection of County Road N, then west to the center line intersection of County Road 19, then south to the south boundary of Prowers County.

District 2:

All that part of Prowers County lying north and west of the following described line:

Beginning at the intersection of the center line of U.S. Highway 385 and the north boundary line of Prowers County, thence south to the intersection of the center line of County Highway 196, then west to the intersection of the center line of County Road 13, then south to the intersection of the center line of U.S. Highway 50, then west to the intersection of the center line of North 2nd Street in the City of Lamar, then south to the intersection of the center line of East Parmenter Street, thence west to the intersection of the center line of South 14th Street, then north to the intersection of the center line of West

Oak Street, then west whereupon the roadway becomes County Road HH, then west to the west boundary line of Prowers County.

District 3:


All that part of Prowers County lying south and west of the following described line:


Beginning at the intersection of the center line of County Road HH and the west boundary line of Prowers County, thence east to the center line intersection of South 14<sup>th</sup> Street in the City of Lamar, then south to the center line intersection of West Parmenter Street, then east to the center line intersection of South 4<sup>th</sup> Street, then south to the center line intersection of East Cedar Street, then east to the center line intersection of Parkview Avenue, then south to the center line intersection of Memorial Drive, then southeasterly to the center line intersection of Lake Drive, then east whereupon the roadway becomes County Road FF.3, then east to the center line intersection of County Road 9.5, then south to the southern boundary of Section 15, Township 23, Range 46, then east continuing on County Road EE to the center line intersection of County Road 19, then south to the center line intersection of County Road N, then west to the center line intersection of County Road 19, then south to the south boundary of Prowers County.



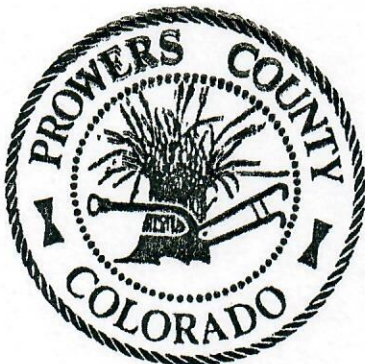
