In accordance with the Colorado Revised Statutes, §1-5-102.9, §1-5-205(1)(a) & (b), §1-5-205(4), §1-7.5-107 through §1-7.5-210 I, Jana Coen, County Clerk & Recorder of Prowers County, Colorado, do hereby give notice that a mail-in ballot election will occur on Tuesday, June 25, 2024, between the hours of 7:00 a.m. and 7:00 p.m.

NOTICE OF SPECIAL CONGRESSIONAL VACANCY (CD4) ELECTION: If you are affiliated with a major party, minor party, or unaffiliated, the Special Congressional Vacancy Election will be included on your ballot. If you are affiliated with a minor party then you will receive a ballot that ONLY contains the Congressional Vacancy Candidate's race for Federal Office.

MAILING BALLOTS TO: All "active" registered electors, during the **week of June 3-7, 2024**. No ballot will be forwarded if your address is incorrect. Deadline for receiving a voter registration application is 6-17-2024.

RETURN VOTED BALLOTS TO:

Prowers County Clerk and Recorder, 301 S. Main St., Ste. 210, Lamar, CO 81052 and must be received by 7:00 p.m. on Election Day (June 25, 2024). **Postmark dates do not count as received!**

24- HOUR DROP BOX: (June 3 - 25, 2024):

Located in the parking lot east side of the courthouse building, open 24/7, June 3-25, 2024, closes 7:00 p.m. election night.

VSPC (Voter Service and Polling Center) and Ballot drop off:

Open June 10 - 25, 2024, 8:30 a.m. - 4:30 p.m., M-F, Saturday, June 22, 2024, 8:00 a.m. - 12:00 p.m., Tuesday, June 25, 2024, (Election Day) 7:00 a.m. to 7:00 p.m.

UNAFFILIATED REGISTERED VOTERS: will be receiving a Ballot "Packet" in the mail which contains both a Democratic and Republican ballot style. Mark only **ONE** ballot style and return only **ONE** of them. **If you vote both ballot styles and return both ballots neither ballot will be counted.**
