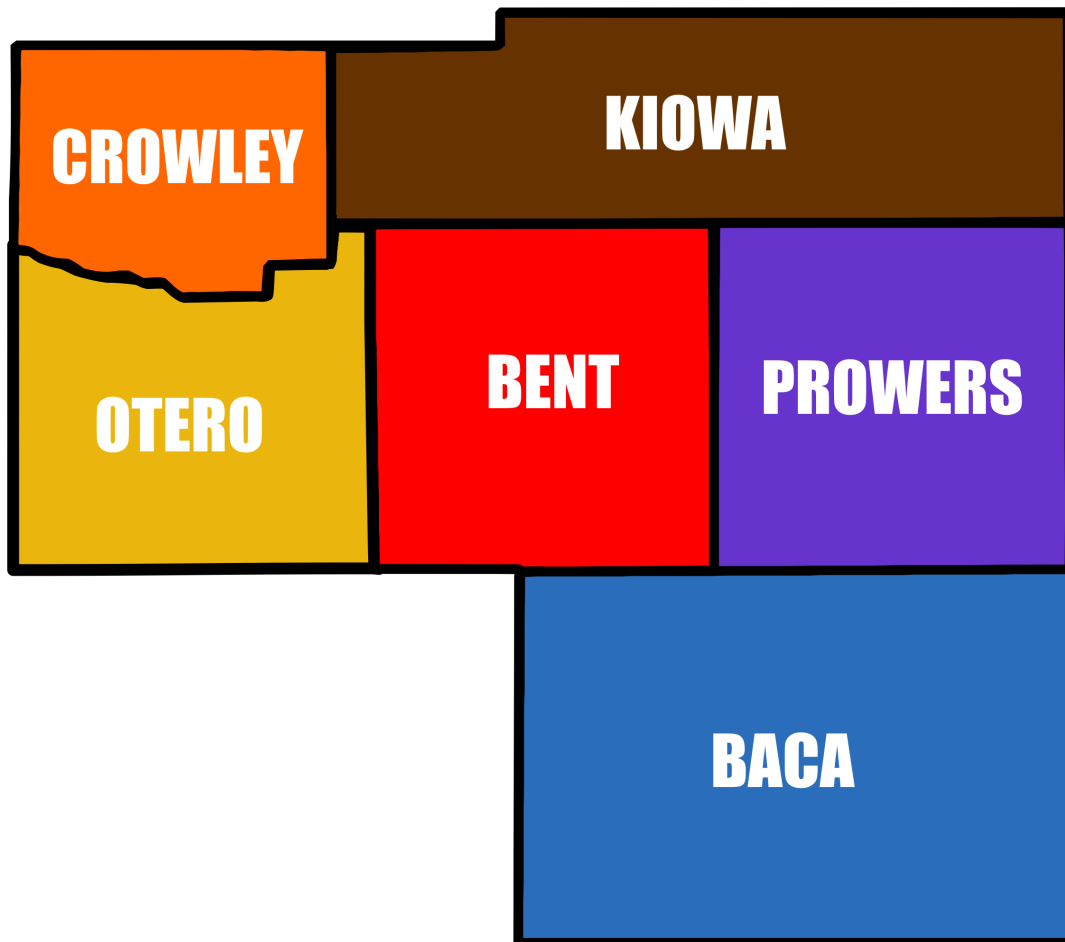


# RIDER'S GUIDE

## MOBILITY SUPPORT AND INFORMATION

The following services are available to assist with more personal discussion of transportation options: SETran, Bent County Transit, Bustang Outrider, Inspiration Field, La Junta Transit and Prowers Area Transit offer travel training to all individuals.

### **Contact each agency for more information regarding each agencies transportation policies and route services**

Demand-response services have vehicles operating in response to calls from passengers. Service areas may depend on availability. Contact providers directly for up-to-date service boundaries and details of service. Service by demand-response service tends to be for older adults (60+) or adults (18+ with disabilities). Please note demand-response services require advanced booking, and the time needed varies by agency. Often times, 24 to 72-hour advanced notice is required. Contact each agency for their requirements.

Buses which run along an established path at preset times, picking up passengers at designated bus stops. Typically, fixed route service is characterized by printed schedules or time tables, with designated bus stops where passengers board.

**Fares:** Inspiration Field supports individuals with intellectual and developmental disabilities in the tri-county area including: Bent, Crowley, and Otero counties. Transportation services are provided to those individuals enrolled in the HCBS-DD waiver and HCBS-SLS waiver. Medicaid is billed for rider- ship and the rider are not billed a fare.

**Service Hours:** Monday-Thursday 7:30 AM to 5:30 PM, for medical transport 5:00 PM to 7:30 AM Monday-Sunday

**Fares:** Medical trips are by donation. Medicaid will pay Medicaid approved medical appointment. Driver will provide authorization form that must be signed by doctor, and returned to driver the day of service. Helpers do not pay a fee.

**Non-Medical Trips:** Trips can be scheduled to any destination in Southeastern Colorado, the Front Range, and Western Kansas. For groups the base cost is \$50 for the minivan (minimum 5 riders), and \$80 for large bus (minimum 8 riders). Senior Trips can be scheduled at a discounted price.

**Service Hours:** Monday-Friday 7:00 AM to 5:00 PM, No Holidays or Inclement Weather. A 24 hour notice is needed to schedule.

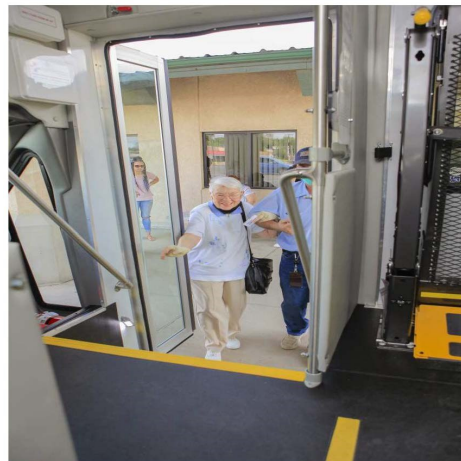
