



SHAVANO PARK MUNICIPAL COURT  
DISMISSAL INFORMATION

The following offense(s) **may** be dismissed with proper proof\* and with the identifiable description of the vehicle cited if needed no later than your appearance date. If you do not appear by your appearance date your offense(s) are no longer eligible for dismissal and you will have to pay the fine amount of \$179.00. For the offense of **Expired Registration**, the renewal must include a 20% penalty paid to the Tax office.

\$10.00 dismissible offenses:

Operating a vehicle with an obscured or dirty license plate  
Fictitious license plate  
Altered license plate  
No license plate  
Fail to display driver's license  
No license plate light and/or lamp  
Defective tail lamp  
Defective brake lamp  
Defective head lamp

\*Proof would consist of a receipt from the location where the violation was corrected and or a printed colored photo of the front and back of the vehicle that would clearly reflect the identification of the vehicle cited and the correction.

\$20.00 dismissible offenses:

Expired Registration  
Expired Driver's License  
Fail to change name/address

\*Proof would consist of a receipt from the DPS, Tax Office, or Inspection location that would clearly reflect the identification of the correction.

**Failure to Maintain Financial Responsibility (No Insurance):** You must submit proof of insurance at the time and date of the citation. The Court will verify this information and if there was coverage, then the offense will be dismissed and there is no dismissal fee.
