REGULAR CITY COUNCIL MEETING DECEMBER 7, 2020

The regular Sikeston City Council meeting of December 7, 2020 was called to order at 5:00 p.m. via Zoom Video Conferencing in Sikeston, MO. Present at the zoom video meeting were: Mayor Steven Burch, Karen Evans and Gerald Settles. Councilmembers Ryan Merideth, Brian Self and Onethia Williams were absent. Staff in attendance were: City Manager Jonathan Douglass, City Counselor Tabatha Thurman, City Clerk Rhonda Council, Finance Director Karen Bailey, HR Director Amanda Groves, Public Works Director Jay Lancaster, Street Superintendent Brian Dial, Public Safety Director James McMillen and Community Development Director Lorenzo Ware.

APPROVAL OF CITY COUNCIL MINUTES

City Council minutes October 26, November 2, November 20 and November 30, 2020 were presented for approval. Councilman Settles moved to approve the minutes as presented. Councilman Sparks seconded the motion and the following roll call vote was recorded:

PUBLIC HEARING – 60/61 WEST TIF DISTRICT

Councilman Settles motioned to begin the Public Hearing to discuss the 60/61 West TIF District. The motion was seconded by Councilman Sparks and the following vote recorded:

Finance Director Karen Bailey discussed the status of the 60/61 West Tax Increment Financing (TIF) District. State statute requires a public hearing every 5 years after the adoption of a Tax Increment Financing (TIF) Redevelopment Plan to determine if the project is making satisfactory progress. The public hearing satisfies the statutory requirement. This TIF district includes the new Malco Theatre, Watami and Hampton Inn.

On May 6, 2015, the City entered into a redevelopment agreement with Sikeston Development Co., LLC regarding the Sikeston 60 West Tax Increment Financing Redevelopment Plan. The agreement requires the City to fund, subject to reimbursement from tax increment financing revenues, the extension of Hennings Drive, the extension of Stallcup Drive, and the construction of a new roadway connecting Hennings Drive and Stallcup Drive. The City uses tax increment financing revenues to reimburse Sikeston Development Co., LLC for certain other project costs. On May 2, 2016, the City entered into an amended and restated redevelopment agreement with Sikeston Development Co., LLC and Cotton Ridge Development Co., LLC regarding this redevelopment plan. Sikeston Development Co., LLC has assigned its interest in portions of the property in RPA I to Cotton Ridge Development Co., LLC. On August 19, 2016, Sikeston Development Co., LLC submitted a Certificate of Reimbursable Costs for \$800,000.00, the maximum approved. On December 9, 2016, Cotton Ridge Development Co., LLC submitted a Certificate of Reimbursable Costs for \$390,737.33. On December 27, 2018, Cotton Ridge Development Co., LLC submitted an additional Certificate of Reimbursable Costs for \$193,993.11. Total balance certified to Cotton Ridge Development Co., LLC is \$584,730.44. The developers are allowed 4.5% per annum interest on their costs. On each payment date, the City shall apply the TIF Revenues, first the sum of \$1,000 shall be retained by the City as an administrative

fee, with the balance paid 46.7% to the City to be applied as provided in the Cooperation Agreement and 53.3% paid to the Developer for Reimbursable Developer Costs. Unless otherwise agreed to by the Developers, the TIF Revenues paid to the Developers shall be paid first to Sikeston Development Co., LLC until all their reimbursable costs have been paid and then to Cotton Ridge Development Co, LLC until all their reimbursable costs have been paid.

No remarks were heard from the public.

Ordinance Number 6211

THIS BILL AS APPROVED SHALL BECOME ORDINANCE NUMBER 6211, CALLING FOR A GENERAL ELECTION IN THE CITY OF SIKESTON, MISSOURI, ON TUESDAY, APRIL 6, 2021, FOR THE PURPOSE OF ELECTING A CANDIDATE FOR THE POSITION OF MAYOR, COUNCILMAN WARD 2, AND COUNCILMAN WARD 3.

BE IT ORDAINED by the City Council of the City of Sikeston, Missouri, as follows:

SECTION I: This ordinance shall not be codified.

<u>SECTION II:</u> That in accordance with the Missouri Comprehensive Election Laws of the State of Missouri, applicable Missouri Revised Statutes of the State of Missouri and the ordinances of the City of Sikeston, Missouri, a General Election shall be held and the same is hereby ordered to be held on Tuesday, April 6, 2021.

<u>SECTION III:</u> That the polls be open for said election continuously from six o' clock in the forenoon until seven o'clock in the afternoon of that day, April 6, 2021.

<u>SECTION IV:</u> That said election be held in the City of Sikeston, Missouri, in the polling places and precincts designated by the County Clerk.

<u>SECTION V:</u> That said election is hereby called for the purpose of electing one (1) candidate for the office of Mayor, Councilman Ward 2 and Councilman Ward 3.

<u>SECTION VI</u>: That the Judges and Clerks of said election shall be those appointed by the County Clerk.

<u>SECTION VII:</u> That the City Clerk shall cause notice, poll books, ballots, and all other matters necessary to the election to be requested from the County Clerk's office as required by law.

<u>SECTION VIII</u>: That the City Clerk of the City of Sikeston, Missouri, be and she is hereby authorized and directed to notify the County Clerk of Scott County, Missouri, of the adoption of this ordinance no later than January 26, 2021, and to include in said notification all the terms and provisions required by the Comprehensive Election Act of 1986, as amended, and the above cited Statutes and ordinances.

<u>SECTION IX:</u> General Repealer Section. Any other ordinance or parts thereof inconsistent herewith, are hereby repealed.

<u>SECTION X:</u> Severability. Should any part or parts of this Ordinance be found or held to be invalid by any court of competent jurisdiction, the remaining part or parts shall be severable and shall continue in full force and effect.

<u>SECTION XI:</u> Record of Passage.

REVOCABLE TRUST DATED AUGUST 15, 1997, certain property descriptions attached here to as Exhibit A, Exhibit B, and Exhibit C, for road improvement purposes and to approve the execution of certain documents herein.

The City also seeks authorization for the mayor to sign a Letter of Agreement, by which the City agrees that if at any time we sell all or a portion of the property, the City will remit a proportionate amount (2/13) of the proceeds of the sale to New Madrid County.

The current determination of rates does not represent the actual cost for excessive sewer discharges of strength and total suspended solids (TSS). Board of Municipal Utilities (BMU) propose the updated rate to prevent excessive sewer discharges that disrupt the sewer plant and to reimburse BMU for this disruption.

In addition to raising the strength and TSS surcharges, this ordinance will also add a strength multiplier for excessive strengths and allow the rate to be changed based on BMU's annual costs without having to draft another ordinance. The strength multiplier accounts for replacement and upgrade costs associated with high strength discharges. If proper pre-treatment is performed by the industries, they do not have to pay these surcharges.

BILL Number 6213

THIS BILL AS ADOPTED SHALL BECOME ORDINANCE NUMBER 6213, AMENDING DETERMINATION OF RATES FOR EXCESSIVE STRENGTH CHARGE FEES FOR COMMERCIAL OR INDUSTRIAL USERS FOR WASTEWATER COLLECTION.

WHEREAS, the current ordinance is outdated and the determination of rate does not represent the actual cost for excessive sewer discharges of strength and total suspended solids (TSS), and

WHEREAS, the purpose of the surcharge rate is to deter excessive sewer discharges that disrupt the sewer plant and to reimburse the utility for this disruption; and

WHEREAS, the excessive strength and total suspended solids can and does overload the sewer plant as well as rob the City of future growth; and

WHEREAS, in addition to raising the strength and TSS surcharges, this ordinance adds a strength multiplier for excessive strengths and also allows for this rate to be changed based on annuals costs without a total ordinance change; and

WHEREAS, the strength multiplier accounts for replacement and upgrade costs associated with high strength discharges. If proper pre-treatment is performed by the industries, they do not have to pay these surcharges.

NOW THEREFORE BE IT ORDAINED BY THE COUNCIL OF THE CITY OF SIKESTON, MISSOURI, AS FOLLOWS:

<u>SECTION I:</u> This ordinance shall be codified in Title VII Utilities, Chapter 725, Section 725.050 (4) Determination of Rates, of the Sikeston Municipal Code.

<u>SECTION II:</u> Title VII, Chapter 725, Section 725.050 (4) is hereby amended to read as follows:

"Section 725.050 Determination of Rates.

4. Commercial or industrial users shall be subject to an excessive strength charge in addition to the basic sewer service charge when the BOD or SS concentrations of a discharge exceeds three hundred (300) milligrams per liter (mg/L). All analyses shall be performed on composite samples collected over a twenty-four (24) hour period.

The excess strength charge shall be based upon the volume of wastewater and a wastewater strength factor. The wastewater strength is measured by the degree of organic pollution in the wastewater; the higher the strength, the more treatment costs the City.

The wastewater strength factor shall be calculated by the differential between the actual wastewater strength in mg/L and the allowable 300 mg/L all divided by 300 mg/L rounded up to the nearest whole number.

This strength factor is then multiplied by the following average treatment costs for a final excessive strength charge:

- a. Forty-nine cents (\$0.49) for each pound of excess BOD; and
- b. Seven cents (\$0.07) for each pound of excess TSS

These surcharge calculations may be revised annually based upon the previous fiscal year's wastewater treatment costs."

<u>SECTION III:</u> General Repealer Section. Any other ordinance or parts thereof inconsistent herewith, are hereby repealed.

<u>SECTION IV:</u> Severability. Should any part or parts of this Ordinance be found or held to be invalid by any court of competent jurisdiction, the remaining part or parts shall be severable and shall continue in full force and effect.

Dear Jeff:

Attached is the recommended modifications to the User Charge Ordinance.

As you know the previous excessive strength charges had not been modified in an unknown time period and did not cover your basic costs incurred to date.

The average treatment costs were calculated from your 2020 Sewer Production Costs of \$952,885.20. This was divided into the BOD, TSS, and Flow which were 80%, 10%, and 10% respectively. This was also based upon your 2020 average flow of 2.33 million gallons per day and resulted in an average BOD cost of \$0.49 per pound of BOD and \$0.07 per pound of TSS.

Not taken into account in this average treatment costs were equipment replacement costs as well as upgrades that could be required for high strength wastes. Should a user continuously discharge a high strength waste, it could overload the capacity of the treatment plant which will cause the plant to exceed the discharge limits. This in turn will require upgrades be made to the treatment plant. These upgrades will have a cost that then must be passed to the users through increases in the user costs or in fees to the high strength dischargers.

The Strength Factor was included to account for these replacement and upgrade costs that would be associated with the high strength discharges.

- 2. Other action the City Council deems appropriate.

Background:

The Parks and Recreation Department is seeking the approval of hiring 11 additional part time/seasonal staff to work weekend tournaments at the Recreation Complex for the months of May, June, and July. In 2020, the Parks and Recreation Department held nine tournaments at the Recreation Complex in May and June; plus, one additional tournament in July and September. The Parks and Recreation Department was not prepared staffing wise for hosting that many tournaments as it resulted in long weekend hours for staff who were already working their regular 40-hour work week. We originally planned to host three or four tournaments in 2020; but due to surrounding city and bordering state restrictions, we quickly became a draw for Tournament Directors in our region. Entering 2021, we have been able to keep the momentum moving forward.

The need to hire additional part time/seasonal staff for weekend tournaments reduces the amount of overtime needed to be paid to full time staff and reduces the number of hours they work to avoid burnout. There are many essential duties that need to occur while hosting tournaments and increasing staff will ensure that families enjoy their visit. Maintenance issues continuously need to be addressed such as: emptying trash barrels, restroom checks, filling in batter's boxes to prevent injury, re-chalking the batter's boxes as needed, and filling pitching mounds with additional clay. When games are completed on Saturday night, maintenance is required to all the playing fields in use such as dragging, chalking, and filling in holes created by players. Trash and restroom facility maintenance is also a must, so when people arrive on Sunday, the Recreation Complex is clean and presentable. There are other issues that may result in having someone go offsite such as getting change for cash registers or purchasing more supplies for the concession stands.

The Parks and Recreation Department proposes the creation of 11 new part time/seasonal positions for tournament play. There is a total of nine tournaments scheduled for 2021 with the possibility of having one added in May and September. These positions include six ballfield maintenance workers, two Complex cleanup workers, two assistant concession stand managers, and one tournament facility supervisor to ensure quality control. The ballfield maintenance workers would work on Saturday nights from 8:00pm-12:00am, Recreation Complex cleanup workers would work 2:00pm-4:00pm and 8:00pm-10:00pm on Saturday and 2pm-4pm on Sunday, and the tournament facility supervisor would work 7:00am-10:00pm on Saturday and 7:00am until games end on Sunday. The two additional assistant concession stand managers provide more adult presence to a young staff and can easily fill in on weekends for the head managers if there is a personal schedule conflict. A staffing budget for these positions is attached separately.

Based on the projections for hosting 11 tournaments in 2021, the Parks and Recreation Department would spend \$78,232.00 on staffing and concession supplies. On average, each 2020 tournament brought in \$10,000 in concession sales, which leaves a net balance of \$31,768.00 in revenue. This revenue would cover the costs of hiring additional staff to work on weekends. There is a breakdown of these expenditures/revenues on the attached spreadsheet.

The Recreation Complex has attracted teams for tournaments from Missouri, Kentucky, Arkansas, Tennessee, Illinois, and Indiana. We have had teams come from as far as Chicago, Illinois play and stay the weekend in Sikeston. The investment that was made to improving the Recreation Complex is starting to pay dividends and last year provided a great experience in what we can do with hosting travel baseball tournaments. The additional staff is a great benefit and will keep our department in good standing with tournament directors and visitors. The Parks and Recreation Department is grateful for the continuing support of our City leaders and citizens and we hope to continue to add to the economic impact on our community.
