Background:

The current Sikeston ordinance related to livestock or in this case chickens' states:

City of Sikeston

Section 205.310

Keeping Livestock, Domestic Animals and Fowl.

[R.O. 2009 § 6.28.030; Ord. No. 4126 § 12, 1980; Ord. No. 5527 §II, 1-6-2003] No person shall keep or maintain horses or cows within one hundred fifty (150) feet of any residence or other dwelling place other than that of the owner, nor keep or maintain a combined total of three (3) or more rabbits, chickens, ducks, turkeys or other domestic fowl within one hundred fifty (150) feet of any residence or other dwelling place other than that of the owner; provided further, that nothing in this Chapter shall prevent the keeping of cows or cattle in any auction barn or veterinary hospital provided same are kept in a clean and non-odorous condition.

Cape Girardeau, MO

(a)Living areas to be clean, inspections authorized. All chicken houses, chicken tractors, and chicken pens wherein chickens are kept or permitted to be, shall be always maintained in a clean and sanitary condition, devoid of all rodents and vermin, and free from offensive, disagreeable or noxious smell or odor to the injury, annoyance, or inconvenience of any inhabitant of the neighborhood. The health officer may at any time inspect, or cause to be inspected, any structure or premises and issue any such order as may be necessary to carry out the provisions of this section.(b)Number and type of chickens allowed.(1)The maximum number of chickens allowed is six per tract of land regardless of how many dwelling units are on the tract.(2)Only female chickens are allowed. There is no restriction on chicken species. (c)Noncommercial use only; restrictions on slaughter. It shall be unlawful to engage in chicken breeding or fertilizer production for commercial purposes. It is also unlawful for anyone to raise chickens for slaughter. Any chicken slaughtering shall only be conducted indoors and shall solely be for the purpose of the owner or keeper consuming them as food. (d)Enclosures. (1) Chickens shall always be kept in an enclosure or fenced area. Chickens shall be secured within a henhouse or chicken tractor during non-daylight hours.(2)Enclosures shall be kept in a clean, dry,

odor-free, neat and sanitary condition at all times.(3)Henhouses, chicken tractors and chicken pens shall provide adequate ventilation and adequate sun and shade and shall be impermeable to rodents, wild birds and predators, including dogs and cats.(e)Henhouses, chicken tractors, and chicken pens.(1)Henhouses, chicken tractors, and chicken pens shall be designed to provide safe and healthy living conditions for the chickens while minimizing adverse impacts to other residents in the neighborhood, Henhouses, chicken tractors, and chicken pens shall be enclosed on all sides and shall have a roof and doors. Access doors shall be able to be shut and locked at night. Opening windows and vents shall be covered with predator and bird proof wire of less than one-inch openings. The materials used in making henhouses, chicken tractors, and chicken pens shall be uniform for each element of the structure such that the walls are made of the same material, the roof has the same shingles or other covering, and any windows or openings are constructed using the same materials. The use of scrap, waste board, sheet metal, or similar materials is prohibited. Henhouses, chicken tractors, and chicken pens shall be well maintained. (2) Henhouses, chicken tractors and chicken pens shall only be in the rear yard and shall be at least ten feet from any property line and at least 25 feet from any principal structure on an adjacent property. (f)Chicken pen. Any enclosed chicken pen shall consist of sturdy wire or wooden fencing. The pen shall be covered with wire, aviary netting, or solid roofing. (q)Odor and noise impacts. (1) Odors from chickens, chicken manure or other chicken related substances shall not be perceptible at the property boundaries. (2) Perceptible noise from chickens shall not be loud enough at the property boundaries to disturb persons of reasonable sensitivity. (h)Predators, rodents, insects, and parasites. The chicken owner shall take necessary action to reduce the attraction of predators and rodents and the potential infestation of insects and parasites. Chickens found to be infested with insects and parasites that may result in unhealthy conditions to human habitation may be removed by an animal control officer. (i)Feed and water. Chickens shall always be provided with access to feed and clean water. The feed and water shall be inaccessible to rodents, wild birds, and predators. (i) Waste storage and removal. The chicken owner shall provide for the storage and removal of chicken manure. All stored manure shall be covered by a fully enclosed structure with a roof or lid over the entire structure. No more than three cubic feet of manure shall be stored. All other manure not used for composting or fertilizing shall be removed. The henhouse, chicken tractor, chicken pen and surrounding area shall be kept free from trash and accumulated droppings. Uneaten feed shall be removed in a timely manner. Chickens atlarge; dangerous animals. (1) Chickens shall be always kept in a proper chicken house, chicken tractor, or chicken pen. No owner or keeper of any chicken shall permit or suffer such chicken to run at-large outside the chicken house, chicken tractor, or chicken pen, or outside of the premises of the owner or keeper, or to annoy, impair or disturb the peace, comfort, health or safety of the residents of the city.(2)No dog or cat which kills a chicken will, for that reason alone, be considered a dangerous or vicious animal.(I)Unlawful acts.(1)It shall be unlawful for any person to keep chickens in violation of any provision of this section.(2)It shall be unlawful for any owner, renter or leaseholder of property to allow chickens to be kept on the property in violation of the provisions of this section.(m)Nuisances. Any violation of this section that constitutes a health hazard or that interferes with the use or enjoyment of neighboring property is a nuisance and may be abated under the general nuisance abatement provisions. Continuing violations. Each day that a violation of this section continues is a separate offense.

Columbia, MO

Sec. 5-91. - Number and type of chickens allowed.

(a)The maximum number of chickens allowed is six (6) per tract of land regardless of how many dwelling units are on the tract. (b)Only female chickens are allowed. There is no restriction on chicken species. (c)The provisions of this section shall not apply to any chickens kept as part of an educational course by public and private schools and educational institutions with fifty (50) or more

students when the chickens are kept on school property that is one-half ($\frac{1}{2}$) acre or more in size. Sec. 5-92. - Noncommercial use only.

It shall be unlawful to engage in chicken breeding or fertilizer production for commercial purposes.

(Ord. No. 20549, § 1, 2-1-10)

Sec. 5-93. - Enclosures.

(a) Chickens must always be kept in an enclosure or fenced area. Chickens shall be secured within a henhouse or chicken tractor during non-daylight hours.(b) Enclosures must be kept in a clean, dry, odor-free, neat and sanitary condition at all times.(c)Henhouses, chicken tractors and chicken pens must provide adequate ventilation and adequate sun and shade and must be impermeable to rodents, wild birds and predators, including dogs and cats.(d)Henhouses and chicken tractors.(1)Henhouses and chicken tractors shall be designed to provide safe and healthy living conditions for the chickens while minimizing adverse impacts to other residents in the neighborhood henhouse or chicken tractor shall be enclosed on all sides and shall have a roof and doors. Access doors must be able to be shut and locked at night. Opening windows and vents must be covered with predator and bird proof wire of less than one-inch openings. The materials used in making a henhouse or chicken tractor shall be uniform for each element of the structure such that the walls are made of the same material, the roof has the same shingles or other covering, and any windows or openings are constructed using the same materials. The use of scrap, waste board, sheet metal, or similar materials is prohibited. Henhouses and chicken tractors shall be well maintained.(2)Henhouses, chicken tractors and chicken pens shall only be located to the rear of the dwelling or other main structure and may be located in the rear yard required by chapter 29.(3)Henhouses, chicken tractors and chicken pens must be located at least ten (10) feet from the property line and at least twenty-five (25) feet from any adjacent residential dwelling, church, school or place of business.(e)Any enclosed chicken pen shall consist of sturdy wire or wooden fencing. The pen must be covered with wire, aviary netting, or solid roofing. (Ord. No. 20549, § 1, 2-1-10)

Sec. 5-94. - Odor and noise impacts.

(a)Odors from chickens, chicken manure or other chicken related substances shall not be perceptible at the property boundaries. (b)Perceptible noise from chickens shall not be loud enough at the property boundaries to disturb persons of reasonable sensitivity. (Ord. No. 20549, § 1, 2-1-10)

Jefferson City, MO

Sec. 5-91. - Number and type of chickens allowed.

(a)The maximum number of chickens allowed is six (6) per tract of land regardless of how many dwelling units are on the tract. Only female chickens are allowed. There is no restriction on chicken species. The provisions of this section shall not apply to any chickens kept as part of an educational course by public and private schools and educational institutions with fifty (50) or more students when the chickens are kept on school property that is one-half ($\frac{1}{2}$) acre or more in size. Sec. 5-7. - Cleanliness of pens, coops, etc.

It shall be unlawful to keep any animal in any structure, pen, coop, or yard that is not always maintained in a clean and sanitary condition, devoid of all rodents and vermin and free from offensive, disagreeable or obnoxious smells or odors, tending to injure, annoy or inconvenience any inhabitant of the neighborhood. The provisions of this section shall not apply to a farm lawfully operating within a RU rural district.

Sec. 18-23. - Fowl running at large.

No person owning any chickens, guineas, geese, ducks, turkeys, or other domestic fowl shall allow or permit the fowl to run at large, except on premises owned or controlled by such person. Springfield, MO

Sec. 18-24. - Keeping fowl and chickens.

(a) Keeping fowl and more than six chickens. (1) No person shall keep chickens or other domestic fowl in any pen having an area of less than 144 square feet or the exterior boundary of which is less than 50 feet at the nearest point from the dwelling of another, a church, a school, or a place of business of another. If more than 12 chickens or other fowl are kept in a pen, the pen shall have an area equal to 12 square feet for each chicken or other fowl kept in such pen.(2)No person shall keep 25 or more chickens, chicks or other domestic fowl in a battery located in a building or structure unless the battery is located more than 50 feet at the nearest point from any dwelling of another, church, school or place of business of another. Not more than 24 chickens, chicks, or other domestic fowl may be kept in a battery located inside a building or structure if the battery is more than 25 feet from the dwelling of another, a church, a school, or a place of business of another. This subsection shall not apply to any lawfully operated hatchery. (b)Keeping of six or less chickens. (1) The maximum number of chickens allowed is six per tract of land regardless of how many dwelling units are on the tract. (2) Only female chickens shall be allowed. There shall be no restriction on chicken breeds.(3)It shall be unlawful to engage in chicken breeding or fertilizer production for commercial purposes.(4)Slaughter may occur for personal use provided that it is conducted in a sanitary manner, does not generate noise that creates a nuisance, and is not visible from adjacent properties or any public area or right-of-way.(5)Chickens shall be kept in a secured enclosure or fenced area at all times. Chickens shall be secured within a henhouse or chicken tractor during non-daylight hours.(6)Enclosures shall be kept in a clean, dry, odor-free, neat, and sanitary condition at all times.(7)Henhouses, chicken tractors and chicken pens shall provide adequate ventilation and adequate sun and shade and shall be impermeable to rodents, wild birds, and predators, including dogs and cats.(8)Henhouses and chicken tractors shall be designed to provide safe and healthy living conditions for the chickens while minimizing adverse impacts to other residents in the neighborhood, henhouse or chicken tractor shall be enclosed on all sides and shall have a roof and doors. Access doors shall be able to be shut and locked at night. Openings, windows, and vents shall be covered with predator and bird proof wire of less than one-inch openings, Henhouses, chicken tractors, and chicken pens shall only be located to the defined rear of the property as required by the zoning code, Henhouses, chicken tractors, and chicken pens shall be located at least three feet from the property line and at least 25 feet from any adjacent residential dwelling, church, school, or place of business.(9)Any enclosed chicken pen shall consist of sturdy wire or wooden fencing. The pen shall be covered with wire, aviary netting, or solid roofing.(10)Odors from chickens, chicken manure, or other chicken related substances shall not be detectable at the property boundaries.(11)All uses shall operate in accordance with the noise standards contained in section 6-1500 of the city zoning ordinance.(12)The chicken owner shall take necessary action to reduce the attraction of predators and rodents and the potential infestation of insects and parasites. Chickens found to be infested with insects and parasites that may result in unhealthy conditions to human habitation may be removed by an animal control officer. (13) The chicken owner shall always provide chickens with access to feed and clean water. The feed and water shall be unavailable to rodents, wild birds, and predators. (14) The chicken owner shall provide for the storage and removal of chicken manure. All stored manure shall be covered by a fully enclosed structure with a roof or lid over the entire structure. No more than three cubic feet of manure shall be stored. All other manure not used for composting or fertilizing shall be removed. The henhouse, chicken tractor, chicken pen, and surrounding area shall be kept free from trash and accumulated droppings.(15)No dog or cat which kills a chicken shall, for that reason alone, be considered a dangerous or aggressive animal. (16) It shall be unlawful for any person to keep chickens in violation of any provision of this article.(17) It shall be unlawful for any owner, renter,

or leaseholder of property to allow chickens to be kept on the property in violation of the provisions of this article.(18)Any violation of this article that constitutes a health hazard or that interferes with the use or enjoyment of neighboring property is a nuisance and may be abated under the general nuisance abatement provisions of the city.(19)Each day that a violation of this article continues is a separate offense.(20)All other applicable city codes shall apply.

Sec. 18-25. - Offensive or noxious odors from keeping animals or fowl.

No person shall keep or allow or permit to be kept on any premises occupied by him, or under his charge or control, any animal or fowl in a pen or other enclosure under such conditions that an offensive or noxious smell or odor shall arise therefrom, to the injury, annoyance, or inconvenience of any inhabitant of the neighborhood.

Background:

The Sikeston Department of Public Safety applied for a FY2023 SHSP grant through the Missouri Department of Public Safety for the protection of soft targets/crowded places in July of 2023 for \$14,986.00 for a drone to be added to our technical rescue team. The Sikeston Department of Public Safety was awarded this grant, however due to grant restrictions on Chinese manufactured drones we were not able to proceed with a satisfactory drone purchase or quote. After conversations with the Missouri Department of Public Safety we learned the awarded grant funds were still available to us and that we could make a different purchase using these funds. The Sikeston Department of Public determined our department would benefit from the purchase of a Stalker MC360 message trailer with (3'x6') message board. This message board would be used to alert residents to developing traffic issues or hazardous conditions as they travel on our roadways. Early warning or quick dissemination of information can improve safety for motorists as well as members of our community during hazardous events. The cost of the message board is \$19,250.00 leaving a difference of \$4,264.00. The cost difference, if approved, could be covered by available funds set aside in the Sikeston Department of Public Safety equipment budget. The Sikeston Department of Public Safety is requesting council approval to proceed with this grant process and purchase of the message board.

The Sikeston Department of Public Safety is duel trained in both law enforcement and fire disciplines. Currently there are approximately 53 post commissioned officers with an additional 25 officers trained in firefighter 1&2. The Sikeston Department of Public Safety has a special operations group who often respond to regional incidents related to high-risk situations not limited to a potential terrorist attack. This group has provided security for visiting national political leaders and other dignitaries. The special operation group is trained in special weapons, tactics and trains monthly on a variety of scenarios including terrorist attack. Many of these same team members are also assigned to the Homeland Security Response Team. This team consists of law enforcement, fire and rescue officers within our region. Some regional team cities are Sikeston, Jackson, and Cape Girardeau Missouri. This team like the Sikeston Special Operations Group meet and train monthly related to structural collapse, terrorist attack as well as swift water rescues. The Sikeston Department of Public Safety in conjunction with the Homeland Security Response Team provide a unique response resource for our region, providing a valuable safeguard against terrorist attack in our region. Notable soft targets within this response area are several power generating sources that feed the electrical grid, not only locally but statewide. Often the power grid is considered a high value target when speaking of soft targets. Damage to the electrical grid can have devastating effects on the economy, the health and safety of residents and create fear of other or continued terrorist attack. Our region is also unique and vulnerable to terrorist attack due to its geographical location. Southeast Missouri's eastern border is home to the Mississippi river and where the Mississippi Delta begins. Our river region is home to ports where grain and other goods are loaded and transported throughout the world. These ports are also considered soft targets to terrorists and a potential attack could have devastating effects on the transportation of grain and other goods. With the Mississippi River there are many bridges within this region that span the river. These bridges also considered soft targets are main routes of travel for commercial truck traffic that carry goods throughout the US. A potential attack on one or more of

these bridges, like an attack on one of the mentioned ports could have a devastating impact on the economy and health and safety of citizens nationally. Within the Southeast Missouri Area there are many events hosted within this region. The annual Sikeston Jaycee Rodeo hosts approximately 40,000 spectators every August with nationally acclaimed country music stars, professional rodeo athletes and notable members of the state of Missouri. Cape Girardeau is home to the Southeast Missouri District Fair which also attracts thousands of spectators each year. This region as a whole is home to many festivals, fairs, and public gatherings as well as a state university, a community college and a host of regional campuses. The Sikeston Department of Public Safety and the Homeland Security Response Team would like to add a drone or (UAV) to the already established response team's resources. The drone (UAV) would be housed at the Sikeston Department of Public Safety located at 201 S. Kingshighway in Sikeston, Missouri and would be used in preplanning to soft target responses related to terrorist attack. This drone (UAV) would be deployed to take arial video/photos in real time giving responders and team members a better understanding of potential weaknesses and strengths of soft targets, as well as response measures. This drove (UAV) would also be used to monitor large gatherings or crowds that also may present themselves as a soft target to a terrorist group.

The total estimated project cost per our application is \$563,310.00 with a local match required of \$112,662.00. (20%)
