Award Bid #25-50, Airport Runway Pavement Maintenance/Apron Improvements

Initial bids for this project was due February 28, 2025 but the two submitted bids were incomplete and both were rejected. Revised bids were opened March 31, 2025 and only one bid was submitted from Apex Paving of Cape Girardeau, MO in the amount of \$1,219,573.24. Hanson Professional Services is the engineering consultant for this project and recommend awarding the bids to Apex Paving and staff was in agreement. The project is a 90/10 funded project through Missouri Department of Transportation (MoDOT) Aviation, therefore only a 10% local match is required.

Councilman Baker motioned to award bid 25-50, Airport Runway Pavement Maintenance and Apron Improvements, to Apex Paving in the amount of \$1,219,573.24, with the City paying the 10% local match. The motion was seconded by Councilman Teachout, discussed and the following roll call vote recorded:
