REGULAR CITY COUNCIL MEETING AUGUST 30, 2021

The Sikeston City Council meeting of August 30, 2020 was called to order at 5:00 p.m. in the Council Chambers at City Hall located at 105 E. Center St., Sikeston. Present at the meeting were: Mayor Greg Turnbow and Councilmembers Brian Self, Ryan Merideth, Brandon Sparks and Vest Baker. Councilmembers Onethia Williams and David Teachout were absent. Staff in attendance were: City Manager Jonathan Douglass, City Counselor Tabatha Thurman, City Clerk Rhonda Council, City Treasurer Karen Bailey, Director of Public Works Jay Lancaster, Public Works Superintendent Brian Dial, Parks Director Dustin Care, Airport Manager Chris Hart and Public Safety Captain Ryan Smith.

PUBLIC HEARING – ESTABALISHMENT OF 2022 MUNICIPAL TAX LEVY

Councilman Self motioned to begin the Public Hearing to discuss the Establishment of the 2022 Municipal Tax Levy. The motion was seconded by Councilman Sparks and the following vote recorded:

Finance Director Karen Bailey presented the State Auditor's Office Assessed Valuation Summary and Tax Rate Calculations for establishing the 2022 property tax rates. The value of real estate and personal property in Sikeston increased by more than the Consumer Price Index of 1.4% established by the State Tax Commission. Tax rates will decrease slightly but combines revenues will increase.

No remarks were heard from the public.

BILL Number 6238

ORDINANCE Number 6238

AN EMERGENCY BILL, WHICH UPON ADOPTION AND PASSAGE, SHALL BECOME ORDINANCE NUMBER 6238, AN ORDINANCE FIXING THE RATE OF TAXATION ON ALL TAXABLE PROPERTY IN THE CITY OF SIKESTON, MISSOURI, FOR THE FISCAL YEAR 2021-2022.

WHEREAS, the Sikeston City Council held a public hearing in accordance with Section 67.110 RSMO prior to the adoption of the City's 2021-2022 Tax Rate.

NOW THEREFORE BE IT ORDAINED by the City Council of the City of Sikeston, Missouri, as follows:

Section I. This ordinance will not be codified in the Municipal Code Book of the City of Sikeston.

<u>Section II</u>. That for the purpose of maintaining a general fund, there is hereby levied a tax rate of four thousand one hundred sixty hundredths of a cent (\$.4160) per one hundred dollars (\$100.00) of assessed valuation on all taxable property in the City of Sikeston, Missouri, for the year 2021-2022.

<u>Section III</u>. That for the purpose of maintaining a public library fund, there is hereby levied a tax rate of one thousand nine hundred ninety-four one hundredths of a cent (\$.1994) per one hundred dollars (\$100.00) of assessed valuation on all taxable property in the City of Sikeston, Missouri, for the year 2021-2022.

<u>Section IV</u>. That for the purpose of maintaining public parks, there is hereby levied a tax rate of one thousand eight hundred thirteen one hundredths of a cent (\$.1813) per one hundred dollars (\$100.00) of assessed valuation on all taxable property in the City of Sikeston, Missouri, for the year 2021-2022.

<u>Section V</u>. General Repealer: Any other ordinance or parts thereof inconsistent herewith, are hereby repealed.

<u>Section VI</u>. Severability: Should any part or parts of this Ordinance be found or held to be invalid by any court of competent jurisdiction, the remaining part or parts shall be severable and shall continue in full force and effect.

<u>Section VII</u>. Emergency Clause: Due to requirements of the State of Missouri, this ordinance will become effective upon its passage.

Section VIII. Record of Passage:

Approve Consultant Selection for Community Development Block Grant (CDBG) Street Project

Bootheel Regional Planning Commission sought RFQs for an engineering consultant on the City's behalf for a Community Development Block Grant (CDBG) to pay for supplemental street projects within the City of Sikeston. The grant could be up to \$500,000. Three engineers responded to the RFQ: Smith & Company, Waters Engineering and Lambert Engineering. The City's Professional Consultant Committee reviewed the qualifications and unanimously selected Lambert Engineering for this project.

Councilman Sparks moved to approve Lambert Engineering as the consultant for the Community Development Block Grant (CDBG) Street Project. The motion was seconded by Councilman Merideth and the following vote recorded:

Approve Bid #22-10, Installation of Electric Service & Heater for Airport Multi Hangar

Over the last couple of years, many improvements have been made to the Multi Hangar at the airport. We are now in the process of updating the electrical service in the multi hangar to accommodate heaters. Six commercial heaters were purchased as a part of last year's budget. Electrical service additions and upgrades are needed for us to accommodate heat in the multi hangar.

On July 22nd, 2021, bids were solicited for the installation of a new 600amp electrical service to be installed and the hanging of the 6 commercial heaters. Only one bid packet was received and it was from Hart Electric Inc. for \$37,135. We reached out to John Chittenden from Waters Engineering for his review and recommendations, and based on his experience with airports, he felt it was a fair price.

Councilman Self moved to approve bid #22-10, authorizing the installation of electric service and heaters for the airport multi hangar. The motion was seconded by Councilman Merideth and the following vote recorded:

Authorize Lease Purchase of Dump Truck

Staff has worked with the most current state contract low bidder for dump trucks (TAG Trucking Enterprises) to prepare quotes for a single tandem axle truck. Staff is recommending the lease purchase of a new dump truck. The bid for the tandem axle is \$186,670.00. This is a 4-year lease.

Trucks will have automatic transmissions and be outfitted and ready to plow snow and pretreat with salt brine.

Councilman Sparks moved to authorize the lease purchase of one single tandem axle dump truck in the amount of \$186,670.00 for a 4-year term. The motion was seconded by Councilman Merideth and the following vote recorded:

1st Draft of Plans for American Recovery Plan Act Funds

The City of Sikeston will receive \$3,233,210.22 in American Rescue Plan Act (ARPA) funds. The first half of those funds was just received, and the second half will be received in twelve months. All of the funds must be obligated by the end of 2024 and spent by the end of 2026. Generally, what is included in the attached plan are parks/outdoor recreation projects in Qualified Census Tracts, technology upgrades to allow more citizen self-service or remote access to information and services, personal protective equipment for city employees, and stormwater projects.

Other Items

Councilman Self suggested to amend our ordinance, allowing non-city residents to ride their UTV's in the city limits of Sikeston.

Councilman Sparks read a letter of resignation, announcing his resignation as Ward 1 Councilman/Mayor Pro Tem effective October 1, 2021.

Authorize Mayor to Execute General Warranty Deed and Property Donation Letter Relating to Ingram Overpass

For the MoDOT Governor's Cost Share project (MoDOT Project #J9P3584), it is a requirement for MoDOT to expend their resources only on MoDOT Right of Way. Therefore, since the right of way for the overpass project was acquired by the City of Sikeston, it now needs to be transferred by deed to MoDOT. This General Warranty Deed handles that precise action. It is standard operating procedure for city projects with MoDOT.

Once the project is complete, any right of way that is not needed by MoDOT on a permanent basis will be transferred back to the City of Sikeston by deed.

In addition to the deed, a letter prepared by MoDOT needs to be executed waiving our requirement for an appraisal. This is also a standard document, and is a requirement of the federal Uniform Act.

SECTION II: Chapter 300, Section 300.010 – Definitions - is amended to read as follows:

"ALL-TERRAIN VEHICLE – Any motorized vehicle manufactured and used exclusively for offhighway use, with an unladen dry weight of one thousand five hundred pounds or less, traveling on three, four or more nonhighway tires, with either:

- (a) A seat designed to be straddled by the operator, and handlebars for steering control; or
- (b) A width of fifty inches or less, measured from outside of tire rim to outside of tire rim, regardless of seating or steering arrangement.

OWNER – Any person, firm, corporation or association, who holds the legal title to a vehicle or who has executed a buyer's order or retail installment sales contract with a motor vehicle dealer licensed under sections 301.550 to 301.580 for the purchase of a vehicle with an immediate right of possession vested in the transferee, or in the event a vehicle is the subject of an agreement for the conditional sale or lease thereof with the right of possession vested in the agreement and with an immediate right of possession vested in the agreement and with an immediate right of possession vested in the or lessee, or in the event a mortgagor of a vehicle is entitled to possession, then such conditional vendee or lessee or mortgagor shall be deemed the owner.

RECREATIONAL OFF-HIGHWAY VEHICLE – Any motorized vehicle manufactured and used exclusively for off-highway use which is more than fifty inches but no more than eighty inches in width, measured from outside of tire rim to outside of tire rim, with an unladen dry weight of three thousand five hundred pounds or less, traveling on four or more nonhighway tires and which may have access to ATV trails.

UTILITY VEHICLE – Any motorized vehicle manufactured and used exclusively for off-highway use which is more than fifty inches but no more than eighty inches in width, measured from outside of tire rim to outside of tire rim, with an unladen dry weight of three thousand five

hundred pounds or less, traveling on four (4) or six (6) wheels, to be used primarily for landscaping, lawn care, or maintenance purposes."

<u>SECTION III:</u> General Repealer Section: Any other ordinance or parts thereof inconsistent herewith, are hereby repealed.

<u>SECTION IV:</u> Severability: Should any part or parts of this ordinance be found or held to be invalid by any court of competent jurisdiction, the remaining part or parts shall be severable and shall continue in full force and effect.

<u>SECTION V:</u> Record of Passage

- A. Bill Number 6241 was introduced and read the first time this 30th day of August, 2021.
- B. Bill Number 6241 was read the second time and discussed this 13th day of September 2021. Following discussion, Councilman Merideth moved to approve Bill Number 6241. The motion was seconded by Councilman Baker, discussed and the following roll call vote was recorded:

This bill would allow non-Sikeston residents to register and operate UTV's in the city limits of Sikeston.

Background:

The City Council determined toward the end of budget preparations for the current fiscal year to include significant renovations to Dancler Field. These improvements included lighting, fencing, field work, etc. At the time, staff made the best judgments possible on estimates for the overall project given the short time frame to do so.

The first portion of this project is now ready to begin: the fencing portion. Staff has bid out a project to remove existing fencing and install all new fencing. This will be done with a slight shift to the current field layout. At the time, we estimated a fencing project with a cost of \$38,700 back in June of this year. Since then, we added to the scope of the project, and there have been significant price increases due to COVID impacts. Staff opened bids on Wednesday, September 15, 2021, and received only one bid from Bootheel Fence Company (located in Jackson, MO) for \$70,500. The bid tabulation sheet is attached.

After having post-bid discussions with the low bidder, and considering the additional work and price increases, staff is comfortable recommending the award to Bootheel Fence Company with a low bid of \$70,500.

Prior to making this recommendation, we did analyze the overall project for price fluctuations to all the aspects of the project scope. We have had conversations with various contractors and

suppliers we work with to determine more refined estimates for the work remaining, so that we can ensure ourselves and the council that the overall project is on track from a budget perspective.

As of the writing of this council letter, our best estimates we have to date are summarized below:

While it can be seen in the table above that some of the items are costing more than we originally expected, we believe at this time that the overall project budget should fall in line.

The main area where we are accessing these savings is in the lighting. Rather than a turnkey project with the large lighting companies, we have had one-on-one meetings with their main contractor to seek ways to create savings while still achieving the design we seek. We believe that with Sikeston BMU's involvement, we can purchase new wood poles, and run power supply wiring to the new pole locations. We will hire the contractor to supply the proper equipment and install it on the wood poles. Then BMU will set each pole. We feel like we have a good plan for this and hope to replicate it in future years in other areas, such as the softball field at Rotary Park.

Specific to this fencing bid, we are seeing a significant increase. Part of this increase is due to modified scope in which we added new items. After the budget was approved, we decided it best to have the area surveyed and get a professional layout. This process determined a need to shift the field, which resulted in more posts and fencing being required to achieve the proper result we felt was best. We also added new dugout work (including concrete slabs) and a 6-foot overhang to the backstop since it is so near vehicle traffic.

The other cost increase came from material increases. We have seen construction materials of all types skyrocket in pricing the last few months, and fencing was no exception. The price increases that have happened since June and continue to be forecast for the next few months continue to have an impact on this project and others.

For these reasons, staff feels it best to continue forward on the project and award Bid #22-12 to Bootheel Fence Company with a low bid of \$70,500. Thank you for your support.



Background:

In August 2013, the State of Missouri established the Sheriffs' Retirement Fund Surcharge. A fee of three dollars (\$3.00) was assessed following a conviction or plea of guilty in all cases involving the violation of a municipal ordinance or traffic law. The three dollar (\$3) fee was collected by the municipal court clerk and subsequently forwarded by the city to the "Sheriffs' Retirement Fund".

In June 2021, the Missouri Supreme Court ruled the fee was unconstitutional and municipalities were ordered to stop withholding it effective July 1, 2021. The city immediately ceased collection of the fee. Bill Number 6245 updates city code referencing court costs.

The Supreme Court order was for new assessments only. There are no appellate or Supreme Court orders regarding the collection of previously assessed or previously disbursed Sheriffs' Retirement Fund surcharge.

Staff recommends passage of Bill Number 6245 following its second reading.

BILL Number 5918

ORDINANCE Number 5918

THIS BILL AS APPROVED SHALL BECOME EMERGENCY ORDINANCE NUMBER 5918 AND SHALL AMEND TITLE 1, CHAPTER 135 OF CITY CODE TO AUTHORIZE THE COLLECTION OF ADDITIONAL COURT COSTS AS REQUIRED BY STATE STATUTE.

WHEREAS, Section 57.955 of the Revised Statutes of the State of Missouri requires municipalities to assess a surcharge on any violation of criminal or traffic laws of the state; and

THEREFORE BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF SIKESTON, **MISSOURI AS FOLLOWS:**

SECTION I: This Ordinance shall be codified in the Municipal Code of the City of Sikeston, Missouri

SECTION II: Establishment of Sheriff Retirement Fund Surcharge;

"SHERIFFS' RETIREMENT FUND SURCHARGE"

- A. In accordance with Section 57.955 of the Revised Statutes of Missouri, there shall be assessed a fee of three dollars (\$3.00) following a conviction or plea of guilty in all cases involving the violation of a municipal ordinance or traffic law, except those cases where the charge has been dismissed by the court or when costs are to be paid by the state, county or municipality.
- B. The said three dollar (\$3.00) fee required in paragraph A above, shall be collected by the Municipal Court Clerk who shall, at least monthly, transmit all such fees collected to the City Clerk.
- C. The City Clerk shall, at least monthly, transmit of all such fees referred to in paragraph A above which are received from the Municipal Court Clerk to the "Sheriff Retirement Fund."

SECTION III: General Repealer Section. Any other ordinance or parts thereof inconsistent herewith, are hereby repealed.

SECTION IV: Severablity. Should any part or parts of this ordinance be found or held to be invalid by any court of competent jurisdiction, the remaining part or parts shall be severable and shall continue in full force and effect.

SECTION V: Emergency Clause. This Ordinance is adopted as an emergency measure to meet the statutory effective date of August 28, 2013.
