DAMAGE & CLEAN-UP AGREEMENT Said Group agrees to pay Springfield Township Parks and Recreation Commission for maintenance cost or damage to any property caused by said Group at said location, and said Group agrees to forfeit their security deposit if the field or fields used by said Group is not CLEANED UP and returned to the condition in which it was found.

Parking and Vehicles: Parking is allowed in parking lots only. No unauthorized vehicles are permitted to be on the grass, sidewalks, trails, fields, etc. **Fields are not accessible by vehicle by way of the asphalt pathway. If vehicles are driven to the field by coaches, parents or players all the liability will be assumed by the team through forfeiture of security deposit, payment of additional damage fees, if applicable, and loss of facility use privileges. In addition, the driver of the vehicle could be subject to a ticket for violating a Township ordinance.**
