**AN ORDINANCE SETTING THE COMMISSION
MEETING SCHEDULE FOR 2024 INCLUDING
WORK SESSIONS**

WHEREAS, U.C.A. §17-53-204 requires the County Legislative Body to "provide by ordinance for the holding of regular meetings of the county legislative body"; and

WHEREAS, the County Legislative Body has determined that the following schedule is in the best interest of the public and county employees.

THEREFORE, THE COUNTY LEGISLATIVE BODY OF UINAH COUNTY ORDAINS AS FOLLOWS:

Section I. Meeting Schedule and Location

The work sessions of the Board of County Commissioners of Uintah County for 2024 will be held every Monday (excepting legal holidays) beginning at 9:00 AM. Should a legal holiday fall on the Monday of a regular scheduled work session meeting, said meeting will be held the following Monday.

The regular meetings of the Board of County Commissioners of Uintah County for 2024 will be held every Tuesday (excepting legal holidays) beginning at 3:00 PM. Should a legal holiday fall on the Tuesday of a regular scheduled meeting, said commission meeting will be held the following Tuesday.

Nothing herein shall be construed as limiting the County Commission from canceling the regular meeting from time to time as the Commission deems prudent. Should a meeting be canceled notice shall be posted at least 24 hours in advance at the State/County building in Vernal, Utah and on the Utah Public Notice Website.

Work session meetings will be held in the commission large conference room and the regular meetings will be held in the Commission Chambers at the County building in Vernal, Utah.

Section II. Public Notice

The following public notice shall be posted at the County Building in Vernal, Utah, on the Utah Public Notice Website, and provided to a newspaper of general circulation in the county:

Should a legal holiday fall on either day the affected meeting will be held on the following Monday or Tuesday, respectively.

Nothing herein shall be construed as limiting the County Commission from canceling the regular meeting from time to time as the Commission deems prudent. Should a meeting be canceled notice shall be posted at least 24 hours in advance at the County Building in Vernal, Utah and on the Utah Public Notice Website.

Work session meetings will be held in the commission large conference room and the regular meeting will be held in the Commission Chambers at the County Building in Vernal, Utah.
