AN ORDINANCE OF UPPER HANOVER TOWNSHIP AMENDING CODIFIED ORDINANCE 460-5 TO PERMIT TRUCK TRAFFIC ON A PORTION OF KRAUSSDALE ROAD; INCLUDING AN EFFECTIVE DATE AND REPEALER CLAUSE

In recognition of the legally permissible commercial development of a portion of Kraussdale Road, such use requiring the ingress and egress of truck traffic, and developer improvements to the involved portion of Kraussdale Road, Upper Hanover Township codified ordinance section 460-5, "Trucks Prohibited On Certain Roads", is hereby amended as follows:

The existing language is deleted and replaced with the following:

Vehicles with a wheel base over 21 feet in length and combination tractor/trailer vehicles of any length are prohibited on the following Township-owned or -controlled roads:

Landis Road

Mill Hill Road

Warner School Road

Wasser Road

Ziegler Road

Kraussdale Road, except, however, that such trucks are permitted on the portion of Kraussdale Road between its intersection with Gravel Pike and a point 750 feet northeast thereof. All such signage as is required to effectively prohibit truck traffic on the remainder of Kraussdale Road is, in addition to such signage as is required to prohibit truck traffic on the other roads listed herein, hereby authorized.

To the extent that any existing Township ordinance is inconsistent with the foregoing, it is repealed to the extent of such inconsistency.

This ordinance is effective five days after adoption.
