### APPOINTMENT

Engineer Robert LeMaitre and property owner Joel Pentlarge are present to request a local upgrade for property located at 1 Doane Road. Request is to use a sieve analysis as a substitute for a perc test due to lack of area and cost. This property has a existing easement for leach field which is located across the street on property at 1 Greenwich Plains Road and owned by Tricia Biron. Ms Biron was notified of this meeting but is not present. John motioned to approve use of sieve analysis as a substitute for a perc test, Katrina 2<sup>nd</sup>, all in favor.

### DISCUSSION/ACTION

**1: Resource Waste** Judy continued to update the board on the process for the proposed modification at this site. Judy and John also attended the public informational meeting at senior center last week ReSource Waste held to inform public of their proposal. At that meeting when Judy questioned why they are not utilizing the approved 750 tons/day was informed they are actually having a hard time finding a landfill that will take the amount of residuals from them they would need on a daily basis.

**2: Harm Reduction update** Board was informed letter to state giving their approval for this program has been prepared and only needs the meeting minutes of 3/16/2022 to attach to them. Once minutes are approved the letter will be mailed.

**3: COVID update:** Judy informed the board this week (Wednesday – Wednesday) Ware had 12 confirmed COVID cases, previous week was 20 and week prior to that was 13. She also informed them of the 17 Influenza cases in Ware for April to date.

**4: Meeting Minutes** John motioned to approve meeting minutes of March 16, 2022, Katrina seconded, all in favor.
