4. IN CONSIDERATION OF THE GRANTING OF THIS PERMIT TO CONNECT TO THE SEWER SYSTEM, THE UNDERSIGNED AGREES:

- To accept and abide by all the provisions of Chapter 43 of the Code of the Town of Ware, Massachusetts, the Regulations of the Commonwealth of Massachusetts and all other pertinent ordinances or regulations that may be adopted in the future.
- To install the sewer service connection according to the applicable standards and specifications of the Town of Ware, the Water Pollution Control Federation and any other professional or governmental organizations charged with establishing such standards.
- To notify the Superintendent or his authorized agents when the sewer service is ready for connection to the municipal sewer system, but before any portion of the work is covered.

The current fee schedule, voted by the Board of Selectmen on April 13, 2010, is as follows:

Application Fee - \$200.00/application
Resident Sewer Connection - \$2,250.00 per Equivalent Dwelling Unit (EDU)
Commercial Sewer Connection - \$5,000.00 per connection
Industrial Sewer Connection - \$10,000.00 per connection

All application and connection fees must be paid in full before any connection is allowed. "Connection Fees" do not include any parts or labor provided by the Ware Department of Public Works.
