#### Greetings:

Welcome to our 2023 Annual Report. I am excited to share this as a stand-alone report from the Waupaca County Department of Public Health (DPH). For the last 36 years, public health and human services have been combined as the Department of Health & Human Services. In 2023, Waupaca County returned to delivering services as independent departments: the Department of Public Health (DPH) and the Department of Human Services.

Public health has certainly evolved in the last 36 years. When the departments of public health and human services combined in 1987, there were some similarities in services. At that time, both health and human services primarily provided individual patient/client-centered services. Today, public health is much more focused on community/population health, as well as acting as a community health strategist to support efforts in communicable disease control, chronic disease prevention, environmental health, mental health, and health equity. DPH still provides some patient care for our community, with services like immunizations and disease testing, but much of our work is centered around programs that provide prevention, promotion of health policy and practices, and control of disease and chronic health conditions.

As a local health department, DPH is also charged with collecting and analyzing data, providing surveillance, and communicating with community partners and the public. Additionally with the separation of departments, DPH now has an independent Board of Health (BOH) as the governing body of the health department. The BOH will provide a focused effort to support and guide this department toward the goal of optimal community health in Waupaca County.

Ultimately, the move to return to an independent department with a stand-alone Board of Health was made to enhance the services provided by Waupaca County DPH. We hope that the new design of this report highlights those services and provides a better understanding of the activities and accomplishments of the last year. We continue to work hard to meet the needs of our community and to support our residents and guests in creating a healthy and vibrant place to live, work, play, and visit.



### Public Health Administration

#### FINANCIAL OVERVIEW

DPH manages fiscal resources in collaboration with the Waupaca County Finance Department and is focused on resource utilization to optimize services. In 2023, DPH operated within the approved budget.



### Public Health Administration

#### **BOARD OF HEALTH**

In 2023, Waupaca County restructured to separate the Department of Health and Human Services (DHHS) into two separate, stand-alone departments - Health Services (Public Health) and Human Services. The departments formally uncoupled in September of 2023. With this change, the DPH re-established its own governing body. This seven member committee is known as the Board of Health (BOH).

Board of Health Responsibilities are outlined by Wisconsin Statute Chapter <u>251.04</u> and are as follows:

- Govern the local health department.
- Assure the local health department is a Level I, Level II, or Level III.
- May adopt regulations for its own guidance and for the governance of the local health department necessary to protect and improve public health. The regulations may be less stringent than, and may not conflict with, state statutes and rules of the department.
- Assess public health needs and advocate for the provision of reasonable and necessary public health services.

- Report to the state department by rule.
- Meet at least quarterly.
- Develop policy and provide leadership that fosters local involvement and commitment, that emphasizes public health needs and that advocates for equitable distribution of public health resources and complementary private activities commensurate with public health needs.
- Assure measures are taken to provide an environment in which individuals can be healthy.
- Unless specified otherwise by ordinance, shall employ qualified public health professionals.







#### **COUNTY HEALTH RANKINGS**

#### COMMUNITY HEALTH IMPROVEMENT PLAN

The <u>Community Health Improvement Plan (CHIP)</u> was published in 2023. A CHIP is a long-term, systematic effort to address community health issues. It describes how DPH and the community will work together to set priorities and coordinate/ target resources. A CHIP is critical for developing policies and defining actions that focus efforts to promote health for all members of the community.



#### FENTANYL AWARENESS CAMPAIGN

Waupaca County DPH launched a multi-month awareness campaign focused on fentanyl. The campaign consisted of billboards, indoor bathroom advertisements, and social media posts sharing the message "One Pill Can Kill."

7 billboards posted throughout the county, were estimated to make **256,977 weekly impressions**.

### 2023 HIGHLIGHTS



#### **EPIDEMIOLOGIST POSITION**

In 2023, Waupaca County DPH hired their first epidemiologist. An epidemiologist's job is to oversee data collection, analysis, and interpretation. They also function as a strategist, helping steer the department's efforts to best meet the community's needs. Hailey Prosek (pictured above) has been DPH's epidemiologist since September 2023.



#### **NITRATE TESTING**

Nitrates in drinking water are a growing concern. In 2023, DPH's water laboratory expanded capabilities to provide in-house nitrate testing. DPH's water laboratory processes ~200-300 nitrate samples per year. Previously, samples were mailed to other laboratories for testing. Now, these samples are tested in-house for rapid results and cost-savings.



#### **HELP ME GROW**

Help Me Grow (HMG) is a national, evidence-based model that consists of programs from a variety of sectors that come together to promote early childhood development.

HMG was first brought to WI in 2020. Waupaca County DPH contracted with ThedaCare and First Five Fox Valley to expand HMG to Waupaca County in 2022, placing a Rural Community Navigator within Public Health. One of the Healthy Beginnings case managers serves as the Rural Community Navigator.

HMG provides access to developmental screenings (the ASQ), links families to services, and provides ongoing support—typically by phone, text, or email.



In 2023, HMG provided & followed up on 361 developmental screenings.  گُلُگُ

### Public Health Overview





DPH works to assist the community with access to preventive and reproductive health services.





Public Health's role is to aid in preventing the spread of these diseases while also promoting recovery and healing for those who are sick through ongoing education, direct care, and case management.




DPH responded to 1,641 communicable disease cases.





### Communicable Disease Control



Illnesses spread by ticks are common in Waupaca County and across Wisconsin, but they are preventable. DPH educates individuals and community partners on Tick Bite Prevention and follows up with people who are diagnosed with tickborne illnesses to help guide them on the next steps of their journey to wellness.



#### **Childhood Lead Poisoning Prevention & Intervention**

Childhood Lead Poisoning Prevention & Intervention supports children with elevated blood lead levels by providing follow-up, investigation, and education to eliminate sources of lead from the child's environment.



**Responded to 22 new cases of elevated blood lead levels in children** (3.5 micrograms per deciliter or greater)



Investigated 1 elevated blood lead case of 20 micrograms/deciliter



Performed 9 Lead Tests and 2 Re-tests for daycares in Waupaca County

#### Infant Safe Sleep

Infant Safe Sleep initiatives provide families with up-to-date information on the current best practices for safely putting their baby to sleep at night. For eligible families, DPH can also provide a pack & play for free to ensure their baby has a safe sleep environment.






#### **Harm Reduction**

Harm Reduction is a public health approach that focuses on reducing the harmful consequences of substance use, including prevention of injury, transmission of infectious disease and overdose.



Waupaca County Fatality Review Teams exist to create a better understanding of the risk factors and circumstances that surround preventable deaths within Waupaca County and improve how organizations can work together to improve function, coordination, service delivery, and ultimately reduce or eliminate future preventable deaths from occurring. 





Fit Families is a 13-month successful behavior change program that strives to help prevent childhood overweight/obesity by empowering families to adopt healthy eating and physical activity behaviors through inperson and phone/text coaching. The program is geared towards families of 2-4 year old children enrolled in WIC. The information in this report reflects the 2023 SNAP-Ed federal fiscal year (FFY) that ran from October 1, 2022, through September 30, 2023.








#### Women, Infants & Children (WIC)

Women, Infants and Children (WIC) promotes and maintains the health and well-being of nutritionally-at-risk pregnant, breastfeeding, and postpartum women, infants, and children.

Our WIC program offers:

- Screening for nutrition and health needs.
- Information on how to use WIC foods to improve health.
- Benefits to buy healthy foods, including infant formula (if needed).
- Immunization referrals.
- Referrals to doctors, dentists, and other support programs.
- Information on healthy eating during pregnancy and breastfeeding.
- Help with starting or continuing breastfeeding.



#### **BREASTFEEDING SUPPORT**


The WIC program contracts a breastfeeding peer counselor to provide education and support to women who are currently breastfeeding or are considering breastfeeding their child.





#### Healthy Beginnings

Healthy Beginnings is a free, voluntary home visitation program that offers information and support to parents of infants or young children. Case managers offer families support in the areas of the parent-child relationship, child development, and family health and safety. Referrals for Healthy Beginnings come from many sources, including Child Protective Services (CPS), primary care providers, the WIC program, and school districts.

#### Prenatal Care Coordination (PNCC)

Prenatal Care Coordination (PNCC) provides expectant parents with information on prenatal care, labor and delivery, breastfeeding and nutrition, and comfort measures for mother and child. PNCC services are provided by Public Health Nurses (PHNs). PHNs also refer families to additional needed community resources.

20 expectant mothers were referred

7 new clients were enrolled 10 total clients received services



#### Postpartum Support

Postpartum support is provided by PHNs. Families are referred for postpartum support due to concerns such as infant health, maternal health, AODA or mental health concerns, or breastfeeding issues.



8 families were referred for postpartum support



### **Foundational Capabilities**



#### Assessment & Surveillance:

Involves DPH's ability to track the health of the community through data, case findings, and laboratory tests, with particular attention to those most at risk.

#### In 2023, DPH :

- Hired an Epidemiologist to oversee and expand data collection, analysis, and interpretation efforts for DPH.
- Expanded testing capabilities in the DPH water lab for rapid detection of drinking water concerns.
- Participated in ongoing communicable disease surveillance systems.
- · Supported community partners to improve data collection and surveillance efforts.



#### **Community Partnership Development:**

Highlights skills that show DPH's capacity to harness and align community resources to advance the health of all community members.

#### Activities included:

- Helped organize a community event focused on reducing stigma and building hope within the recovery community.
- DPH staff are involved in a number of community coalitions such as the Waupaca Area Recovery Coalition, Waupaca County Suicide Prevention Coalition, Be Well Waupaca County (previously Living the Waupaca Way), and Community Health Action Team (CHAT).
- Convened multi-agency partners to collectively address preventable deaths through fatality review teams.



#### Equity:

Includes skills that indicate DPH's ability to address social and structural determinants of health through policy, programs, and services.

#### **Efforts included:**

- Strategically expanded DPH's offsite operations to improve accessibility of services.
- Increased staff capacity to work with multilingual populations by purchasing translation equipment to expand availability of DPH resources in various languages.
- Supported DPH staff in participating in health equity training opportunities.
- Integrated health equity principles into program and service areas.



#### **Organizational Competencies:**

Looks at the ability to lead internal and external stakeholders to consensus and action, with a particular focus on advancing health equity in communities. These competencies include leadership and governance, information technology services including privacy and security, human resources, financial management, legal services, and analysis.

#### DPH:

- Oversaw recruitment, training, and performance review processes for all new and returning DPH employees.
- Secured multiple grants to support the department's work.
- Provided annual training on HIPAA and ongoing training on confidentiality, privacy, and security.



### Foundational Capabilities



#### **Emergency Preparedness & Response:**

Focuses on preparing for, responding to, and recovering from events that pose a substantial risk to the health of residents in the county. The PHEP program provides information, resources, and expertise to partners and community to be ready for and recover from health threats, emergencies, and disasters.

#### Activities included:

- Coordinated/supervised a school vaccination clinic.
- Worked with partners to support public health preparedness, response, and/or recovery activities.
- Distributed 1000 2-1-1 and DPH informational magnets.
- Staff held active membership in Fox Valley Area HealthCare Coalition meetings.



#### Policy Development & Support:

Includes skills that indicate DPH's ability to translate science into appropriate policy and regulations.

#### In 2023:

- Provided control measures and public protections for communicable disease events.
- Acted as a resource to outside agencies looking to implement new or revise current practices that affect health.
- Routinely provided oversight to various facilities around the county to issue, promote or enforce compliance with public health regulations.
- Assisted partners in responding to changes in policies that promote and protect public health.

#### **Communications:**

Highlights skills related to DPH's ability to reach the public effectively with timely, science-based information.

#### In 2023, DPH:

- Posted 169 times on Facebook to educate and inform on a variety of public health topics.
- Regularly updated information and resources on department website for public access.
- Utilized billboards and indoor advertisements around the county for the Fentanyl Awareness Campaign.
- Provided partners around the county with informational flyers, posters, and handouts with DPH information to reach community members.



#### Accountability & Performance Management:

Looks at the ability to apply business practices that assure efficient use of resources to achieve desired outcomes and foster a continuous learning environment (e.g., quality improvement).

#### 2023 efforts included:

- Completed the Wisconsin Department of Health Services (DHS) 140 Review process and proved compliance with all required statutes and rules.
- Staff completed Public Health Core Competency Assessments to indicate future training opportunities.





## Local health departments are the center of the local public health system


- Responsible for the health & well-being of everyone who lives, learn, works, and plays within their jurisdiction


#### **Social Determinants of Health**


# WI Administrative Rules

"to protect and promote the health of all people in all communities"

# Assessment

1. Assess and monitor population health status, factors that influence health, and community needs & assets

2. Investigate, diagnose, and address health problems and hazards

# Policy Development

3. Inform and educate people about health, factors that influence & how to improve it

4. Mobilize communities and partnerships

5. Create, champion & implement policies, plans, and laws

## Assurance

6. Use legal and regulatory actions designed to improve and protect

7. Assure effective systems enables equitable access to services and care

8. Build & support diverse & skilled workforce

9. Improve & innovate through ongoing evaluation, research, and QI

10. Build & maintain strong organizational infrastructure

# WI DHS 140 Review

- Confirms a local health department meets requirements for Level 1, Level 2, or Level 3
- Conducted every 5 years

National Public Health Accreditation

- Standards in carrying out the 10 Essential Public Health Services
- Demonstrates ability to meet national standard to carry out quality governmental public health services
  - Pathways Recognition Program
  - Accreditation

# What is a Board of Health in WI?

Governing body for a local health department

Governance varies across Wisconsin

Currently 85 local health departments

County, multi-county, city-county, city, village, and multi-city/village

Wisconsin Statute Chapter 251.03 Membership

- No more than 9 members
- At least 3 members not elected officials
- Good faith effort to appoint RN and physician, allowing to appoint physician assistant, advance practice RN, or both, if unable to find
- Reflect the diversity of the community

# What does a Board of Health do?

Wisconsin Statute Chapter 251.04 outlines powers and duties:

- Govern the local health department
- Assure the local health department is a Level I, Level II, or Level III
- May adopt regulations for its own guidance and for the governance of the local health department necessary to protect and improve public health. The regulations may be less stringent than, and may not conflict with, state statutes and rules of the department.
- Report to the state department by rule.
- Meet at least quarterly.

# What does a Board of Health do? (continued)

- Assess public health needs and advocate for the provision of reasonable and necessary public health services.
- Develop policy and provide leadership that fosters local involvement and commitment, that emphasizes public health needs and that advocates for equitable distribution of public health resources and complementary private activities commensurate with public health needs.
- Assure measure are taken to provide an environment in which individuals can be healthy.
- Unless specified otherwise by ordinance, shall employ qualified public health professionals
