


#### SHERIFF'S OFFICE 2002 ANNUAL REPORT

Negotiating with other Counties for the housing of their Safekeepers in our facility was a major consumer of my time for 2002. I focused on obtaining written contracts from counties that were in the same position now that we were in in 2001, with over crowded jails. I had succeeded at the end of 2001 in having Portage County begin to send us some inmates to alleviate their population problems. By mid 2002, Wood County signed a contract with us guaranteeing payment for 25 beds per day until the end of the year.

In mid-2002, budget cuts struck the County, in turn affecting the Sheriff's Office. We had to become very inventive to cut \$140,000.00 from our approved budget. This resulted in a lessoning of coverage in certain divisions of the department including patrol, jail and the reserve unit. Vacant shifts were not filled, as would normally be the case. Groups holding functions such as a corn roast were now responsible for paying the entire costs of maintaining a reserve officer on site. Thanks to all of the efforts of Chief Deputy Kraeger and rest of the officers, who, despite the pressure of working under these types of conditions, helped us meet those requirements.

Traffic fatalities for the year of 2002 stood at 15. This is down from 20 for 2001. The grant awards from the Wisconsin DOT for OWI saturation, US 10 and Speed Waves were received again this year. It is my understanding, according to the Wisconsin Department of Transportation, the plans for reconstruction of the USH 10 and CTY A intersection are still on tract.

In April of 2002, Captain James Kneisler retired after serving this department for 30 years. He was instrumental in directing several countywide projects. His attention to detail, mentoring abilities and organizational skills will be missed. Lieutenant Christ Brogaard was promoted to Captain replacing Kneisler as head of the Administrative Division. With the departure of Emergency Management Director Jeff Kubitz, at the end of 2001, the Communications Center was moved under the Sheriff's Department and is now within the Administrative Division.

In November, Detective Captain Donald Berglund announced his plans to retire in early January of 2003. Don also retiring with 30 years of service with this Department. He was involved in every major case in Waupaca County during his years here. His knowledge, experience and endless commitment will be missed. In order to continue the organizational structure, the process for his replacement was begun. Detective Sergeant Donald Conat was chosen on December 18, 2002 to replace Berglund. I believe Captain Conat will continue to be an asset to this Department in his new position.

As demands for budgetary restraints continue, my staff remains diligent in serving the citizens of Waupaca County as resources allow. I believe they are doing the best job possible with what they have, however, time will decide how long this pace can be continued with the available staff.

#### ADMINISTRATIVE DIVISION 2002 ANNUAL REPORT

The year of 2002 saw many changes in the Administrative Division of the Sheriff's Office. The most significant change was the April retirement of James Kneisler, Captain of the Administrative Division. Captain Kneisler was a driving force within the Sheriff's Office and headed several key projects in his 30 years with the Department. The creation of a new countywide communications project, including an enhanced 911 center and being the transition coordinator for the new Law Enforcement Center building project, just to name a few. His absence will be felt by all. With his retirement I was promoted to the Administrative Captain's position. I will do my best to fill the gap left by his leaving. Sergeant Jacqueline Radtke was promoted to Lieutenant, replacing me and Officer Charity LePak was promoted to Sergeant to replace Radtke.

The year 2002 was our first full year in the new facility. Although most of the "bugs" had been worked out at the end of 2001, there was still some adjusting to do by staff and inmates alike. Inmates were coming to the realization that the officers controlled the jail now versus the way it was in the old facility. Officers were finally becoming comfortable with all of the new equipment and procedures, particularly procedures dealing with Safekeepers.

The housing of "Safekeepers" from other Counties was another change. Even though we actually started accepting Safekeepers at the end of December 2001, we did not reach our peak until mid 2002 when a contract was signed with Wood County for 25 beds. Between Wood, Portage and Winnebago counties we held an average of 34 Safekeepers per day resulting in a daily high of 48. With this new income, brought about renewed interest in the opening of our second floor, which was unused except for the medical unit. The signed contract was a step in the right direction to hiring the additional corrections staff necessary in opening the second floor. The Wood County contract stated that in September of 2002 they would re-contact us with a number of beds they needed for 2003. However, the new contract did not materialize thus the second floor remains only partially open.

For the first time in the jail's history, it became a source of revenue in 2002. We collected \$22,685.00 in booking fees, \$4503.42 in daily fees and \$439,395.00 for housing Safekeepers and \$61,083.99 in jail assessment fees from citations that were issued. We also discontinued a practice that has always been followed here. In the past we paid full price for all medical charges. According to Wisconsin State Statute 302.38(3), the county is liable for the costs of inmate medical and hospital care at the medical assistance rate.

We have contracted with EDS of Madison, who codes our medical provider bills and then returns them to us with the rate we should pay. For 2002 we were billed for \$26,343.58 and have paid \$3,016.29 for a savings of \$23,327.29.

Another change was brought about by budget concerns. The department had to make financial cuts. The overtime budget was severally attacked in our division. Needed, but not mandatory, positions, which would normally be filled by overtime was left vacant. This did not occur until JUNE/JULY of 2002 but by October it was evident that the increased workload associated with the increased number of Safekeepers and the staff levels at minimum, was starting to take its toll on the officers "well being".

The most dramatic change in the Administrative Division was the addition of the E911 Communications Center. Due to the retirement of the Emergency Management director in November of 2001, the center came under the Sheriff's Office. In June of 2002 it was positioned under the Administrative Division, adding 11 new persons to it. In December, Daniel Hayes resigned his position as telecommunicator. Officer Shane Bazile transferred to the Communications Center from Transport due to an injury received while on duty in March of 2001. Shane's injury prevents him from continuing as a transport officer, so we are glad he was able to stay with the department. He will be a welcomed asset to the communications center.

As stated above, 2002 brought about many changes. Along with that came many challenges. I believe those challenges were met due to the hard work and diligence by all of the staff in the Administrative Division. We look forward to what 2003 will bring.

## DETECTIVE DIVISION 2002 ANNUAL REPORT

In 2002 the Waupaca County Sheriff's Department investigated over 100 drug complaints. As a result of those investigations 49 individuals were charged as misdemeanor offenders and 19 were arrested as felons. There are numerous drug investigations that began in 2002 that are currently ongoing. Included in the felon category were two individuals from the Iola area that were arrested following a joint investigation with the Portage County Sheriff's Department, the Juneau County Sheriff's Department, the Wisconsin State Department of Narcotics Enforcement, and the Federal Drug Enforcement Agency. The two who were arrested were husband and wife. Between the two of them they face over 300 years in prison.

In March of 2002 detectives spent a considerable amount of time investigating the death of a nine-month-old baby from rural Clintonville. The baby had received a skull fracture when she was thrown onto a hardwood floor by her 24 year old father. The baby's father was arrested for physical abuse of a child. He was convicted for first degree reckless homicide and two counts of substantial battery. He was sentenced to thirty-two years in prison with twenty-one years extended supervision.

In August of 2002 Waupaca County Sheriff's Department detectives with the assistance of patrol officers, arrested a 43-year old rural Waupaca man for attempted murder for an incident that happened in Elkhart County Indiana. The Waupaca man had forced his way into a residence with a gun. During the armed home invasion he attempted to kill the homeowner but his gun failed to fire. He was shot in the left shoulder by the homeowner. The Waupaca man showed up the next morning at the hospital in Waupaca seeking treatment. Detectives from The Waupaca County Sheriff's Department became involved in the case when he could not give a reasonable explanation for his gunshot wound. The man is currently in jail in Elkhart County Indiana. He was unable to post the \$500,000 cash bond that had been set. He is awaiting further court proceedings.

Detective Captain Don Berglund retired from the Waupaca County Sheriff's Department January 3, 2003 after thirty years of service. His wealth of knowledge and experience were very beneficial to all officers over the years. We wish him the best in his retirement. I was promoted to Detective Captain to replace Berglund. Patrol Officer James Gorman was promoted to Detective Sergeant to replace my position. It will be a pleasure to have James Gorman on board working with the other fine Detective Sergeants in the division.

#### CRIME STOPPERS 2002 ANNUAL REPORT

The year 2002 was a successful year for the Waupaca County Crime Stoppers. Crime Stoppers received 30 anonymous tips, which led to at least 7 crimes being solved and numerous arrests.

Crime Stoppers paid in excess of \$1,675.00 in cash rewards to anonymous callers.

This year also implemented was a new program set up by Waupaca County Data Processing used in keeping track of Crime Stoppers Statistics. This program aids in keeping statistics compiled daily and can be presented at monthly meetings.

#### PATROL DIVISION 2002 ANNUAL REPORT

Again the Patrol Division has demonstrated that they are the true heart and sole of this Department. Our Officers have written 2,206 citations, handled 7,780 complaints, handled 1,815 accidents and reduced the amount of fatal accidents by 5 people.

We applied for Traffic Grants through the Department of Transportation. The Grants that we received monies for came from the following:

- <u>Click-It</u> program, which encouraged education and usage of safety belts
- <u>US 10 Corridor</u> program, aggressive enforcement of traffic laws on US 10 from Portage to Outagamie County lines
- Alcohol Enforcement program, aggressive enforcement for the Impaired Drivers
- Speed Waves program, target problem traffic areas within the county for aggressive traffic enforcement

As a direct result of traffic enforcement, Waupaca County has received \$61,083.99 for Jail Assessment, \$90,992.33 for Traffic Fines, \$59,528.73 for Drivers Improvement Program and \$61,801 for Court Cost, for a total of \$273,406.05.

The Patrol Division has been tasked with vast increase in the amount of violent complaints and accidents throughout the years. Even though these numbers have increased, the number of our personnel has remained the same. With the safety of the citizens of Waupaca County in mind, I will respectfully request the Sheriff to consider and work with the County Board to increase the amount of Patrol Officers. Along with this, I believe it is time for us to look at 24-hour supervision of these officers with Patrol Sergeants. At this point, we do not have 24- hour coverage. It has been 20 plus years since there has been a new position created for Patrol Sergeant.

#### FIREARMS TRAINING/ARMORY 2002 ANNUAL REPORT

We now carry Walther Model P99QA .40 caliber pistols for duty pistols and they continue to serve us well.

We have also added a .223 caliber tactical rifle to each of our squads. These rifles were purchased through a federal forfeiture in conjunction with our focal drug unit and we appreciate the administration directing some of those funds for this project.

Officer Peter Bosquez attended the tactical rifle instructor course and is now certified through Training and Standards to instruct in that area.

Officers Scott Lewis and Mark Goerlinger both attend an armors school in Minnesota for our tactical rifles and are now able to maintain and repair them.

We continue to enjoy our new armory and all the equipment that goes with it in our new facility.

The department is also in the process of implementing a less lethal program. Officer Rob Karski has been placed in charge to see that the necessary policies are put in place and the officers get the necessary training in its use.

The Wisconsin Training and Standards Bureau in an effort to improve firearms training as of January 2003 will commence (voluntarily) a new firearms program. The new training program will significantly improve officers' combat shooting and their ability to survive deadly force encounters.

Our department has elected to participate in the new program. There have been a few changes in the grip of the pistol, stance and most of all the evaluation for 100% accountability (100% accuracy) in training.

All of our instructors continue to maintain their certification with Training and Standard and provide the necessary training for our officers

#### EMERGENCY RESPONSE UNIT 2002 ANNUAL REPORT

The Waupaca County Emergency Response Unit was called out on three occasions in 2002. Two of the call outs were high-risk search warrants where weapon usage was likely and the other was a suicidal subject with a weapon. The two search warrants were resolved without incident, suspects were secured and turned over to Investigators for questioning. The suicidal subject spoke with our negotiator and gave up peacefully, he was subsequently transported for a mental evaluation.

Officer Mike Krueger of the Clintonville Police Department resigned his position on the team due to personal reasons.

Officer Gene Meyer a veteran of Clintonville Police Department replaced Officer Krueger.

Training was held once a month, which consisted of Firearms, Defense and Arrest Tactics, Law Enforcement and Dynamic room entries.

#### WATER PATROL 2002 ANNUAL REPORT

In 2002 the eleven officers of the Waupaca County Water Patrol experienced a successful season on the counties waterways. The patrolmen began a very busy season with patrol duties on April 6<sup>th</sup> on the Wolf River, with the Chain-O-Lakes activity beginning its busy summer season on May 24<sup>th</sup>. The Wolf River along with its adjoining waters such as the Colic and Jenny sloughs, Partridge and Partridge Crop Lakes and Cut Off along with the Chain-O-Lakes received the majority of the patrol. There was also patrol action on other area waters such as Bear Lake, Stratton Lake, Spencer Lake, White Lake, Weyauwega Mill Pond and the Little Wolf River.

The officers observed a significant increase in usage of the counties waters by recreational boaters, jet skiers, fishermen, tubers and swimmers. Officers responded to an injury sustained by a tuber on the Little Wolf River and also another report of a missing tuber on the Little Wolf which included an extensive search by law enforcement and the Mukwa Fire Department for the subject who was located the next day at his residence. Officers also investigated seven boating accidents which resulted in several injuries of which one was life threatening. The estimated total loss in property damage in these accidents was in excess of \$50,000.00.

Officers issued a total of 179 citations for a wide variety of violations. The violations experiencing the greatest increase of arrests were for operating while intoxicated, speeding in slow no wake zones and failure to provide personal flotation devices. Of the 179 citations issued 107 were issued on the Wolf River and adjoining waters with the other 72 citations coming mainly from the Chain-O-Lakes. Although a couple cases remain unresolved at this time, there has been a total of \$19,891.10 of forfeitures administered by the court.

The patrol was hampered in mid summer when the Alumacraft patrol boat stationed at New London was taken out of operation because of a rotted transom which a local marina found to be unsafe for use. Because of the age of the unit and prohibitive costs in repair it, the unit is in the process of being replaced. With continuous population growth in the Fox Valley area, coupled with the publics desire for recreation and larger and faster boats, it is expected that the area will continue to see increased needs for effective enforcement and protection.

#### D.A.A.T. & EVOC 2002 ANNUAL REPORT

In 2002, Deputy Clint Thobaben and myself trained the Department in Baton update, which included, going over the way the baton is carried, drawn, and the different strikes used with the baton. All Officers had the opportunity to watch instruction on these areas from the instructors and then were able to practice the techniques on training pads. This instruction was in February of 2002 and took place in the training room at the Sheriff's Office.

I also trained and certified several new Reserve Deputies in the use of Oleoresin Capsicum, (OC). These Officers were trained in the use of OC along with the way to carry and spray the unit. These Officers were also exposed to OC by spraying them in the face and then they had to work through a scenario before being decontaminated. This training was done in April of 2002 at the Manawa City Hall.

In December of 2002, I trained the Clintonville Police Department in the Emergency Vehicle Operation Course, (EVOC). The course involved an Evasive maneuver course, an Evasive braking maneuver, a serpentine course, a comprehensive course and straight line backing. This training was done at the Clintonville Municipal Airport.

#### NEIGHBORHOOD WATCH PROGRAM 2002 ANNUAL REPORT

The Neighborhood Watch Program is a Crime Prevention Program that has been operating in Waupaca County for the past six years. This is an organization of committed citizens who work together in an effort to deter crime in their neighborhoods. These residents are the main participants in the program with the assistance from the liaison officer of the Sheriff's Department. Once the citizens are interested in organizing a neighborhood watch group, they contact the Sheriff's Department's liaison officer and set up a meeting.

In 2002, the Neighborhood Watch Program continued its growth. In the fall of 2002 a Neighborhood Watch Program started up in the Township of Caledonia along the roads of Wieland Road and Robe Road. This watch group was assisted greatly by the Rawhide Boys Ranch taking a leadership role with this group. With the addition of this Neighborhood Watch group, we would have approximately 2000 citizens throughout the county participating in this crime prevention program.

The Neighborhood Watch Program has accomplished adding additional crime prevention resource throughout Waupaca County. The continued success of this program will ensure the citizens commitment to assisting law enforcement personnel in their own neighborhoods.

#### JOB SHADOWING PROGRAM 2002 ANNUAL REPORT

#### WAUPACA COUNTY DEPUTY ASSOCIATION 2002 ANNUAL REPORT



#### **Annual Report for 2002**

We have assisted with death notifications and the families of accident victims on more than 6 occasions, and assisted officers and emergency personnel with counseling, care and communications with family members who often feel confused and lost during these tragic crises. The assistance with death notifications continue to be one of the most appreciated uses of the Chaplaincy Unit as it frees up officers to continue with their duties while the Chaplains give family members much needed attention and direction.

The Chaplains again hosted a Memorial Service for all Waupaca County law enforcement officers in May of 2002 at the Rawhide Boys' Ranch with great assistance from the New London Police Department.



We continue to remain ready to serve at all times, and deeply appreciate the growing relationship we have come to experience with the Sheriff's Office.


