



# **COMMUNICATIONS CENTER**



The Communications Center is staffed twenty-four hours a day, 365 days per year with highly dedicated, trained professionals known as Telecommunication Officers. The Communications Center is staffed with 13 Telecommunication Officers, 1 Communications Sergeant, and 1 Communications Captain. These professionals are the vital link between the citizens, emergent and non-emergent agencies and services within Waupaca County. The Telecommunication

Officers continually monitor and respond to over 12 radio channels as well as 911 landlines, 911 cell lines, and administration non-emergent calls.


The critical information the Telecommunication Officers receive must be assessed and then disseminated to appropriate emergent or non-emergent responders. The data is vital for the responders as they evaluate the risks and determine the proper response method for each incident. A Telecommunication Officer handles numerous telephone calls for service each day; and answer more than 99% of all phone calls, including 911 and instances of receiving multiple calls simultaneously, in less than 4 seconds. The State of Wisconsin recommended average answering time is 10 seconds.







The Waupaca County Sheriff's Office has opened our new 911 center. The new facility offers more room for state of the art technology, enhanced security systems, ergonomic dispatch consoles, a system to provide clean, fresh air, as well as internal employee break rooms and restrooms.



## **PATROL DIVISION**




The Patrol Division is the most visible and available division of the Waupaca County Sheriff's Office. The division includes 21 Patrol Deputies, 4 Transport Deputies, 30 Part-Time Deputies, 6 Patrol Sergeants, 1 Patrol Lieutenant, and 1 Patrol Captain. Together, they provide law enforcement services 24 hours a day, 365 days a year for all municipalities that do not have a law enforcement agency and assist the agencies that provide law enforcement coverage. These services cover approximately 765 square miles, including 2,085 miles of state, county, and municipal roadways, 240 lakes, and 79 rivers and streams.

Waupaca County consists of 22 townships, 6 cities, and 6 villages. The population of the County is approximately 52,410.

The Patrol Division is responsible for enforcing state and local laws and handling many different types of calls for service. In addition to their regular duties, many of our deputies have taken on additional responsibilities requiring specialized training. These include:

# PATROL DIVISION



Waupaca County is divided into 3 law enforcement sectors as illustrated above. One deputy is assigned to each of the sectors every shift. Any extra deputies we have working help cover areas of the county that are busy.

#### ATV / UTV Patrol


ATV/UTV patrol had 44.5 hours of patrol, including patrol on roadways and lakes for fisheries within Waupaca County. ATV/UTV patrol issued 14 citations in total, 3 OWI related citations were issued as well as several citations issued for operating on closed roadways for UTV / ATV operation. Waupaca County Sheriff's Office responded and investigated 3 UTV / ATV crashes which either involved operating while intoxicated or injury incidents.

#### **Snowmobile Patrol**

Snowmobile patrol issued 2 citations and 2 written warnings for the season. Citations were issued for nonregistration and no trail pass, written warnings were issued for no trail pass and fail to comply with regulatory signs. The snowmobile patrol season was very short with some zones not able to open the trails at all. As a result of this, patrol concentrated their efforts in the northern part of the county.

#### Water Patrol

Water patrol concentrates mainly on the Wolf River and Chain O' Lakes. The patrol hours for the season were 1596 hours. Water patrol issued a total of 102 citations and 108 written warnings for the season. Majority of citations were issued for Navigational Rules, 13 citations were issued for OWI related offenses. Water patrol assisted 24 vessels and 27 person(s) in need of assistance.



### HONOR GUARD



The Waupaca County Sheriff's Office Honor Guard is comprised of 7 deputies who are dedicated to representing the agency at police memorial services, funeral services, parades and processions, and posting colors for special events. The unit trains throughout the year to prepare and provide our best service to honor those who have fallen to protect our community, state, and nation.

In 2022, the Honor Guard participated in law enforcement memorial ceremonies locally and statewide and events throughout Waupaca County. The Sheriff's Office Honor Guard belongs to the Wisconsin Honor Guard Association, which coordinates providing honors to the officers who die in the line of duty in Wisconsin.

The Honor Guard annually attends the Wisconsin Law Enforcement Memorial service in Madison, which honors Wisconsin Officers killed in the line of duty. The Wisconsin Law Enforcement Memorial contains the names of 289 law enforcement officers who have died in the line of duty in the history of the State of Wisconsin.

241 officers were killed in the line of duty in the United States in 2022.

### K9 Unit



Deputy Barden and K9 Nova, partners since 2019 Nova assisted another deputy on a suspicious vehicle complaint at a storage unit. After performing a free air sniff of the vehicle and an alert from Nova, multiple different narcotics were located along with a concealed knife and felon in possession of a firearm.

Nova enjoyed meeting people while participating in K9 Demos, Meet the Fleet and the K9 golf outing. Nova always perked up and was in the best mood when she would see how she was able to make the kids happy.


Deputy LaBrosse and K9 Dom, partners since 2019 K9 Dom and his handler responded to a facility where two juveniles ran away. A track was conducted and K9 Dom located the two juveniles unharmed over half a mile away.


Deputy Santiago and K9 Cuda, partners since 2017 Waupaca County Deputies were attempting to locate a male subject who was currently on Probation, with multiple arrest warrants, a history of fleeing from law enforcement, and pending criminal charges (10 Felony and 9 Misdemeanor) for prior violations of Wisconsin State Statute. Deputies were able to locate the subject inside an apartment.

Cuda was deployed (on leash) and the subject was located sleeping on the floor in a dark low light environment. The subject was woken up by the barking of Cuda, flashlights, and red Taser target acquisition lights. The subject was subsequently taken into custody without incident and transported to the Waupaca County Jail.

Waupaca County Deputies were dispatched to a Domestic Incident call for service to locate a male subject who was possibly armed with a handgun, was making homicidal comments, and had held a victim at knifepoint. Cuda was deployed to assist in clearing the residence and to locate the suspect. Cuda was then deployed on a track. Cuda tracked and located the suspect near a woods line where the suspect began fleeing on foot into an open field. Cuda and handler engaged in a brief foot pursuit, when the suspect made visual confirmation of Cuda the suspect stopped running and was taken into custody without incident and transported to the Waupaca County Jail.

## **Transport Unit**

The 2022 Transport Unit consisted of four deputies. The transport unit provides a critical link between the patrol division and corrections, courts, medical professionals, mental health professionals, and individuals involved in the court and mental health process.



Deputies in the Transport Unit complete several primary duties, including:

- Transport prisoners to and from county jails, state prisons, juvenile detention centers, and hospitals for court appearances, medical appointments, sentences, and warrant arrests.
- Serve civil process including small claims, civil suits, evictions, Sheriff sales postings, replevins, injunctions, and restraining orders.
- Security of the courthouse including jail inmate escorts to court appearances, courtroom security when needed for court proceedings, periodic courthouse entry point screening.
- Serve criminal arrest warrants
- Assist with other Patrol Division functions

In 2022, the Waupaca County Circuit Court system returned to normal operations. Transports to and from court appearances increased from 2021. The Sheriff's Office and the courts continued to use remote appearances when feasible. Despite the advancements of technology making video appearances an option, remote appearances do not replace many personal appearances which will always be part of our judicial system as a constitutional right, such as trials, preliminary hearings, sentencing, and emergency detention hearings.

# SWAT

The primary goal of this team is to contain, control, and resolve situations as effectively and efficiently as possible while protecting life and minimizing the risk of injuries to all persons involved.

In 2022 the Waupaca County Swat Team was deployed for two separate situations. One situation involved a violent barricaded subject; the other was to execute a drug search warrant.






The team comprises 20 Tactical Operators and 4 Negotiators, along with the Commander and Deputy Commander. The team is multi-jurisdictional and includes members from the Sheriff's Office and officers from various agencies within Waupaca County.

The Waupaca County Swat Team possess state of the art equipment, including a Command Post, Armored Vehicle, Equipment Vehicle, various entry tools, and weapon delivery systems.

# WAUPACA COUNTY CRISIS NEGOTIATIONS



The Waupaca County Sheriff's Office has four trained Crisis Negotiators. All four Crisis Negotiators have attended training provided by the Federal Bureau of Investigation (FBI) – Milwaukee Division. Patrol Sergeant Josh Krueger is responsible for coordinating trainings and/or conferences with the WICNA – Wisconsin Crisis Negotiator Association with the other three negotiators who are Telecommunication Deputy Kirk Merrill, Patrol Deputy Sara Besel, and Waupaca PD Officer Paul Jensen who used to be a Communications Sergeant with the Sheriff's Office until late 2021. In November of 2021, Communications Division Sergeant Paul Jensen accepted a position as a patrol officer with the City of Waupaca Police Department. He still remains a part of the Crisis Negotiating Team.

In 2022, the Waupaca County Sheriff's Office responded to 114 Mental Health calls, down from 125 in 2021 and 476 Welfare Check calls, down from 563 in 2021, many of which end up being a person in mental health crisis. While these don't turn into a call out for every mental health call, Waupaca County Crisis Negotiators are able to utilize their communication skills several times a week to find a peaceful resolution and get people who are in crisis the help that they need.

# FIELD TRAINING OFFICER PROGRAM


The Waupaca County Sheriff's Office Field Training and Evaluation Program is modeled after the San Jose, CA model. The San Jose model is recognized in the Law Enforcement profession as the leader in the area of field training. Waupaca County's current field training manual has been built through the input of Sergeant Gene Goode (retired), Sergeant Scott Lewis (retired), Sergeant Bill Zeamer, and Deputy David Huberty (retired). The field training program consists of five phases. The new officer will go through a 14 week training program to strengthen their skills that they learned during their time in college followed by the academy.


Waupaca County Field Training Officers are chosen after Deputies submit a letter of interest for the position. By this method, Waupaca County Sheriff's Office gain Deputies that have a genuine



The Waupaca County Sheriff's Office have five deputies who started in the year 2022. All five have successfully completed the Field Training Program. They are;




## **DETECTIVE DIVISION**



The Waupaca County Sheriff's Office Detective Division comprises 1 Property manager & Evidence Technician, 2 Narcotics Detectives, 6 Detective Sergeants and 1 Captain.

The Detective Division is focused on advocating for victims while conducting fair, transparent, and impartial investigations.

The Detective Division is primarily responsible for investigative follow-up, evidence collection, crime scene analysis, and proactive investigative efforts on many different crimes, which generally require more time or resources. These crimes include sex crimes, child neglect and abuse, death investigations, property crimes, computer crimes, and significant traffic crash investigations. The detective division works in cooperation with other local, state, or federal agencies.



## Internet Crimes Against Children (ICAC) and Digital Forensics



The Waupaca County Sheriff's Office collaborates and is a participating member of the Wisconsin Internet Crimes Against Children (ICAC) Task Force lead by the Wisconsin Department of Justice-Division of Criminal Investigation.

In 2022, we received 13 case referrals, called "Cybertips", from the Wisconsin Department of Justice, involving suspected child enticement and child pornography activity within Waupaca County. Cases are received through the National Center for Missing and Exploited Children (NCMEC), the U.S. Department of Homeland Security, and disseminated through the Wisconsin DOJ ICAC online portal. 4 arrests were made as a result of the Cybertips.

Electronic devices, including mobile phones, tablets, and computers, carry increasingly more evidence related to criminal activity. Most everyone possesses mobile devices that are constantly recording data such as location, activity, biometrics, messaging and call logs, internet history, and much more. This information proves to be invaluable during criminal investigations as criminals utilize these devices while committing crimes.

The Waupaca County Sheriff's Office Digital Forensics Lab can process these devices utilizing tools such as Cellebrite Mobile Forensics and forensic programs such as Griffeye Analytics and Axiom by Magnet Forensics. With these tools, we can rapidly analyze digital evidence in-house to keep the investigation on track and conclude promptly. Devices are analyzed within hours versus months when using the Wisconsin Department of Justice Digital Forensics Unit.

The Waupaca County Sheriff's Office continues to be a leader in Digital Forensics by keeping up to date with changing technology, continued advanced training, and maintaining compliance with the Wisconsin Department of Justice Standards.

In 2022, the Waupaca County Sheriff's Office Digital Forensics Unit analyzed approximately 61 mobile phones and processed over 15.4 terabyte of data from hard disk drives, USB drives, cloud storage, and mobile devices. Evidence from this data provided information resulting in the successful outcome of numerous cases referred to the Waupaca County District Attorney's Office.

# **Narcotics Division**

The Waupaca County Narcotics Division is an active member of the Central Wisconsin Drug Task Force (CWDTF), which includes 15 law enforcement agencies within 8 counties. The CWDTF is funded largely through grants provided by the Federal Government, administered by the State of Wisconsin. These grants reimburse member agencies for manpower and other expenses involved in combating illicit drug activity. The Waupaca County Narcotics Division has 2 Detectives assigned to the CWDTF on a full-time basis.



## **DIVE TEAM**

The Waupaca County Dive Team comprises 13 team members ranging from Patrol Officers, Telecommunication Officers, Correctional Officers, and Detective Sergeants. The primary goal of this team is to respond to any waterway within Waupaca County where there is a need for a water recovery, search, or rescue.




During 2022, if the Dive Team was operational, we would have received three deployments for three separate incidents.

- Suicidal mental subject threatening to swim under ice
- Search of a missing person
- Drowning

## **DIVE TEAM**

In 2022, the Dive Team raised their goal of \$75,000 for startup funds. Throughout the year of purchasing necessary equipment, the team found that \$75,000 was a close estimate but due to inflation and higher costs, additional funds were needed to purchase everything necessary. Four divers received certification through PADI (Professional Association of Diving Instructors) in Open Water, Advanced Water, Rescue Diver, and Public Safety Diver. Obtaining these certifications is a difficult task and is very costly averaging approximately \$1,500 per diver.







## Shop with a Cop

The seventh annual Shop with a Cop was completed on Thursday, December 6, 2022. Forty children participated in the event. The children met at the Waupaca Rec Center.



They were paired up with an officer. Pictures were taken with the child and officer. Everyone was bused to Waupaca Fleet Farm by Riteway bus line.



The officers and children roamed the aisles at Fleet Farm searching for gifts. Each child was given \$200 to spend. Each family also received \$100 gift certificate from their local grocery store. More photos were taken at Fleet Farm during and after purchases were complete. Everyone was bused back to the Waupaca Rec Center.

Volunteers were waiting to wrap the children's gifts. Pizza and dessert was waiting for the children and officers when they arrived.

Forty children participated in Shop with a Cop Program. Over \$12,000 was raised for the 2022 program. \$10,500 was spent on gifts and gift cards.



# **Crime Stoppers**

The Waupaca County Crime Stoppers program is a way for someone to report a crime while remaining anonymous. A person is eligible for a cash reward if their "tip" results in an arrest/citation. Crime Stoppers also offers the "quick \$50" program. This program is designed for school kids and encourages students to report crimes within the schools. A student can receive \$50.00 for providing information



resulting in an arrest/citation. In 2020, There were 48 total tips (see chart). There was no money given out for "tips".

Crime Stoppers transitioned into a new program through Motorola. Currently, every Telecommunicator, Narcotics Officer, Patrol Sergeant, and Detective Sergeant have access to the program.

## Law Enforcement Support Program Or 1033 Program

Waupaca County participates in the Federal Excess Property Management Information System also known as the LESO 1033 Program. The U.S. Department of Defense 1033 Program permits the Secretary of Defense to transfer excess Department of Defense supplies and equipment to state and local law enforcement agencies for use in our law enforcement duties.

Created as part of the 1997 National Defense Authorization Act, the 1033 Program allows the Department of Defense to get rid of excess equipment by passing it off to local authorities; we only have to pay for the cost of shipping and maintaining the equipment we acquire.



In 2022 the Sheriff's Office did not acquire any additional items from the 1033 program. Although we did not acquire any additional items we still hold and maintain several items to include the SWAT team's MRAP Vehicle and several weapon accessories. These items are invaluable to the department and would have a large impact on annual budgets if not for the program.

The Sheriff's Office has had the opportunity to participate in the 1033 program for several years. The program is continually monitored by the Sheriff's Office in an attempt to locate and secure equipment to assist in serving the citizens of Waupaca County as all items available are on a first come first serve basis.



The Corrections Division is a critical component in the Criminal Justice System. The Waupaca County Jail is a correctional facility operated by the Sheriff, in accordance with the Constitutions of the State of Wisconsin and the United States of America. Accordingly, the jail will meet or exceed standards established by the Wisconsin Department of Corrections, federal, state and local law. The division includes 38 Correctional Deputies, 6 Correctional Sergeants, a Lieutenant, and a Captain.



In 2001, Waupaca County saw the opening of its new facility at 1402 East Royalton Street. The jail can house 321 inmates. Currently its average daily population is approximately 200 inmates.

The jail is responsible for the care and custody of prisoners. It also functions as a holding facility for convicted felons awaiting transfer to the Wisconsin State Prison System, sentenced prisoners, and prisoners awaiting trial.

Our facility holds a contract with Wood County to house 75 safe-keepers a day and Portage County to house 35 safe-keepers a day.

The County Jail is a busy and active facility. Numerous programs are offered to inmates. Our goal is to help the prisoners incarcerated.



There are several programming opportunities provided and offered to inmates confined at the facility. All volunteers complete safety and security training to introduce them to the correctional environment and are subject to a criminal background check. Programs have been continually increasing due to the commitment of Jail Administration and support of the County and Community philosophy allocating supporting resources.

Programs offered include the following:

- FVTC provides GED education
- FVTC provides GOAL
- Religion: 7 days per week both services and bible study
- AA/NA
- Volunteers are used throughout the facilities as needed for occasional programming needs
- AODA is being provided by DHS
- Local Library- There is a good working relationship with the local library
- Volunteers continue to bring books in approximately three times per year





In order to provide safe and professional services to our inmates, deputies train yearly in many specialized areas. These include:







# **RECORDS DIVISION**

The records division consists of 3 full-time civilian employees. Included in this count are two Records Specialists, and one Records Supervisor/Administrative Assistant. These staff members play a vital role within the Sheriff's Office and are an essential part of every division.

Duties include but are not limited to: reception duties, answering request phone calls, type reports and documents for deputies, managing sheriff sales, background checks, processing all criminal charges, preparing records and legal documents, extracting data from the RMS system, performing duties of Incident-based reports, receiving and preparing all documents related to civil process, processing discovery material for the Waupaca County District Attorney, serving as a notary republic, and also processing some DMV transactions.






