Waupaca County Ordinance 52.06 (C) (1). "LICENSE ISSUANCE: The Sanitarian shall issue a license to the applicant only after compliance with the requirements of this chapter and upon payment to the department of all required fees. The Department's decision to grant or withhold a license shall not exceed 30 calendar days. The decision to withhold shall accompany written inspection or documentation of justification or cause."

Waupaca County Code of Ordinance 52.9 "VIOLATION-PENALTIES: Any person who violates this ordinance may be fined not less than \$100.00, nor more than \$1,000.00. Any person who fails to comply with an order of the Department under this ordinance, shall forfeit \$50.00 for each day of noncompliance after the order is served upon or directed to him/her per sec. 254.59 and 97.41, Wis. Stats."
