

Splash Station Construction Wraps Up As Heartland Park Gets Underway



Several of the young members of the Wildcats who are looking forward to playing on the new athletic fields at Heartland Park took part in the official groundbreaking ceremony on January 11.



By the end of January, the finishing touches were being added to Wentzville's new, state-of-the-art aquatic center, Splash Station.



This year promises to be an exciting time for parks development in Wentzville with the opening of the City's new 62,600-square-foot aquatic center, Splash Station, and construction beginning on the City's next new park—Heartland Park.

In January of this year, the final touches were being put on Splash Station, readying it for its May 15 Open House and the Opening activities scheduled for May 22 and 23. More information about everything planned for the Grand Opening of Splash Station will be in the May/June *Vision* newsletter, and posted in the Parks and Recreation section of the City's website at www.wentzvillemo.org.

Located on Peine Road, adjacent to Peine Ridge Elementary, Splash Station will offer water features like a 400-foot lazy river with tubes for people to float, a 90-foot-long and 24-foot-tall fiberglass water flume with plunge pool, and a 35-foot by 40-foot diving pool with a 3-meter diving platform. Other amenities will be a recreation pool featuring a zero-depth beach entry and shade umbrellas over portions of it, 60-foot lap lanes, water basketball, a therapy seat, water benches, and more.

On January 11, the City celebrated the groundbreaking of Heartland Park, which is located behind Dierbergs, just off Wentzville Parkway. The opening of Heartland Park is expected by late this year, or early 2015. When it opens, Heartland Park will provide residents trails, a lake, and two synthetic-turf fields for playing football, soccer or lacrosse.

For its construction of Heartland Park, Wentzville was awarded a 319 Grant to support nonpoint source pollution prevention projects, including \$477,000 towards construction of green infrastructure at Heartland Park. Funding comes from US EPA Region 7 through the Missouri Department of Natural Resources under the Clean Water Act. Features such as rain gardens, a lake forebay, wetlands, and pervious pavements help remove contaminants such as trash, oil, and chemicals on parking lots from rain water runoff before it flows into Crossroads Creek. The City matched \$500,000 for construction costs at the park for the grant.

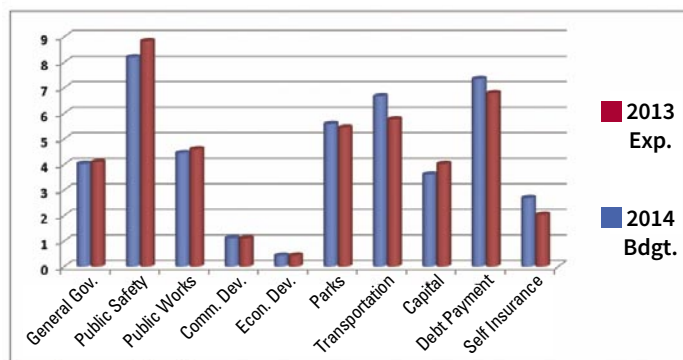

2014 Budget Continues Conservative Approach With Reduced Spending

The City of Wentzville operates on a January 1 through December 31 budget year. In late December of 2013, the Board of Aldermen gave final approval to the City's 2014 Budget of just over \$56.53 million in total City expenditures, which is about one percent less than what year-end estimates were for the City's 2013 total expenses.

Revenue projections for 2014 are a little over \$57.19 million, which reflects a four-percent increase over the City's 2013 estimated revenue totals. The projected one-percent drop in budgeted expenditures despite a predicted four-percent increase in revenue is typical of the conservative fiscal approach the City has followed for years, and one of the reasons the City has been able to maintain an Aa2 bond rat-

ing by recognized bond rating services.

Revenue

The 2013 reassessments dropped assessed property values in Wentzville by three percent. Property tax for 2014 is anticipated to remain flat. The good news last year was a 10-percent increase in the City's sales tax collected. While the 2014

Robert Bartolotta Hired as New City Administrator

At their January 22 Board of Aldermen meeting, Wentzville's Board members reviewed and approved a contract agreement to appoint Robert Bartolotta as the City's new City Administrator. Wentzville has been without a City Administrator since the unexpected passing of T. Michael McDowell in August of 2013.



Bartolotta holds a Master's Degree in Public Administration and his experience includes 35 years in municipal management—cutting across four states and multiple suburban areas. He says he manages with a focus on customer service, continuous improvement, planning, and employee development. Under his contract agreement with the City, Bartolotta will assume his City Administrator duties in late February, and be paid an annual salary of \$130,000. The City will also provide Bartolotta an automobile for his use.

Of his upcoming move to Wentzville, Bartolotta said, "We are looking forward to living and working in Wentzville and becoming active in community programs." Bartolotta said his wife, who is a social worker, is active in dog rescue and takes classes in agility with their three family dogs. She is hoping to continue the sport in the Wentzville area and is quite excited about living fairly close to the Purina Farms at Grey Summit.

Bartolotta grew up in St. Louis County and still has family members living in the area. In addition to family in St. Louis, Bartolotta said he and his wife have five grandchildren and three grown children—a son in North Carolina, a daughter in Georgia, and a son in Arizona.

increase in sales tax collected is expected to be a more modest three-percent, the City still expects an increase in this important revenue source in 2014.

The increased production volume at the

General Motors Assembly Plant and more new homes coming to Wentzville are expected to result in increased revenue in 2014 for Charges for Services. Charges for Services include the City's charges for water, sewer, and trash, as well as for park programs and facility fees.

Intergovernmental revenue is primarily grant funding, and varies greatly each year depending on the number of large road projects or other grant-related projects scheduled. There was not much change in the capital projects total in 2014 from the total in 2013.

Expenditures

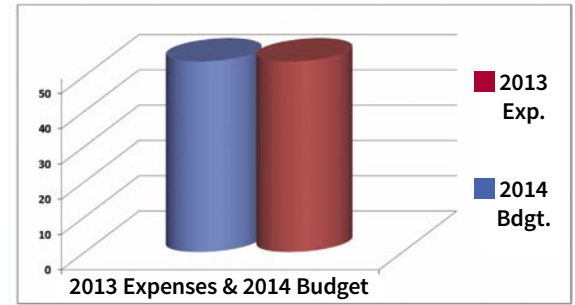
Total City expenditures budgeted for 2014 are one percent lower than what year-end estimates were for expenditures in 2013. The reduction, in large part, is due to fewer large capital projects budgeted in 2014.

The 2014 Budget does reflect increases in personnel, other charges and services, repairs and maintenance, and contract services. Additional personnel in the Police, Public Works, Community Development, and Finance departments accounted for some of the increased personnel costs. Some of the potential cost increases were offset, however, by a change in the medical insurance plan for City employees. The new plan changes employee contribution for family coverage from \$10 per month to \$132.20 per month.

An increase in the area of Repairs and Maintenance is due primarily to increased road maintenance planned for FY 2014. Approximately \$2 million is planned this year for concrete replacement and asphalt overlays.

The amount the City plans to spend in 2014 for Contract Services is also up \$87,090 over the budgeted amount for 2013. The category for Contract Services in 2014 includes \$1.3 million for the City's share of a Mo-DOT project constructing the new Peine Road and Hwy P interchange, lifeguard positions at both Progress Park and Splash Station, and all mowing, with the exception of ball fields.

2013 City-Utility-Tax Refunds Available to Eligible Residents



From April 1 through May 30, eligible residents can apply for a City-utility-tax refund. The refund amount is according to what was listed as "City Tax" on the resident's electric, gas and phone bills during 2013.

To be eligible for the refund, individuals need to either rent or own their primary residence in the City of Wentzville, be at least 65 years old or considered totally disabled by Social Security, and had a maximum 2013 gross income of \$39,450 for single-person households and \$45,050 for married-couple households. Refunds are only available for the months when the resident lived in Wentzville and was at least 65 years old or considered totally disabled.

Residents can apply for the refund at City Hall, located at 310 West Pearce Boulevard. When applying for the refund, residents will need proof of residency (such as a current utility bill), income, age and/or disability, and copies of their gas, electric and primary phone bills for the months they were eligible. Also, to comply with Missouri's section 208.009 that prohibits a local public benefit being distributed to illegal aliens, residents will be required to present one of the following: a driver's license, Social Security card, or birth certificate.

April 8 Municipal Candidates

All eligible City residents are encouraged to vote and make their choices known in the April 8, 2014, election. Residents who have not yet registered to vote have until March 12 to register. Voter registration forms are available at all Missouri State offices that provide public assistance, any City Hall, public library, public school, vehicle registration office, St. Charles Community College, or at the St. Charles County Election Authority's Office, which is located at 397 Turner Boulevard in St. Peters.

MAYOR'S COMMENT: 2014 State of the City

I'm happy to say the state of our City is good and our future is bright. In large part, this enviable state is due to the City's long history of taking a conservative fiscal approach, while at the same time positioning our City for future development.

Our City is financially sound. We still maintain an Aa2 bond rating, and at the end of 2013, the Board of Aldermen approved a balanced budget of \$56,539,388 for 2014—one percent less than our estimated expenses in 2013. Although property assessment values dropped 3 percent in 2013, we saw a 10-percent-sales-tax increase last year, and we expect to see a 3-percent increase this year. We also expect an increase in our utility revenue in 2014, due to continued residential growth and the expansion at the General Motors Wentzville Assembly Plant.

Wentzville continues to see residential and commercial growth. In 2013 we issued 538 permits for new housing units, which is the highest number of new housing starts we've seen since 2007. In 2000 our population was only 6,896, but by late 2013, our estimated population had risen to 32,500, and we expect our population to top 44,000 by 2020.

In 2013 we saw 35 million construction dollars invested in our City, which is the highest amount we've experienced since 2008. Last year we issued 627 business licenses, 48 of which were for new businesses. This new commercial development has brought hundreds of new jobs to Wentzville, and more are expected this year.

Even through a brutal recession, our **infrastructure has kept up with growth.** Two community-development projects completed in 2013 were the Church Street improvements, and the scheduled expansion of our Wastewater Treatment Plant, which will make it possible for us to stay ahead of our population growth. In 2013 we also invested \$1.2 million in slab replacement on our roads, implemented an

Board Endorses Pilot Program to Reduce Speeding in Neighborhoods

At press time for the March/April *Vision* newsletter, the Board of Aldermen, with the support of the Mayor, was giving final passage to an ordinance crafting a pilot program to address drivers speeding through our neighborhoods. The "Increased Safety Area" initiative calls for double fines for speeding in certain subdivisions.

The initial streets selected for the pilot project are:

- Bear Creek (Bear Creek Drive)
- Woodlands at Bear Creek (Rocky Mound Drive only)
- Villages at Stone Gate (Stone Run Boulevard only)
- Great Oaks (all streets in Great Oaks)

Wentzville's Police Chief Lisa Harrison said, "The goal of the program is to increase the safety of the residents in these neighborhoods through the promotion of safer driving habits. Both the motoring and pedestrian public will benefit from these increased safety zones."

Chief Harrison said that signage is being installed in all the affected neighborhoods. After the Board of Aldermen gives final passage to the measure, there will be a 45-day educational period for all areas. Chief Harrison explained the educational period is designed to give all drivers notice of the double-fine zones for speeding.

The request for increased traffic safety zones originated with residents of the neighborhoods selected for the pilot program. The pilot program is scheduled for one year, after which the Wentzville Police Department will evaluate the effectiveness of the program.

If residents would like their neighborhood streets to be included in the Increased Safety Area initiative, they should contact their representatives on the Board of Aldermen.

online payment process for utility bills and court fines, and implemented body cameras for all our police officers. Steady growth and maintaining adequate fund balances have made it possible for us to continue community-development projects at a time when other cities are struggling to maintain status-quo.

We've also continued adding recreational amenities. As we move into 2014, we're putting the finishing touches on our new, state-of-the-art aquatic center, Splash Station. On May 15 we'll hold an Open House to show off this 62,000-square-foot aquatic center, with the Grand Opening scheduled for May 23. On Jan 11 of this year we celebrated the ground breaking of our next new park, Heartland Park. We expect Heartland Park to open for use by late 2014 or early 2015. When it opens, Heartland Park will provide residents trails, a lake, and two synthetic-turf fields for playing football, soccer or lacrosse.

There are several significant projects scheduled in 2014. We've budgeted \$2 million for slab replacement and asphalt overlay this year to keep our roads up to acceptable standards. Also, by the end of July or early August, we expect to see the implementation of a new, regional radio communications system. The new system will provide interoperability of communications between police departments, fire and ambulance districts, public works, and parks departments within seven counties and the city of St. Louis. It will also hook into the state communications system. Because the new system will move our communications from analog to a digital basis, it will eliminate many of the communication challenges that currently exist.

We also expect to see the replacement of the current 911 emergency system. The new system will accept text as well as spoken calls for help, and will be better at identifying a person's location when he or she dials 911 from a cell phone.

As I said in the beginning of this article, the state of our City is good and our future is bright. I look forward to continuing to serve the residents of Wentzville throughout 2014.

Irrigation Systems Require Permits and Annual Spring Testing

Irrigation systems are a great convenience, but they come with some responsibilities. First, residents who want to install an irrigation system must obtain a permit from the City prior to installation.

Second, the State of Missouri requires everyone with an irrigation system to have the backflow devices checked each spring by a certified backflow tester to make sure the system's backflow device is working properly. This requirement even applies to systems that are not used. Debris buildup and damaged parts due to freezing can allow contamination to flow from the sprinklers back into public water lines.

Once the testing has been completed, the homeowner is responsible for making sure the results are submitted to the City, whether the inspector sends in the results or the homeowner sends them. **Test-result reports must be sent to Wentzville's Public Works Department no later than June 1 of each year. Reports received after June 1 will be assessed a \$30 per month fine and non-compliance after July 1 results in the property being scheduled for water disconnection.**

If residents wish to completely discontinue use of their irrigation system, they must have a certified plumber remove the backflow device, and that same plumber must send the City a letter verifying that the device has been removed. The discontinued irrigation system may not be re-connected without re-installation of a backflow device.

If residents have any questions about having their irrigation system checked or submitting the test results, they can call the Wentzville Water Department at (636) 327-5102.



Yard-Waste Pickup Resumes March 3

Yard-waste pickup for the City of Wentzville resumes the first full week in March and continues through the last week of December. **Cancellations are accepted this year between January 1, 2014, and February 28, 2014. Residents who have not cancelled the service and were receiving yard-waste pickup when it ended December 31, 2013, will automatically receive the service again, beginning March 1, 2014.** Residents who receive yard-waste pickup should set yard waste out on the same day they set out trash and recycling. Everything should be at the curb by 6:00 a.m. on the appropriate morning.

Residents can place their yard waste in brown recyclable bags or in a trash can. Residents can rent a yard-waste cart for \$3.00 a month, or they can use their own can. If residents use their own can, it must be clearly marked "Yard Waste" on the both sides. Residents can obtain "Yard-Waste-Only" stickers at Wentzville's Public Works Building, located at 200 E. Fourth Street.

Yard Waste includes leaves, grass clippings, or limbs and branches. Limbs and branches should not be more than 4-feet long, 18 inches in diameter, or weigh more than 40 pounds. Also, bundles should be tied with a natural twine or other bio-degradable binding material. Yard waste **DOES NOT** include dirt, sod, rock, concrete, asphalt, lumber, tree stumps or logs over 18 inches in diameter.

Property Maintenance Inspections Begin April 1

For most people, their homes are their single largest investment. To help protect Wentzville homeowners' investments and ensure property values remain stable, the City annually conducts property-maintenance inspections. All properties are inspected every two years, with one half of the City inspected one year and the other half inspected the following year. The City is vigilant with these inspections, because deteriorating exteriors of homes can lower the marketability and value of neighboring properties.

In 2014, all structures in the western half of Wentzville will be inspected, with inspections beginning April 1. The City conducts these exterior inspections based upon the 2009 International Property Maintenance Code.

The items inspected on properties are as follows:

- Address numbers
- Sidewalk/driveway deterioration
- Overgrown grass/weeds/dead trees
- Garbage, trash or rubbish in yard
- Derelict autos or parts in yard
- Porches deteriorated
- Fences deteriorated
- Masonry damaged or deteriorated
- Windows damaged or broken/screens missing or broken
- Garage or main doors deteriorated or broken
- Exterior wall surfaces deteriorated—needing paint
- Guttering damaged or missing
- Roof shingles damaged or missing
- Accessory Structures



When City inspectors find a property that needs attention, they leave a notice on the door of the property. This notice allows a reasonable time for completion.

If residents have a concern about the exterior maintenance of properties in their neighborhood, they don't have to wait for the City's biannual inspection. Residents can call the Customer Service Center at (636) 639-2121 anytime to alert the City of a problem. By remaining attentive to ensure all Wentzville properties are suitably maintained, the City works to keep Wentzville a desirable place to live and work.

Chipper Program Provides Easy Disposal of Small Tree Limbs

The City's Chipper Program provides residents a free, convenient way to dispose of small tree limbs twice a year—once in the spring and once in the fall. The 2014 Spring Chipper Program will be the week of April 21 through April 25 for residents living north of the railroad tracks. For residents living south of the railroad tracks, the Spring Chipper Program will be the week of April 28 through May 2. The Fall Chipper Program will be October 20 through October 24 for residents north of the railroad tracks, and October 27 through October 31 for the residents south of the railroad tracks.



To take advantage of this free program, residents should have their tree limbs stacked at the curb by 6:00 a.m. on Monday of the week their area is scheduled for the Chipper Program. Tree limbs must be less than eight inches in diameter and should not be bundled or placed in bags. The 2014 Chipper Program collection **does not include leaves, root balls, shrub and hedge trimmings, decorative grasses, or grass.**
