Seconded by Chairman McCarthy. The Board by roll call (Mr. McCarthy= affirmative, Ms. Smith= affirmative, and Ms. Bunker = affirmative) at 6:25 p.m. to enter executive session. The Board returned from executive session into open session at 7:23 p.m.

The Board of Assessors voted to approve the Assessor's Annual Report for 2016.

The Board voted to authorize the Chairman, on behalf of the Board, to respond to attorney Irene Bagdoian's request for information relative to Matfield Woods Association, LLC.
