The meeting was called to order at 5:30 P.M.

### **Septic Plans**

#### **1 Tiffany Circle Septic Upgrade.**

1. Ms. Simpson motions to approve the local upgrade to reduce the separation to groundwater from 4 feet to 3 feet to eliminate the need for a pumped system Mr. Cruz 2nds out of RON.
2. Ms. Simpson makes a motions to approve the plans, Mr. Cruz 2nds out of Ron. Motions Passed

#### **58 Hartshorn Septic Upgrade.**

1. Ms. Simpson makes a motion to approve the variance to decrease the separation to groundwater from 4 feet to 3 feet to reduce costs, grading and surface water impacts. Mr. Cruz 2nds out of RON.
2. Ms. Simpson makes a motion to approve the use a grain size analysis in lieu of a perc test to determine loading rate, Mr. Cruz 2nds out of RON.
3. Ms. Simpson makes a motion to approve the variance for a reduction in separation between groundwater and tees from 12 inches to 4 inches due to site constraints. Mr. Cruz 2nds out of RON.
4. Ms. Simpson makes a motions to approve the plans, Mr. Cruz 2nds out of Ron. Motions Passed.
