This historical War Memorial Park is available for weddings, graduations, cookouts, and company picnics. A fee of \$150.00 has been established for out-of-town groups who wish to use the park. There will be no charge to residents of the town of West Bridgewater. These fees will be applied to the West Bridgewater Beautification Fund and will be used to improve, maintain, and repair our park.

Town Hall Gazebo and Friendship Park Playground

These areas are also available and carry a fee of \$25.00 for out-of-town groups. The fee will be applied to maintenance of the grounds.

Park Rules and Regulations

1. Park closed sunset to sunrise
2. No alcoholic beverages
3. No tents or canopies
4. No amplified sound systems
5. Horseback and bicycle riding prohibited
6. Please respect flowers, lawns, stone walls, and fences
7. Park only in designated areas. No vehicles are allowed on lawn areas
8. Read and understand posted rules sign at park. These are strictly enforced!
9. Remove all trash generated from picnic and/or function
