## Facility Rules

*\*If there are any rules or regulations contained herein that conflict with the terms of the license agreement, the terms in the License agreement shall prevail in all instances.*

1. \_\_\_\_\_ **USER MUST ACT AS A GOOD STEWARD** for Williamson County Parks and Recreation Department at all times during its use of the Williamson County Government Facility.
2. \_\_\_\_\_ **ABSOLUTELY NO ALCOHOL OR DRUG USE.** Any staff, guests, volunteers, coaches or spectators displaying signs of intoxication or found with alcohol will be asked to leave the premises, via the Williamson County Sherriff's Department should a Facility or WCPR representative deem appropriate without refund.  
Also, no unlawful, disreputable or hazardous business may be conducted on premises, nor any private business conducted.
3. \_\_\_\_\_ **IF CONCESSIONS WILL BE SOLD,** User and Vendor must have approval to sell concessions at any facility. **NO CHARCOAL GRILLS ALLOWED, ONLY GAS Grills** will be allowed. USER/Vendor must obtain permits required.
4. \_\_\_\_\_ **WCPR RESERVES THE RIGHT TO REQUEST SECURITY FOR YOUR EVENT.** WCPR recommends that security be used for all tournament play but may be required at the discretion of WCPR depending on the size of the event.
5. \_\_\_\_\_ **A COPY OF THE EVENT SCHEDULE OR TOURNAMENT BRACKET MUST BE RECEIVED BY WCPR AT LEAST 72 HOURS PRIOR TO THE START OF THE EVENT.**
6. \_\_\_\_\_ **BEGINNING AND ENDING TIME FOR THE EVENT WILL BE LIMITED TO PARK REGULATIONS.** Make sure you are familiar with the WCPR regulations for the facility being requested prior to making your event schedule and that you have made all participants aware of the regulations.
7. \_\_\_\_\_ **THE USE OF PORT-A-LETS SHALL REQUIRE THE USER TO RENT AND ARRANGE THE DROP OFF AND PICK UP OF THE PORT-A-LETS AT THEIR OWN EXPENSE FOR THE EVENTS.** A WCPR representative will designate the location where the port-a-lets can be set.
8. \_\_\_\_\_ **THE USER WILL ASSIST WITH TRASH PICKUP AND DISPOSAL DURING EVENT AND ASSIST IN CLEANING OF THE RESTROOMS DURING THE EVENT.**
9. \_\_\_\_\_ **FIELD PREP WILL ONLY APPLY FOR EVENTS THAT ARE HELD AT FLY PARK.**
10. \_\_\_\_\_ **WCPR PET REGULATIONS WILL APPLY AT ALL FACILITIES.**
11. \_\_\_\_\_ **WEATHER DECISIONS/INCLEMENT WEATHER WILL BE AT THE FULL DISCRETION OF THE WILLIAMSON COUNTY PARKS & RECREATION DEPARTMENT DIRECTOR, OR HIS DESIGNATED RESPRESENTATIVE.**
12. \_\_\_\_\_ **USER AGREES TO IMMEDIATELY NOTIFY DESIGNATED REPRESENTATIVE WITH ANY PROBLEMS AT THE FACILITY AND ALL ACCIDENTS OR INCIDENTS THAT ARISE DURING THE EVENT.**
13. \_\_\_\_\_ **USER AGREES TO HAVE THEIR STAFF ON PREMISES** at all times during any event. Likewise, a Facility representative will be present for all events. Any decision affecting any matter not herein expressly provided for will rest solely within the discretion of a Facility representative.
14. \_\_\_\_\_ **USER WILL NOT LITTER, DEFACE, OR DAMAGE ANY PART OF THE FACILITY**  
Upon conclusion of each event(s) the USER and a Facility Representative will perform a post-event walk through check list. Williamson County Parks and Recreation reserves the right to charge the User for any extensive cleaning services, repairs, or replacements necessitated due to their use during the Agreement specified time on premises.
15. \_\_\_\_\_ **NO FEES MAY BE CHARGED FOR PARKING** unless otherwise arranged though the Williamson County Parks and Recreation Department Director or designated representative.

16. \_\_\_\_\_ **FACILITY MAY ONLY BE USED FOR PURPOSES STATED IN USER'S AGREEMENT** and only approved Vendors and concessions may be sold or contracted for sale. If an outside Vendor is contracted, all permits and insurance certificates must be submitted when Agreement is signed.
17. \_\_\_\_\_ **HOUSEKEEPING:**  
All Williamson County facilities are smoke-free. No smoking is allowed anywhere on Williamson County property. **NO CIGARETTE BUTTS ARE TO BE THROWN ON THE GROUND AT FACILITY OR THE PARKING AREAS AT ANY TIME.**
18. \_\_\_\_\_ **FIREARMS:** Pursuant to TCA § 39-17-1309, it is an offense for any person to possess or carry, whether openly or concealed, any firearm in the Venue while the Venue is being used or operated by any board of education, school, college or university board of trustees, regents or directors for the administration of any public or private educational institution. Williamson County Government has these signs currently posted at Facilities.
19. \_\_\_\_\_ **USER will complete a walk-through of the facility space with a facility representative.** All issues/damages must be noted and documented at that time by a facility representative and the USER. Issues/damages not noted in the walk-through will be assessed as damage caused by the USER and USER will be charged for the repair or replacement for any damages.
20. \_\_\_\_\_ **EVENTS CAN NOT BE OVERSOLD.**
21. \_\_\_\_\_ **MAINTENANCE/REPAIRS:** Should any maintenance issue arise during your Agreement period, the on-site Facility Representative is your first point of contact.
24. \_\_\_\_\_ **FINAL SAY** - All decisions by the Williamson County Parks and Recreation Director or said Director's duly appointed representative shall be in their complete discretion.
